The QUEEN's Most Excellent Majesty in Council.

WHEREAS Her Majesty's Commissioners VV for building new churches have, in pursuance of the sixteenth section of an Act of Parliament, passed in the fifty-eighth year of the reign of His Majesty King George the Third, intituled " An Act for building and promoting the building " of additional churches in populous parishes, and also of the ninth section of an Act, passed in the fifty-ninth year of the reign of His late Majesty's King George the Third, intituled "An "Act to amend and render more effectual an "Act passed in the last session of Parliament "for building and promoting the building of ad"ditional churches in populous parishes," duly prepared and laid before Her Majesty in Council a representation, bearing date the twenty-fourth day of July, one thousand eight hundred and fifty-five, in the words and figures following; viz.:

"Your Majesty's Commissioners for building new churches beg leave humbly to represent that, when the last census was taken, the parish of Tardebigge, in the county and diocese of Worcester, contained a population of six thousand four hundred and twenty-three persons; and that besides the parish church of Tardebigge; which will accommodate five hundred persons, there is also a consecrated church at Redditch, in the said parish of Tardebigge, called Saint Stephen's Church, which will accommodate one thousand five hundred persons, including four hundred and seventy free seats for adults, and three hundred

sittings for children.

"Your Majesty's said Commissioners beg leave further to represent that having taken into consideration all the circumstances of the said parish of Tardebigge, it appears to them to be expedient that the same should be divided into two distinct and separate parishes for all ecclesiastical purposes whatever, under the powers contained in the sixteenth section of an Act of Parliament, passed in the fifty-eighth year of the reign of His Majesty King George the Third, intituled An Act for building and promoting the building of additional churches in populous parishes, and that the same should be respectively named 'The Parish of Tardebigge,' and 'The Parish of Redditch;' that the present parish church of the said parish of Tardebigge,

should remain and be the parish church of such parish; and that the said church of Saint Stephen, should become and be the parish church of the said parish of Redditch; and that the boundaries of the said parishes should be those hereinafter mentioned and set forth; that is to say:

"The parish of Tardebigge will comprise the whole of the townships of Tutnell and Cobley, Bentley Pouncefoot and Webheath, and part of the township of Redditch, and be bounded as follows; that is to say: the boundary line of the proposed parish of Tardebigge is, on the east, the boundary line which separates the old parish of Tardebigge from the parish of Alvechurch; on the north and west, the boundary line which parts the said parish from the parishes of Bromsgrove and Stoke Prior; and on the south-west and south, the boundary line which parts the said parish from the parishes of Hanbury, Feckenham, and Ipsley; and on the south-east, the line of demarcation between the proposed parishes of Tardebigge and Redditch, commencing at the eastern corner of Blind-lane, and proceeding along the southern, south-western, and north-western enclosure of Tilehouse Wood, No. 522 on the Tithe Commutation Map of the parish of Tardebigge; then to and along the western enclosure of the fields, Nos. 563, 564, to the road called Redlane; then easterly, along the middle of the said road, to the southern corner of the field No. 565; then in a northerly direction, along the western enclosures of the fields Nos. 565, 566, and easterly, along the enclosures of Nos. 566, 556, and 552; then crossing the lane and following the northern enclosures of the fields Nos. 697, 701, 702; then northerly, along enclosure No. 693, and easterly, along Nos. 693, 690, 689, and 688, to the road from Birmingham to Redditch; then crossing the said road and turning in a south-easterly direction along the eastern enclosure of field No. 783, to the northern enclosure of No. 804; and then along the said enclosure to and across the River Arrow; then along the south-western enclosures of the fields Nos. 807, 812, 813, to the point at which the Beoley-road crosses the River Arrow and meets the parish of Alvechurch, and which said parish of Tardebigge is more particularly delineated on the map or plan hereto annexed, and is thereon coloured green.

"Your Majesty's said Commissioners beg leave further to represent that the portion of the said parish of Tardebigge which is encircled within a yellow line on the said map or plan was duly assigned to Saint Luke's Church, situate at Headless Cross, in the parish of Ipsley, in the said diocese of Worcester, by an Order of your Majesty in Council, bearing date the eighth day of January, one thousand eight hundred and fifty, under the powers for such purpose contained in the ninth section of an Act of Parliament, passed in the eighth and ninth years of your Majesty's reign, intituled 'An Act for the further amendment of the Church Building Acts,' and which said portion of the said parish of Tardebigge so duly assigned to the said church of Saint Luke at Headless Cross aforesaid, your Majesty's said Commissioners beg leave to represent should, for vicarial rights and purposes, be considered as forming part of the said parish of Tardebigge, but so as not to interfere with the pastoral duties or rights of the incumbent of Saint Luke's Church aforesaid, as by law established. The parish of Redditch will comprise the remaining part of the township of Redditch, and be bounded as follows; that is to say:

"The parish of Redditch is bounded on the south by the parish of Ipsley, on the east by the parish of Beoley, on the north-east by the parish of Alvechurch, and on the north-west, west, and south-west by the line of demarcation between the proposed parishes of Redditch and Tardebigge, commencing at the point where the Beoley-road crosses the River Arrow, and meets the parish of Alvechurch; and then proceeding southerly, along the south-western enclosures of fields, marked on the said Tithe Commutation Map, Nos. 813, 812, and 807, across the River Arrow to the northern enclosure of field No. 804; then westerly along that enclosure to the eastern enclosure of field No. 783; then north-westerly along that enclosure, and crossing the road from Redditch to Birmingham, over to the north-eastern enclosure of field No. 688; then along enclosures Nos. 688, 689, 690, and 693, to the western end of No. 693; then southerly, along enclosure No. 693, to the northern enclosure of field No. 702; then westerly, along part of the northern enclosures of fields Nos. 702, 701, to No. 697; then along No. 697, and crossing the lane to the northern enclosure of No. 552, and along that enclosure, and also of fields Nos. 556 and 566 to the western side of No. 566; then southerly, along that enclosure, and of No. 565, to the road called Red-lane; then westerly, along the middle of that road, to the western enclosure of fields No. 564; then southerly, along the western enclosures of Nos. 564 and 563, to the northern enclosure of Tilehouse Wood, No. 522, and along the boundary of that wood in a south-westerly and south-easterly direction to the point where the boundary-line of the parishes of Tardebigge and Ipsley meet, and which said parish of Redditch is more particularly delineated on the map or plan hereto annexed, and is thereon coloured blue.

"Your Majesty's said Commissioners beg leave further to represent, that it appears to them to be expedient that, after such division as aforesaid, all the glebe land which now belongs to the vicar or incumbent of the said parish of Tardebigge, and which is situate within the proposed boundaries thereof, should continue to belong to such vicar or incumbent, and his successors.

"Your Majesty's said Commissioners beg leave further to represent that the whole of the vicarial tithes or moduses of the entire parish of Tardebigge have been commuted into and now consist of certain tithe rent charges amounting altogether to the annual sum of six hundred and three pounds, seven shillings, and six pence, but by a certain instrument under the hands and seals of the bishop of the diocese, and of the patron and incumbent

of the said parish of Tardebigge, bearing date the twelfth day of April, one thousand eight hundred and fifty-one, the said commuted tithes or other revenues of the said parish of Tardebigge are charged with the payment of fifteen pounds per annum to the incumbent for the time being of Saint Luke's Church, at Headless Cross aforesaid, under the powers for such purpose given by the fourteenth section of an Act of Parliament, passed in the first and second years of your Majesty's reign, intituled 'An Act to amend and render more effectual the Church Building Acts,' and which said sum of fifteen pounds per annum your Majesty's said Commissioners beg leave to represent, should remain charged upon the said commuted tithes or other revenues belong to the vicar for the time being of the said parish of Tardebigge after such division thereof, as aforesaid.

"Your Majesty's said Commissioners beg leave further to represent that the whole of the said vicarial commuted tithes or moduses now arising within the said parish of Tardebigge, according to the reduced boundaries thereof hereinbeforementioned, will amount to the annual sum of five hundred and thirty-two pounds, one shilling and ten pence, and which your Majesty's said Commissioners propose should continue as at present to belong to the vicar thereof for the time being; and that the whole of the commuted tithes or moduses now arising within the said parish or proposed parish of Redditch will amount to the annual sum of seventy-one pounds, five shillings, and eight pence, and which your Majesty's said Commissioners propose should belong to and be enjoyed by the vicar for the time being of the said parish or proposed parish of Redditch; and they beg further to represent that the estimated amount of the relative proportions of commuted tithes or moduses which will belong or accrue to the vicar of each of the said parishes will be as aforesaid, five hundred and thirty-two pounds, one shilling and ten pence to the vicar of the said parish of Tardebigge, and seventy-one pounds, five shillings, and eight pence to the vicar of the parish or proposed parish of Redditch.

"Your Majesty's said Commissioners beg leave further to represent that it is estimated that the annual produce of fees, oblations, offerings, and other ecclesiastical dues which will arise or accrue to the vicar of the said parish of Tardebigge will amount to nine pounds, and of those which will annually arise or accrue in the said parish or proposed parish of Redditch will amount to fifteen pounds.

"Your Majesty's said Commissioners beg leave further to represent that in addition to the sources of income hereinbefore-mentioned as belonging to the vicar of the said parish or proposed parish of Redditch, he will also possess a parsonage-house and the rents of certain land or of charges on land now producing about twenty pounds per annum, and also the rents to be derived from the pews or sittings in the said church of Saint Stephen, at Redditch aforesaid, and likewise the dividends, interest, or annual produce of one thousand six hundred and sixty-six pounds, thirteen shillings and fourpence consolidated three pounds per cent. annuities, standing in the books of the Governor and Company of the Bank of England, in the names or to the account of the Governors of the Bounty of Queen Anne, for the augmentation of the maintenance of the poor clergy, in trust for the incumbent of the said parish or proposed parish of Redditch, and which said sum of one thousand six hundred and sixty-six pounds, thirteen shillings, and four pence consolidated three pounds per cent. annuities was transferred to the said Governors by Lady Harriet Clive, as a benefaction for such lastnamed incumbent, who will also receive an annual sum of seven pounds or thereabouts, granted by the said Governors as an augmentation of the said church of Saint Stephen, at Redditch aforesaid, and a further annual sum of ten pounds from the Ecclesiastical Commissioners for England, as an augmentation by that body of the said church at Redditch aforesaid, which two last-mentioned sums will become payable from the formation of the said

new parish of Redditch.
"Your Majesty's said Commissioners beg leave further to represent that it also appears to them to be expedient, with the consent of the said bishop of the said diocese of Worcester, as required by and in pursuance of the powers in that behalf contained in the ninth section of an Act passed in the fifty-ninth year of the reign of His late Ma-jesty King George the Third, intituled 'An Act 'to amend and render more effectual an Act 'passed in the last session of Parliament for building and promoting the building of additional 'churches in populous parishes,' that a certain payment of eight pounds, payable by every vicar or incumbent of the parish church of the said parish of Tardebigge, upon his induction to such church, to the Governors of the Bounty of Queen Anne, for the augmentation of the maintenance of the poor clergy, and also a certain annual payment of sixteen shillings, likewise payable by such vicar, during his incumbency of the same church, to the said Governors, should, from and after the proposed division of the said parish of Tardebigge shall have completely taken effect, be borne and paid to the said Governors by the vicars for the time being of the said parishes of Tardebigge and Redditch, in the proportions following; that is to say: seven pounds one shilling by the vicar of the said parish of Tardebigge and his successors, and nineteen shillings by the vicar of the said parish or proposed parish of Redditch and his successors, upon their respective inductions to those parishes, and the annual payment of fourteen shillings, part of the said annual payment of sixteen shillings, should be borne and paid to the said Governors by the vicar of the said parish of Tardebigge and his successors, and that the annual payment of two shillings, being the residue of the said annual payment of sixteen shillings should be borne and paid to the said Governors by the vicar of the said parish or proposed parish of Redditch and his successors, during their respective incumbences of the said two parishes.

"That the consent of the Right Reverend Henry, Bishop of the diocese of Worcester, has been obtained thereto, as required by the Acts and sections firstly and lastly hereinbefore mentioned, and also the consent of Lady Harriet Clive, of Hewell Grange, in the said county of Worcester, Widow, patron of the said parish and parish church of Tardebigge, as required by the Act and section firstly hereinbefore mentioned, in testimony whereof they have signed and sealed this repre-

sentation.

"Your Majesty's said Commissioners therefore beg leave humbly to lay before your Majesty the before-mentioned circumstances, and pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect thereto as to your Majesty in your royal wisdom shall seem

Her Majesty having taken the said representation, together with the maps or plans thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve !

thereof, and to order, and it is hereby ordered, that the proposed division of the parish of Tardebigge into two distinct and separate parishes, to be respectively named "the parish of Tardebigge," and "the parish of Redditch," be accordingly made, and that the recommendations of the said Commissioners, with respect to certain payments payable by every vicar or incumbent of the parish church of the said parish of Tardebigge, upon his induction to such church, be carried into effect, as proposed in the said representation, agreeably to the provisions of the said Acts; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Worcester.

'THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Plenipotentiary in China (a copy of which is subjoined) relative to certain inaccuracies which have been found to exist in the official charts of the Gulf of Siam.

(Copy.)

Her Majesty's ship Rattler, Off Singapore, May 5, 1855. MY LORD,

I BEG leave to solicit that your Lordship will kindly call the attention of the Lords of the Admiralty to the following errors which we have detected in the official charts of the Gulf of Siam; and to suggest, in anticipation of the probable extension of trade in these regions, that a thorough survey of the Gulf should be made. Many inaccuracies have to be corrected besides those I shall now point out.

In our charts the Island of Pulo Paujang is placed about 18 miles too far to the westward.

Its real position is, north latitude 9° 18', longitude

Cape Liant stands 25 miles too far to the east, and six miles too far to the south. Its true position is latitude 12° 34′, longitude 101° 11′.

The anchorage at Meinam Bar, in four fathoms, is 52 miles too far to the eastward; it really being latitude 13° 24′ 50″, longitude 100° 36′ 30″. Some of these errors were pointed out by Mr. Crawfurd, in the account of his mission to Siam in the year 1822.

The situation of Bangkok and its neighbourhood is given erroneously, as a necessary consequence of the errors I have noticed.
