**I**T is this day ordered by Her Majesty in Council that the Parliament, which stands prorogued to Tuesday the twenty-third day of October instant, be further prorogued to Tuesday the eleventh day of December next.

**W**HEREAS by an Act, passed in the last session of Parliament, intituled "An Act for the better Local Management of the Metropolis," it is enacted, that each of the parishes mentioned in either of the schedules A and B to the said Act, which at the time of the passing of the said Act contained more than two thousand rated householders, shall be divided into Wards; and that it shall be lawful for such person or persons as may be appointed for that purpose, as in the said Act provided, to determine and set out, on or before the tenth day of October in this present year, the number, extent, limits, and boundary lines of such wards; but so, nevertheless, that no ward shall contain less than five hundred rated householders, and that the whole number of wards in any parish shall not exceed eight; and that the person or persons setting out such wards in any parish, shall apportion among the several wards the number of vestrymen to be elected for such parish, and shall, in assigning the number of vestrymen to each ward, have regard, as far as in

his or their judgment it is practicable, as well to the number of persons rated to the relief of the poor in each ward as to the aggregate amount of the sums at which all such persons are rated; and that the number of vestrymen assigned to each ward shall be a number divisible by three; and that a copy of the particulars of such division and apportionment shall be forthwith transmitted to one of Her Majesty's Principal Secretaries of State, and also to the Vestry Clerk of the parish to which such division and apportionment relate; and that if Her Majesty, by the advice of Her Privy Council, approve of such division and apportionment, the particulars thereof shall be published in the London Gazette; and that the parish shall, after such publication, be deemed to be divided into such wards so determined and set out, and such division shall continue to be in force until the same be altered, as in the said Act provided; and that the number of vestrymen assigned to each ward, shall be the number to be elected for such ward until altered as aforesaid:

And whereas, in pursuance of the provisions of the said Act, the following award has been made by the person appointed for that purpose by the Right Honourable Sir George Grey, Bart., one of Her Majesty's Principal Secretaries of State; viz.:

"PARISH OF SAINT MARYLEBONE.

"(EIGHT WARDS.)

"I, Arthur John Wood, Esquire, Barrister-at-Law, having been duly appointed by the Right Honourable Sir George Grey, Baronet, one of Her Majesty's Principal Secretaries of State, by virtue of an Act, passed in the nineteenth year of the reign of Her Majesty Queen Victoria, intituled 'An Act for the better Local Management of the Metropolis,' to be one of the persons to set out the wards into which certain parishes are by the said Act directed to be divided, and to apportion the number of vestrymen to be elected for such parishes respectively among such wards, and also to ap-

portion the number of vestrymen to be elected for any parish already divided into wards under any local Act, and to act separately in such division and apportionment from the other persons appointed or to be appointed by the said Sir George Grey to perform those duties under the said Act, do hereby divide the parish of Saint Marylebone (being a parish mentioned in Schedule (A) to the said Act, containing more than two thousand rated householders, and not already divided into wards under any local Act), into eight wards (none of which contain less than five hundred rated householders), to be distinguished by the numbers mentioned in the first column of the schedule hereto, and do set out the extent, limits, and boundary lines of the said wards as the same are

described in the second column of the schedule hereto, in conjunction with the numbers distinguishing such wards respectively; and, having regard, as far as in my judgment it is practicable, as well to the number of persons rated to the relief of the poor in each ward as to the aggregate amount of the sums at which all such persons are rated, do hereby apportion the number of vestrymen to be elected for the said parish among the said wards according to the respective numbers mentioned in the third column of the schedule hereto, in conjunction with such wards respectively.

"I, William Durrant Cooper, of Guilford-street, in the county of Middlesex, Esquire, having been duly appointed by the Right Honourable Sir George Grey, Baronet, one of Her Majesty's Principal Secretaries of State, by virtue of an Act passed in the

last session of Parliament, intituled 'An Act for the better Local Management of the Metropolis,' to be one of the persons to set out the wards into which certain parishes are by the said Act directed to be divided, and to apportion the number of vestrymen to be elected for such parishes respectively among such wards, and to apportion the number of vestrymen to be elected for any parish already divided into wards under any local Act, and, further, to act separately in such division and apportionment from the other persons appointed or to be appointed to perform those duties under the said Act, have proceeded in the performance of the duties required by the said Act to be executed by me in reference to the parish of Lambeth (being a parish mentioned in Schedule (A) to the said Act, containing more than two thousand rated householders, and not already divided into wards under any local Act), and to determine and set out the number, extent, limits, and boundary lines of the wards into which the said parish is to be divided, and to apportion among such wards the number of vestrymen to be elected for such parish:

"Now I do hereby, by virtue of the provisions and directions of the said Act, divide the said parish of Lambeth into eight wards, none of which contains less than five hundred rated householders, to be called respectively No. 1 or North Marsh Ward; No. 2 or South Marsh Ward, No. 3 or Bishop's Ward, No. 4 or Prince's Ward, No. 5 or Vauxhall Ward, No. 6 or Stockwell Ward, No. 7 or Brixton Ward, and No. 8 or Norwood Ward; and I determine and appoint that the said ward to be called No. 1 or North Marsh Ward shall consist of so much of the said parish as will be comprised within a line drawn from the boundary of the parish in the centre of the River Thames opposite the Old Barge House running along the east boundary of the parish to the centre of the New Cut, thence westward along the centre of the New Cut to the centre of the Westminster Bridge-road, thence turning north-westerly along the centre of the Westminster Bridge-road to the boundary of the parish in the centre of the said river at Westminster Bridge, and thence eastward along the said boundary of the parish in the said river to the starting point opposite the Old Barge House; and that the said ward to be called No. 2 or South Marsh Ward shall consist of so much of the said parish as will be comprised within a line drawn from the boundary of the parish in the centre of the New Cut adjoining the parish of Christchurch running in a south and south-westerly direction along the boundary of the said parish of Lambeth to Durham-place, where the said parish of Lambeth adjoins the parish of St. George Southwark, thence westward along the centre of the Lambeth-road to Hercules-buildings, thence along the boundary of the Bishop's Liberty to the centre of the Westminster Bridge-road, thence south-eastward along the centre of the Westminster Bridge-road to the centre of the New Cut, and thence easterly along the centre of the New Cut to the starting point; and that the said ward to be called No. 3 or Bishop's Ward shall consist of the district known as the Bishop's Liberty; and that the said ward to be called No. 4 or Prince's Ward shall consist of the district known as the Prince's Liberty; and that the said ward to be called Ward No. 5 or Vauxhall Ward, shall consist of so much of the

said parish of Lambeth as will be comprised within a line drawn from the north point where the said parish of Lambeth adjoins the parish of Saint Mary Newington on the east side of Kennington-park running along the boundary of the said parish of Lambeth next the parishes of St. Mary Newington and Camberwell to the centre of the Camberwell New-road, thence north-westerly along the centre of the said road to the centre of Vassal-road, thence westward along the centres of Vassal-road and of Holland-street to the centre of the Clapham-road, thence south-westerly along the centre of the Clapham-road to the west boundary of the parish of Lambeth adjoining the parish of Clapham, thence by the boundary of the said parish of Lambeth next the parishes of Clapham and Battersea to the centre of the River Thames, thence eastward by the boundary of Lambeth in the said river to the boundary of the Prince's Liberty, and thence along the south-eastern boundary of the said liberty to the starting point; and that the said ward to be called No. 6 or Stockwell Ward shall consist of so much of the said parish of Lambeth as will be comprised within a line drawn from the centre of the Brixton-road opposite Holland-street running south-easterly along the centre of the said Brixton-road to the point on the south-west where the said parish of Lambeth adjoins the parish of Streatham, thence by the boundary of Lambeth next the parishes of Streatham and Clapham to the boundary of No. 5 or Vauxhall Ward, and thence north-easterly and easterly by the said boundary to the starting point; and that the said ward to be called No. 7 or Brixton Ward shall consist of so much of the said parish of Lambeth as will be comprised within a line drawn from the centre of the Brixton-road opposite Vassal-road running eastward along the boundary of No. 5, or Vauxhall Ward to the point where the said parish of Lambeth adjoins the parish of Camberwell on the east, thence by the boundary of Lambeth next the parish of Camberwell to the centre of Water-lane, thence turning north-west and west along the centre of Water-lane to the centre of the Brixton-road, and thence northward along the centre of the said road to the starting point; and that the said ward to be called No. 8 or Norwood Ward shall consist of the remainder of the said parish of Lambeth south of No. 6 or Stockwell Ward, and of No. 7 or Brixton Ward, and will include the district of Norwood. AT the Court at *Windsor*, the 19th day of *October*, 1855,

PRESENT,

The QUEEN'S Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the last session of Parliament, intituled "An Act for the better Local Management of the Metropolis," it is enacted, that each of the parishes mentioned in either of the schedules A and B to the said Act, which at the time of the passing of the said Act contained more than two thousand rated householders, shall be divided into wards; and that it shall be lawful for such person or persons as may be appointed for that purpose, as in the said Act provided, to determine and set out, on or before the tenth day of October in this present year, the number, extent, limits, and boundary lines of such wards; but so, nevertheless, that no ward shall contain less than five hundred rated householders, and that the whole number of wards in any parish shall not exceed eight; and that the person or persons setting out such wards in any parish, shall apportion among the several wards the number of vestrymen to be elected for such parish, and shall, in assigning the number of vestrymen to each ward, have regard, as far as in his or their judgment it is practicable, as well to the number of persons rated to the relief of the poor in each ward as to the aggregate amount of the sums at which all such persons are rated; and that the number of vestrymen assigned to each ward shall be a number divisible by three; and that a copy of the particulars of such division and apportionment shall be forthwith transmitted to one of Her Majesty's Principal Secretaries of State and also to the Vestry Clerk of the parish to which such division and apportionment relate; and that if Her Majesty, by the advice of Her Privy Council, approve of such division and apportionment, the particulars thereof shall be published in the London Gazette; and that the parish shall, after such publication, be deemed to be divided into such wards so determined and set out, and such division shall continue to be in force until the same be altered, as in the said Act provided; and that the number of vestrymen assigned to each ward, shall be the number to be elected for such ward, until altered as aforesaid:

"And whereas, in pursuance of the provisions of the said Act, the following award has been made by the person appointed for that purpose by the Right Honourable Sir George Grey, Bart., one of Her Majesty's Principal Secretaries of State; viz.:

"PARISH OF LEWISHAM

"(Including Sydenham Chapelry).

"(THREE WARDS).

"I, William Durrant Cooper of Guilford-street in the county of Middlesex, Esquire, having been duly appointed by the Right Honorable Sir George Grey, Baronet, one of Her Majesty's Principal Secretaries of State, by virtue of an Act passed in the last Session of Parliament, intituled 'An Act for the better Local Management of the Metropolis,' to be one of the persons to set out the wards into which certain parishes are by the said Act directed to be divided, and to apportion the number of vestrymen to be elected for such parishes respectively among such wards, and to apportion the number of vestrymen to be elected for any parish already divided into wards under any local Act, and, further, to act separately in such division and apportionment from the other persons appointed or to be appointed to perform those duties under the said Act, have proceeded in the performance of the duties required by the said Act to be executed by me in reference to the Parish of Lewisham, including Sydenham Chapelry, (being a parish mentioned in Schedule (B) to the said Act, containing more than two thousand rated householders, and not already divided into wards under any local Act), and to determine and set out the number, extent, limits, and boundary lines of the wards into which the said parish is to be divided, and to apportion among such wards the number of vestrymen to be elected for such parish:

"Now I do hereby, by virtue of the provisions and directions of the said Act, divide the said parish of Lewisham, including Sydenham Chapelry, into three wards, none of which contains less than five hundred rated householders, to be called respectively No. 1 or Blackheath Ward, No. 2 or Sydenham Ward, and No. 3 or Lewisham Ward; and I determine and appoint that the said ward to be called No. 1 or Blackheath Ward shall consist of so much of the said parish as lies north of a line drawn from the east boundary of the parish at the point where it adjoins the parishes of Lee and Charlton running westward along the centre of the London-road to the point where the parish of Lewisham adjoins the parish of Saint Paul, Deptford; and that the said ward to be called No. 2 or Sydenham Ward shall consist of so much of the said parish of Lewisham as will be comprised within a line drawn from the west boundary of the said parish near Honor Oak, adjoining the parish of Camberwell, running eastward to the west side of the bridge known as No. 9 bridge over the London and South Coast Railway, thence southward in a straight line to the west side of the railway bridge thrown over the road leading from the Dartmouth-road, Forest-hill, to Perry-vale, thence to the centre of the said road under the last-mentioned bridge, thence along the centre of the road leading through Dartmouth-vale and Perry-vale to the centre of the Sydenham-road opposite Meadow-croft, thence southward along

the centre of the Sydenham-road to the centre of the road at Bell-green, thence along the centre of Kent-house-lane to the south boundary of the parish of Lewisham adjoining the parish of Beckenham, and thence by the boundary of the parish of Lewisham next the parishes of Beckenham and Camberwell to the starting point; and that the said ward to be called No. 3 or Lewisham Ward shall consist of the remainder of the said parish of Lewisham, including the remainder, if any, of the said chapelry of Sydenham. And, having regard, as far as in my judgment it is practicable, as well to the number of persons rated to the relief of the poor in each ward as to the aggregate amount of the sums at which all such persons are rated, I do apportion and assign nine vestrymen to the said ward to be called No. 1 or Blackheath Ward, and twelve vestrymen

to the said ward to be called No. 2 or Sydenham Ward, and fifteen vestrymen to the said ward to be called No. 3 or Lewisham Ward.

“In witness whereof I have hereunto set my hand, this fourth day of October, in the year of our Lord, one thousand eight hundred and fifty-five.

Now, therefore, Her Majesty, having taken the said award into consideration, is pleased by and with the advice of Her Privy Council, to approve thereof, and of the division and apportionment therein proposed, and the same are hereby approved accordingly; and Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette.
