# PRESENT.

The QUEEN's Most Excellent Majesty in Council.

HEREAS Her Majesty's Commissioners for building new church building new churches have, in pursuance of the ninth section of an Act, passed in the session of Parliament holden in the eighth and ninth years of Her Majesty's reign, intituled "An Act for the "further amendment of the Church Building "Acts," and in the nineteenth and twentieth sections of an Act, passed in the fourteenth and fifteenth years of Her Majesty's reign, intituled "An Act to amend the Church Building Acts," duly prepared and laid before Her Majesty in Council a representation, bearing date the nineteenth day of October, one thousand eight hundred and fifty-five, in the words and figures following; viz.:

"Your Majesty's Commissioners for building new churches beg leave humbly to represent that having taken into consideration all the circumstances of the parishes of Michelmersh and Romsey and the district parish of Ampfield, in the county of Southampton, and in the diocese of Winchester, it appears to them to be expedient to unite and consolidate certain contiguous portions of the said parishes and district parish, and to form the same into one consolidated chapelry for all ecclesiastical purposes, for the consecrated church called All Saints Church, situate at Braishfield, in the said parish of Michelmersh, under and by virtue of the power or authority contained in the ninth section of an Act of Parliament, passed in the eighth and ninth years of your Majesty's reign, intituled 'An Act for the further 'amendment of the Church Building Acts,' and in the nineteenth and twentieth sections of an Act of Parliament, passed in the fourteenth and fifteenth years of your Majesty's reign, intituled 'An Act to amend the Church Building Acts,' and that such proposed consolidated chapelry should be named or called 'The Consolidated Chapelry of Braishfield, and that the boundaries thereof should be those hereinafter mentioned; that is to say:

"The boundary line commences at the point where the three parishes of Michelmersh, Ashley, and King Somborne meet, in or near to the road

proceeding south-westerly along the boundary line separating the said parishes of Michelmersh and King Somborne as far as the north-eastern fence of field, No. 242 on the Tithe Commutation Man of the parish of Michelmersh, where such field adjoins the said road to Ashley; then proceeds along the middle of that road in a southerly direction as far as the cross roads eastwards of Pitt House; then proceeds from such cross roads north-westerly along the middle of the road leading to Hall, Farm, until it reaches the fences separating that farm from fields, Nos. 265, 264, and 271 on the said map, along the fences of which farm and fields the boundary line then proceeds in a southerly and westerly direction, when it enters the road leading from Hall Farm to Michelmersh, and proceeds along the middle of that road south-erly to the point where the boundary line, separating the parish of Michelmersh from the parish of Timsbury, meets the said road; then proceeds southerly along such boundary line until it reaches the boundary line of the parish of Romsey; then proceeds easterly along the boundary line separating the parish of Michelmersh from the said parish of Romsey as far as the north-western fence of field No. 981, on the Tithe Commutation Map of the parish of Romsey; then proceeds southerly along the western fences of fields Nos. 981 and 984, and the southern fence of field No. 989, on the last last-mentioned map, when the line again meets the boundary line which separates the said parish of Michelmersh from the parish of Hursley; then proceeds easterly along the boundary line separating the two last-named parishes until it reaches the road or lane separating field No. 33, in Michelmersh parish, from field No. 644, in the district parish of Ampfield; then crossing such road or lane proceeds along the southern fences of fields Nos. 644, 643, 651, 650, and 649, to the southern side of Woolley Green, and along the southern side thereof to the eastern side; then proceeds northerly up the eastern side of Woolley Green and the fence of field No. 627; then westerly along the northern fence of field No. 627, the pond No. 629, and of Nos. 628 and 630 on the lest-No. 629, and of Nos. 628 and 630 on the lastmentioned map, and crossing the road continues northerly by the eastern fence of fields Nos. 631 and 633, to the point where the boundary line of the parishes of Michelmersh and Farley and the district parish of Ampfield meet; then proceeding in a northerly and westerly direction along the boundary line separating the said parish of Michelmersh from the parishes of Farley and Ashley, as leading from Michelmersh to Ashley, and then I far as the point where the boundary line of the

consolidated chapelry commenced, as the same is more particularly delineated on the map or plan hereunto annexed, and is thereon coloured pink,

blue, and yellow.

"That the consents of the Right Reverend Charles Richard, Bishop of the said diocese of Winchester, and also patron in right of his see of the parish church of the said parish of Michelmersh, of the dean and chapter of the cathedral church of Winchester, patrons of the parish church of the said parish of Romsey, and of the Reverend John Keble, Master of Arts, Vicar and Incumbent of the parish of Hursley, in the county and diocese aforesaid, and as such vicar and incumbent, patron of the church of the said district parish of Ampfield, have been obtained to the formation of the said consolidated chapelry of Braishfield, as required by the Acts and sections hereinbefore mentioned, in testimony whereof the said Charles Richard, Bishop of Winchester, and John Keble have signed and sealed this representation, and the said dean and chapter have hereto affixed their common seal.

" Your Majesty's said Commissioners beg leave further to represent, that it has been mutually agreed between the said Charles Richard, Bishop of Winchester, the said dean and chapter, and the said John Keble, as such respective patrons as aforesaid, testified as aforesaid (with the approbation of your Majesty's said Commissioners testified as hereinafter mentioned, and of the said Charles Richard, Bishop of Winchester, testified as aforesaid), that the right of presentation and appointment of an incumbent or perpetual curate to serve the said church of All Saints, at Braishfield aforesaid, should be vested in, belong to, and, whenever occasion may require, be exercised by, the Reverend John Pierce Maurice, Master of Arts, rector and incumbent of the said parish of Michelmersh, during his incumbency thereof, and from and after his avoidance of such incumbency, that such right of presentation and appointment as aforesaid should belong to, be vested in, and, whenever occasion may require, be exercised by the bishop of the said diocese of Winchester for the time being.

"Your Majesty's said Commissioners therefore humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the consolidated chapelry therein mentioned for the consecrated church of All Saints, at Braishfield, in the parish of Michelmersh, be accordingly formed, and that the agreement mentioned in the said representation, in respect of the right of presentation and appointment of an incumbent or perpetual curate to serve the said church, be carried into effect, agreeably to the provisions of the said Acts; and that the right of presentation and nomination to the said church shall belong to, and, whenever occasion may require, be exercised by, the Reverend John Pierce Maurice, Master of Arts, rector and incumbent of the said parish of Michelmersh, during his incumbency thereof, and from and after his avoidance of such incumbency, that such right of presentation and appointment as aforesaid, shall belong to and be vested in, and, whenever occasion may require,

be exercised by the bishop of the diocese of Winchester, for the time being, they being the persons mentioned in such representation; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Winchester.

THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Consul-General at Hamburg, forwarding a translation of a further notification respecting the levying of a rate on ships, in consequence of

the completion of the deepening of the Trave and its estuary, of which the following is a copy:—

Whereas in the notification of the 29th of February, 1840, respecting the levying of a rate in consequence of the measures taken for deepening the Trave and its estuary, a proviso having been made for raising this rate after the completion of the works executed in conformity with the plan for the regulation of the river, and the Senate, in accordance with the Commoners (Bürgerschafft) having decided that the said works being now completed, the rate in question shall be raised, the Senate, conformable to this joint decision, annulling at the same time the dispositions contained in the notification of the 29th of February, 1840, hereby decrees and publicly makes known as follows:

- 1. From this 1st of January, 1856, all sailing vessels and steamers of more than 30 lasts burden, arriving or leaving here, will have to pay the rate levied for deepening the Trave according to the following tariff:—
  - A. Laden, 6 schilling per last of 4120lbs.\*
  - B. Exceptionally when laden with timber, 4 schilling per last of 4120lbs.
  - C. In ballast or empty, 2 schilling per last of 4120 lbs.
- 2. The rate will be collected by the Customs and Excise Department, according to the tonnage ascertained by Lübeck measurement, and the certificate of measurement granted thereon, conformable to the instructions annexed to the decree of the 30th of January, 1850, respecting the measurement of sea-going vessels, and has to be paid on entry and departure, and by sailing vessels at the same time as the tonnage dues.
- 3. Ships laden to not more than one-tenth part of their total capacity pay as empty ships, two schilling per last.

Ships which, besides timber, are also partly laden with other goods, pay, when such goods fill a space not exceeding one-tenth of the total capacity of the vessel, the rate of timber-laden ships, four schilling per last.

Whoever lays claim to one of the two exceptional cases above mentioned, has to certify the same to the Customs and Excise Department; for which, as a rule, the bill of lading for inward, and a ship broker's certificate for outward bound vessels, will suffice; the Customs and Excise Department retaining, however, the right of ordering a search to be made when expedient.

4. Mail packet-ships, and other vessels sailing under state flags, are, as *such*, not subjected to the rate levied for deepening the Trave; but mail packet-ships, carrying passengers or goods, will have to pay the rate conformable to the above regulations.

And also the following translation of a Supplement to the above Notification:

The regulations contained in the Notification of the 29th February, 1840, relative to the rate for the deepening of the Trave, together with the dispositions respecting the *Dredging* dues, taken from the said notification, and incorporated (under 7) in the Decree of the 30th of January, 1850, respecting the shipping dues for sea traffic and the passage on the Lower Trave, shall, upon and from the 1st of January, 1856, cease to operate (be repealed).
