**REGULATIONS TO BE OBSERVED AT THE QUEEN'S** LEVEES AT ST. JAMES'S-PALACE.

The Noblemen and Gentlemen, who purpose to attend Her Majesty's Levees, at St. James's-Palace, are requested to bring with them two large card, with their names *clearly written* thereon, one to be left with the Queen's Page in Attendance in the Ante-Room, and the other to be delivered to the Lord Chamberlain, who will announce the name to Her Majesty.

Those Gentlemen who are to be presented are hereby informed, it is absolutely necessary that their names, with the name of the Nobleman or Gentleman who is to present them, should be delivered at the Lord Chamberlain's Office, before twelve o'clock on the Monday previous to each Levee, or upon any earlier day between the hours of eleven and four, in order that they may be submitted for the Queen's approbation; it being Her Majesty's command, that no presentation shall be made at the Levecs but in conformity with the above regulations.

It is particularly requested, that in every case the names be *very distinctly written* upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to the Queen.

The state apartments will not be open for the reception of Company coming to Court, until half-past one o'clock.

Notice is hereby given, that all persons having petitions or addresses to present to Her Majesty at the Levee, are to send a card (having on it their names, a statement of the object of such Petitions or Addresses, and the names of the persons from whom they come), to the Lord Chamberlain's Office, *before twelve o'clock*, on the *Monday previous* to each Levee; and that two other cards, having on them precisely what is written upon that sent to the Lord Chamberlain's Office, are to be taken to the Levee; one of the two cards to be delivered to the Page in the Ante-Room, and the other to the Lord Chamberlain, who will read its contents to Her Majesty; and, on these occasions, no other statement is to be addressed to Her Majesty.

A Deputation to present an Address is not to exceed four persons.

WHEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the ninth section of an Act, passed in the session of Parliament holden in the eighth and ninth years of Her Majesty's reign, intituled "An Act for the "further amendment of the Church Building "Acts," duly prepared and laid before Her Majesty in Council a representation, bearing date the nineteenth day of December, one thousand eight hundred and fifty-five, in the words following; viz.:

lowing; viz.: "Your Majesty's Commissioners for building new churches beg leave humbly to represent to your Majesty, that having taken into consideration all the circumstances of the parishes of Stoughton and Up Marden, in the county of Sussex, and within the diocese of Chichester, it appears to them to be expedient to unite and consolidate certain contiguous portions of the said two parishes and to form the same into one consolidated chapelry for all ecclesiastical purposes, for the consecrated church called Christ Church, situate at Forest Side, Stansted, in the said parish of Stoughton, under and by virtue of the power or authority for this purpose contained in the ninth section of an Act passed in the session of Parliament, holden in the eighth and ninth years of your Majesty's reign, intituled 'An Act for the further amendment of the Church Building Acts,' and that such proposed consolidated chapelry should be named or called ' The Consolidated Chapelry of Christ Church, Stansted, and that the boundaries thereof should be those hereinafter mentioned; that is to say :

The boundary line of the consolidated chapelry of Christ Church, Stansted, commences at the stone in the Sling Wall, in Castle-lane, and proceeds in a westerly direction along the boundary line, separating the said parish of Stoughton from the parish of Warblington, until it reaches the chapelry or tithing of Idsworth; then northerly

along the boundary of the parish of Stoughton and the chapelry or tithing of Idsworth, until it reaches the boundary line of the parish of Up Marden, continues northerly along the boundary line, separating the said parish of Up Marden from the said chapelry or tithing of Idsworth, until it reaches the parish of Compton, then proceeds along the boundary line, separating the said parishes of Up Marden and Compton, until it reaches the parish of East Marden, then follows the boundary line, separating the said parishes of Up Marden and East Marden, until it reaches Horsley-lane ; then proceeds south-easterly along the middle of Horsley-lane and enters the road to Forest-gate ; then proceeds south-westerly along the middle of that road until it reaches the boundary line of the parish of Stoughton; then proceeds south-easterly along the boundary line, separating the said parishes of Stoughton and Up Marden, until it reaches the road leading to Broad Reed Farm ; then proceeds southerly along the middle of that road for about fifty yards to the northern fence of Blue-fields, then proceeds south-easterly along the eastern fences of Bluefields and Brocks Napp until it reaches Park-lane ; then proceeds westerly along the middle of that lane until it reaches the paddock on the south side thereof, when it leaves the said lane and proceeds southerly, westerly, and northerly along the fences of that paddock and again enters the said lane, along which it proceeds westerly as far as Short-lane; then proceeds southerly along the middle of Short-lane and along the eastern fences of the Nine Acres, and the Woodland Fourteen Acres, until it reaches the boundary line of the parish of Racton; then proceeds westerly along the boundary line, separating the parishes of Stoughton and Racton, until it reaches the said parish of Warblington; then proceeds northwesterly along the boundary line, separating the said parishes of Stoughton and Warblington, until it reaches the Stone in the Sling Wall, where the boundary line of the said consolidated chapelry commenced as aforesaid, and which is more particularly delineated on the map or plan hereto annexed, and thereon coloured pink and blue.

"That the consents of the Right Reverend Ashurst Turner, Bishop of the said diocese of Chichester, of the Right Honourable and Right Reverend Charles James, Bishop of the diocese of London, patron in right of his see of the parish church of the said parish of Stoughton, and the Reverend George Augustus Langdale, of Compton, in the said county of Snssex, Clerk, patron in his own right of the parish church of the said parish of Up Marden, have been severally obtained to the formation of the said consolidated chapelry of Christ Church, Stansted, as required by the Acts and sections hereinbefore mentioned, in testimony whereof they have respectively signed and sealed this representation.

"Your Majesty's said Commissioners beg leave further to represent to your Majesty, that it has been mutually agreed between the said Charles James, Bishop of London, and George Augustus Langdale, as such respective patrons as aforesaid, testified as aforesaid, and Augustina Ivers Mary Dixon, of Stansted Park, in the said county of Sussex, Widow (in whom her heirs and assigns the right of presentation and appointment of a minister to serve the said church, called Christ Church, at Stansted aforesaid, is now vested, under and by virtue of the provisions of the will, with several codicils annexed thereto, of her late husband, Charles Dixon, of Stansted Park aforesaid, Esquire, deceased, who, previous to the execution of the said codicils, which bears date the thirteenth day of April, one thousand eight hundred and fifty-five, acquired the perpetual patronage or right of appointment to Christ Church, at Stansted aforesaid, under the powers contained in the twenty-third section of the Act of Parliament firstly hereinbefore mentioned, as amended by the fourth section of an Act, of Parliament, passed in the eleventh and twelfth years of your Majesty's reign, intituled 'An Act to amend the law relative to the assignment of ecclesiastical districts'), testified by her signing and sealing this representation with the approbation of your Majesty's said Commissioners, testified as hereinafter mentioned, and also of the said Ashurst Turner, Bishop of the said diocese of Chichester, testified as aforesaid, that the right of presentation and appointment of an incumbent or perpetual curate to serve the said church, called Christ Church, at Stansted aforesaid, should be vested in, belong to, and whenever occasion may require be exercised by, the said Augustina Ivers Mary Dixon, her heirs and assigns, for ever.

"Your Majesty's said Commissioners therefore humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the consolidated chapelry therein mentioned for the consecrated church called Christ Church, situate at Forestside, Stansted, in the parish of Stoughton, be accordingly formed, and that the agreement mentioned in the said representation, in respect of the right of presentation and appointment of an incumbent or perpetual curate to serve the said church, be carried into effect, agreeably to the provisions of the said Acts; and that the said right of presentation and appointment of an incumbent or perpetual curate to serve the said church shall be vested in, and shall belong to, and whenever occasion may require be exercised by, Augustina Ivers Mary Dixon, her heirs and assigns, for ever, she being the person mentioned in such representation; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Chichester.

WHEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the sixteenth section of an Act of Parliament, passed in the fifty-ninth year of the Reign of His Majesty King George the Third, intituled "An Act to amend and render more "effectual an Act passed in the last session of Par-"liament, for building and promoting the building "of additional churches in populous parishes," as enlarged by the twelfth section of an Act passed in the first section of an Act of Parliament passed in the third and fourth years of Her Majesty's reign; intituled "An Act to further amend the church "building Acts," duly prepared and laid before Her Majesty in Council a representation, bearing date the tenth day of January, one thousand eight hundred and fifty-six, in the words following; viz.:

"Your Majesty's Commissioners for building new churches beg leave humbly to represent that having taken into consideration all the circumstances of the district chapelry of the Holy Trinity, Wavertree (heretofore assigned or taken out of the parish of Childwall), in the county of Lancaster, and in the diocese of Chester, it appears to them to be expedient that a particular district should be assigned to the consecrated church of Saint Mary, situate at Wavertree, in the said district chapelry of the Holy Trinity, Wavertree, under and by virtue of the power or authority, contained in the sixteenth section of an Act of Parliament, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled 'An Act to amend and render more 'effectual an Act, passed in the last session of 'Parliament, for building and promoting the 'building of additional churches in populous 'parishes,' as enlarged by the first section of an Act of Parliament, passed in the third and fourth years of your Majesty's reign, intituled, 'An Act 'to further amend the church building Acts,' and that such proposed district should be named 'the District Chapelry of Saint Mary Wavertree,' and that the boundaries thereof should be those hereinafter mentioned; that is to say:

"The boundary line of the district chapelry of Saint Mary Wavertree, commences at the North Western Railway Bridge, on the road leading from Wavertree to Liverpool, and proceeds southeasterly along the middle of that road, through the village of Wavertree, passing Yew Tree House, as far as the road leading to Broad-green Railway Station, and proceeds north-easterly along the middle of that road, as far as Moss Cottage, and from thence northerly to Oak Vale Nursery, and the boundary line of the township of Wavertree, and thence proceeds westerly and southerly along such boundary line until it reaches the Railway Bridge at the point where the boundary line of the said district chapelry of Saint Mary Wavertree commenced, and as the same is more particularly delineated on the map or plan hereto annexed and thereon coloured pink.

"Your Majesty's said Commissioners beg leave further to represent that it also appears to them to be expedient that banns of marriage should be published, and that marriages, baptisms, and churchings should be solemnized or performed at the church of Saint Mary Wavertree aforesaid, and that one half of the fees to arise therefrom should be paid and belong to the Minister or Incumbent of such church for the time being, for his own use and benefit, and that the other half of such fees should be by such Minister or Incumbent received on account of, and paid over to the Incumbent for the time being of the said district chapelry of the Holy Trinity Wavertree, for his own use and benefit.

"That the consent of the Right Reverend John, Bishop of the said diocese of Chester, has been obtained thereto, as required by the Acts and sections hereinbefore mentioned, in testimony whereof he has signed and sealed this representation.

"Your Majesty's said Commissioners therefore humbly pray that your Majesty will be graciously pleased to take the premises into your royal con-

sideration, and to make such Order in respect thereto as to your Majesty, in your royal wisdom, shall seem meet."

Her Majesty, having taken the snid representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the proposed assignment of a particular district, to the consecrated church of Saint Mary, situate at Wavertree, in the district chapelry of the Holy Trinity Wavertree, be accordingly made, and that the recommendation of the said Commissioners in respect of the publication of banns and the solemnization of marriages, baptisms, and churchings, in the said church, and the fees to arise therefrom, be carried into effect agreeably to the provisions of the said Acts; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Chester.

The QUEEN's Most Excellent Majesty in Council.

WHEREAS Her Majesty's Commissioners for building new churches have, in pursuance of the sixteenth section of an Act of Parliament, passed in the fifty-eighth year of His Majesty King George the Third, initituled "An Act for building and promoting the building " of additional churches in populous parishes," duly prepared and laid before Her Majesty in Council a representation, bearing date the tenth day of January, one thousand eight hundred and fifty-six, in the words following; that is to say:

"Your Majesty's Commissioners for building new churches beg leave humbly to represent that, when the last census was taken, the parish of Lyncombe and Widcombe, in the county of Somerset, and diocese of Bath and Wells, contained a population of nine thousand nine hundred and seventy-three persons; that besides the parish church at Widcombe, which is the parish church of the said parish of Lyncombe and Widcombe, and which will accommodate one hundred and fifty persons, there are two consecrated churches or chapels in the said parish ; namely : one called Saint Marks, situate in the Lyncombe portion of the said parish, which will accommodate one thousand one hundred and eighty-three persons, including six hundred and thirty on free seats; and another, called Saint Matthew's, situate in the Widcombe portion of the said parish, which will accommodate one thousand two hundred and fifty persons, including six hundred on free seats :

"Your Majesty's Commissioners beg leave further to represent that having taken into consideration all the circumstances of the said parish of Lyncombe and Widcombe, it appears to them to be expedient that the same should be divided into two distinct and separate parishes for all ecclesiastical purposes whatever, under the powers contained in the sixteenth section of an Act of Parliament, passed in the fifty-eighth year of the reign of His Majesty King George the Third, intituled 'An Act for building and promoting the <sup>c</sup> building of additional churches in populous <sup>c</sup> parishes,' and that the same should be respectively named 'The parish of Lyncombe' and 'The parish of Widcombe ;' that the said church or chapel of Saint Mark, should become and be the parish church of the said parish of Lyncombe; that the present parish church at Widcombe aforesaid should remain or otherwise become and be the parish church of the said parish of Widcombe; and that the boundaries of the said two proposed parishes should be as follow; that is to say:

"The boundaries of the parish of Lyncombe commence at the north-western corner of such parish, where the same adjoins the parish of Twerton and the River Avon, and then proceed eastwardly along the middle of the said River Avon to Lower Widcombe Mill, on the west; then leaving the said River Avon and proceeding southwardly along the middle of the street or road, called Lyncombe Hill, and south-westwardly along the middle of the road or lane, called Greenway-lane, and then again, southwardly, along the middle of the road or lane, called Entry Hill, to the corner of the road near the house called the Cross Keys Inn, where the said parish of Lyncombe adjoins the parish of South Stoke; then proceeding in a westwardly direction along the boundary separating the said parish of Lyncombe from the parish of South Stoke to the point where the same adjoins the parish of English-combe; then proceeding northwardly along the boundaries separating the said parish of Lyncombe from the parishes of Englishcombe and Twerton to the point where the boundary line of the said parish of Lyncombe commenced, as the same is more particularly delineated on the map or plan

hereto annexed and thereon coloured green : "The boundaries of the parish of Widcombe commence at the western side of the mill (including the mill), called Lower Widcombe Mill, in the parish of Lyncombe and Widcombe, and then proceed northwardly along the middle of the River Avon to the point where the said parish of Widcombe adjoins the parish of Bathwick ; then in an eastwardly direction along the boundary line separating the said parish of Widcombe from the said parish of Bathwick, as far as the parish of Claverton; then proceed in a southwardly direction along the boundary of the said parishes of Widcombe and Claverton, as far as the parish of Monkton Combe, and then in a westwardly and southwardly direction along the boundary line separating the said parishes of Widcombe and Monkton Combe, as far as the parish of South Stoke: then westwardly along the boundary line separating the said parishes of Widcombe and South Stoke, as far as the house called the Cross Keys' Inn, at the southern end of the said road or lane called Entry-hill, and from thence pro-ceeding northwardly along the middle of the said road or lane called Entry-hill, and thence north-easterly along the middle of the said road or lane called Greenway-lane, and nothwardly along the middle of the road or street called Lyncombehill to Lower Widcombe Mill, where the boundary line of the said parish of Widcombe commenced, as the same is more particularly delineated on the map or plan hereto annexed, and thereon coloured pink.

"Your Majesty's said Commissioners beg leave further to represent that there is no glebe land belonging to the vicar or incumbent of the said entire parish of Lyncombe and Widcombc.

"Your Majesty's said Commissioners beg leave further to represent that the whole of the vicarial tithes or moduses of the entire parish of Lyncombe and Widcombe, now belonging to the vicar

or incumbent thereof, have been commuted into, and now consist of, a certain tithe rent charge, amounting to the annual sum of two hundred and sixty pounds, five shillings, and seven-pence, of which the sum of one hundred and thirty-one pounds, thirteen shillings, and two-pence is entirely arising in the Lyncombe portion of the said parish, and the remaining part thereof, amounting to the annual sum of one hundred and twentyeight pounds, twelve shillings, and five-pence, is entirely arising in the Widcombe portion of the said parish.

"Your Majesty's said Commissioners beg leave further to represent that the proportion of the said commuted tithe rent charge, amounting as aforesaid to the annual sum of one hundred and thirty-one pounds, thirteen shillings, and twopence, now arising and accruing in the Lyncombe portion of the said parish, should after such division as aforesaid, belong to, and be enjoyed by, the vicar or incumbent for the time being of the said parish and parish church of Lyncombe, and that the remainder of the said commuted tithe rent charge, amounting as aforesaid to the annual sum of one hundred and twenty-eight pounds, twelve shillings, and five-pence, now arising and accruing in the Widcombe portion of the said parish should, after such division as aforesaid, belong to, and be enjoyed by, the vicar or incumbent, for the time being, of the said parish and parish church of Widcombe; and they beg further to represent that the estimated amount of the relative proportions of commuted tithes or moduses which will hereafter belong or accrue to the vicar of each of the said parishes will be as aforesaid, one hundred and thirty-one pounds, thirteen shillings, and two-pence to the vicar of the said parish of Lyncombe, and one hundred and twenty-eight pounds, twelve shillings, and five-pence to the vicar of the said parish of Widcombe.

"Your Majesty's said Commissioners beg leave further to represent that it is estimated that the annual produce of fees, oblations, offerings, and other ecclesiastical dues which will, after such division aforesaid, arise or accrue to the vicar of the said parish of Lyncombe will amount to one hundred pounds, and of those which will, after such division as aforesaid, annually arise or accrue to the vicar of the said parish of Widcombe will also amount to one hundred pounds.

"Your Majesty's said Commissioners beg leave further to represent that the vicar or incumbent of the said parish and parish church of Lyncombe will also be entitled (as the minister of the same church now is) to the whole of the rents to be received and payable from the letting of the pews or sittings therein, which were duly assigned to the minister thereof by your Majesty's said Commissioners, under the provisions contained in the hereinbefore recited Act, by a certain instrument, bearing date the third day of April, one thousand eight hundred and thirty-two (save and except the annual sum of fifteen pounds, which by the same instrument was assigned out of such pew rents to the clerk of such church as a yearly salary).

salary). "That the consent of The Right Honourable and Right Reverend Robert John, Baron Auckland, Bishop of the said diocese of Bath and Wells, and also the consents of the Reverend William Marsh, of Beckenham, in the county of Kent, Clerk, Doctor in Divinity, the Reverend William Carus, of the city of Winchester, Clerk, the Reverend John Venn, of the city of Hereford, Clerk, the Reverend Edmund Hollond, of Hydepark-gardens, in the county of Middlesex, and of Benhall Lodge, in the county of Suffolk, Clerk, and the Reverend Edward Auriol, of Mecklenburgh-square, in the said county of Middlesex, Clerk, patrons of the parish church of the said parish of Lyncombe and Widcombe, have been obtained thereto, as required by the Act and section hereinbefore mentioned, in testimony whereof they have severally signed and sealed this representation.

"Your Majesty's said Commissioners beg leave therefore to lay before your Majesty the beforementioned circumstances, and humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the proposed division of the parish of Lyncombe and Widcombe into two distinct and separate parishes for all ecclesiastical purposes whatever, to be respec-tively named "The parish of Lyncombe" and "The parish of Widcombe," be accordingly made, and that the recommendations of the said Commissioners, with respect to the tithe rent-charge, and the fees, oblations, offerings, and other ecclesiastical dues arising and accruing within each respective portion of the said parish, and with respect to the pew rents of the parish church of Lyncombe, be carried into effect, agreeably to the provisions of the said Act; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Bath and Wells.
