Bill.

PPLICATION will be made by Petition to the House of Commons, on the 28th day of February instant, or as soon after as the forms of the House will permit, for leave to deposit a Petition for a Bill more effectually to provide for the Care and Reformation of Juvenile Offenders in the West Riding of the county of York.

It is intended by the said Bill, that the Justices in the said West Riding, or such other persons as the Bill shall name, may, upon the conditions and subject to the restrictions to be contained in the Bill, determine upon the building and management of a reformatory institution or institutions for Juvenile Offenders, in the said West Riding.

The Bill will enable the Justices to purchase by agreement, and hold and convey lands and other property for the purposes of such institutions, or to take such lands and property on lease, and to levy rates on the owners and occupiers of lands and property in the said West Riding, for the establishment and maintenance of such institution, and for the payment of any rent in relation thereto, and for the maintenance of the inmates thereof, and for the payment of the officers and servants connected therewith, and also to borrow money upon mortgage of such rates, and to make and enforce bye-laws and regulations for the management of the same institutions and the inmates thereof, and the officers and servants connected therewith.

The Bill will also authorise the said Justices to associate with themselves, either partially or absolutely, in the establishment and maintenance of such institutions, any neighbouring riding, county, or borough, and will extend the power of taxation, and of borrowing money upon the credit of the rate leviable under the Bill, to any such riding, county, or borough.

The Bill will enable the Justices of the said West Riding, and of any such associated place, to agree with individuals or with existing institutions for a participation in the establishment,

maintenance, and management of the institutions to be created under the powers of the Bill, or for acquiring a share in such existing institutions for the purposes of the Bill.
