#### PRESENT,

The QUEEN's Most Excellent Majesty in Council.

HEREAS by the "Foreign Deserters Act, 1852," it is provided, that whenever it is made to appear to Her Majesty that due facilities are or will be given for recovering and apprehending seamen who desert from British Merchant Ships in the territories of any Foreign Power, Her Majesty may, by Order in Council, stating that such facilities are or will be given, declare that seamen, not being slaves, who desert from Merchant Ships belonging to a subject of such Power, when within Her Majesty's dominions or the territories of the East India Company, shall be liable to be apprehended and carried on board their respective ships, and may limit the operation of such Order, and may render the operation thereof subject to such conditions and qualifications, if any, as may be deemed expedient.

And whereas it hath been made to appear to

And whereas it hath been made to appear to Her Majesty, that due facilities will be given for recovering and apprehending seamen who desert from British Merchant Ships in the territories

belonging to the Republic of Chile:

Now, therefore, Her Majesty, by virtue of the powers vested in Her by the said "Foreign Deserters Act, 1852," and by and with the advice of Her Privy Council, is pleased to order and declare, and it is hereby ordered and declared, that from and after the publication hereof in the London Gazette, seamen, not being slaves, who desert from Merchant Ships belonging to citizens of the Republic of Chile, within Her Majesty's dominions or the territories of the East India Company, shall be liable to be apprehended and carried on board their respective ships: Provided always, that if any such deserter has committed any crime in Her Majesty's dominions, or the territories of the East India Company, he may be detained until he has been tried by a competent Court, and until his sentence (if any) has been fully carried into effect.

And Her Majesty, by virtue of the powers vested in Her by the said "Foreign Deserters' Act, 1852," and by and with the advice of Her Privy Council, is further pleased to order and declare, that upon and after the publication hereof in the London Gazette, the Order in Council relating to seamen who desert from merchant ships belonging to citizens of the Republic of

Chile, made by virtue of the said Act, on the twenty-fifth day of February, one thousand eight hundred and fifty-six, and which was published in the London Gazette on the twenty-ninth day of February, one thousand eight hundred and fifty-six, shall be revoked, and the same is hereby revoked accordingly.

And the Right Honourable the Lords Commissioners of Her Majesty's Treasury, and the Commissioners for the affairs of India, are to give the necessary directions herein accordingly.

WHEREAS by an Act, passed in the last session of Parliament, intituled "An Act " for the better local management of the metro-" pol's," it is amongst other things enacted, that, upon the petition of the Metropolitan Board of Works or of any district board or vestry, representing to Her Majesty in Council, that by reason of the provisions of any local Act of Parliament relating to any district or parish or any part thereof respectively, difficulties have arisen in the execution of the said Act, and of such local Act or either of them, and praying for a suspension or alteration of all or any of the provisions of such local Act, or for the establishment of other provisions in lieu thereof, under this enactment, it shall be lawful for Her Majesty, by Order in Council, to suspend or alter all or any of the provisions of such local Act, or to make other provisions in relation to the matters thereof as Her Majesty, with the advice of Her Privy Council, may think necessary under the circumstances of the case; and every such Order in Council shall be laid before both Houses of Parliament within one month after the making thereof, if Parliament be then sitting, or if Parliament be not sitting, then within one month after the next meeting of Parliament, and shall be published in the London Gazette: Provided always, that no such Order in Council shall remain in force beyond the term of one year from the making thereof:

relating to seamen who desert from merchant And whereas, the vestry of the parish of Saint ships belonging to citizens of the Republic of Mary, Islington, have presented a potition to Her

Majesty in Council representing that, under the circumstances set forth in the said petition, they have found difficulties, arising by reason of the provisions of the said local Acts therein and hereinafter mentioned, in the execution of the said Metropolis Local Management Act, and praying the suspension of the provisions contained in certain of the sections of the said local Acts, and also praying that all the provisions, powers, and authorities therein respectively contained may be transferred to, vested in, and exercised by the said vestry.

Now, therefore, Her Majesty, having taken the said petition, and also a memorial of the trustees of the said parish of Saint Mary, Islington, relating thereto, into consideration, is pleased, by and with the advice of Her Privy Council, to suspend the provisions of the fourteenth section (so far as the same relate to the collection of the parochial rates) and of the thirty-nirth, forty-first, fortysecond, forty-sixth, forty-seventh, forty-eighth, and one hundred and forty-sixth sections of the local Act passed in the fifth year of the reign of His Majesty King George the Fourth (cap 125) intituled "An Act to repeal several Acts for the " relief and employment of the poor of the parish " of Saint Mary Islington, in the county of Mid-" dlesex; for lighting, and watching, and prevent-"ing nuisances therein; for amending the road from Highgate through Maiden Lane, and " several other roads in the said parish; and for "providing a chapel of ease and an additional "burial-ground for the same; and to make more "effectual provisions in lieu thereof," and also to suspend the provisions of the sixth section of the Local Act passed in the second year of the reign of His late Majesty King William the Fourth (cap. 26) intituled "An Act to equalize the eccle-"siastical burthens of the parish of Saint Mary, "Islington, in the county of Middlesex; for " partially altering the application of the rents and profits of the Stone Fields Estate within the said parish; for letting the pews in the parish church " of Saint Mary, Islington, and the Chapel of "Ease thereto; and for other purposes connected therewith," and the said sections and part of section are hereby suspended accordingly; and it is also ordered that (except as is hereinafter directed, all the provisions, powers, and authorities in the said sections, and part of section, respectively contained, be transferred to, vested in, and

exercised by the vestry of the said parish.

And Her Majesty is further pleased by and with the advice aforesaid, to order, and it is hereby ordered, that the trustees of the parish of Saint Mary, Islington, shall, from time to time, by a notice in writing to be signed by their chairman, and delivered at the office of the Vestry Clerk of the said parish, for the time being, require the vestry of the said parish, to levy and pay over to the treasurer of such trustees, or into any bank in such notice mentioned, and within the time or times thereby limited, the sums which such trustees may require for defraying the expenses payable out of the poor rates of the said parish.

And it is further ordered, that the vestry of the said parish shall levy the amount mentioned in every such notice and requirement, according to the exigency thereof, and shall for that purpose make an equal pound rate upon the parishioners of the said parish of such amount in the pound on the annual value of the property rateable, as will in their judgment be sufficient to raise the sum specified in such notice and requisition; and that such vestry shall pay to the treasurer of the trustees the amount mentioned in the notice or requisition, within the time or respective times

specified for that purpose; and that the said vestry shall, at the time of making any such payment, deliver, with the money, a note in writing, under their seal, or the hand of their Vestry Clerk, specifying the amount so paid, which note shall be kept as a voucher for the rest of that particular amount, and the receipt of the treasurer of the trustees, or of any proper officer or person of, or belonging to, any bank into which such money is so paid, specifying the amount paid to him by the vestry, shall be a sufficient discharge to the overseers for such amount.

And Her Majesty is further pleased to direct, that this order shall remain in force for one year from the date hereof, and no longer.

"Whereas it is by the said Act (amongst other things) enacted, that notwithstanding the charge by that Act created (being a charge created in favour of the Governors of the Bounty of Queen Anne), all the same and the like powers and rights of ownership as are possessed and enjoyed respecting and over any lands, tithes, rent-charges, tenements, or other hereditaments whatsoever, by any absolute owner thereof, shall be enjoyed by us with respect to and over all or any lands, tithes, rent-charges, tenements, or other hereditaments, vested in us under certain Acts therein mentioned (being the Acts under which the property hereinafter described is vested in us), and may, subject to the provisions of the same Acts, and of the now reciting Act, be exercised by us, by proper instruments in writing, duly executed according to law, with a certain proviso respecting the application of every sum of money received as the consideration or purchase money for the sale, transfer, or conveyance by us of any of such lands, tithes, tenements, or other hereditaments, or of any estate or interest therein, and with a further proviso that none of such lands, tithes, tenements, or other hereditaments be sold, transferred, or conveyed, except by the authority of a scheme, and an Order issued by your Majesty in Council ratify-

"And whereas under the provisions of an Order of your Majesty in Council, hearing date the ninth day of March, one thousand eight hundred

and fifty-four, and duly published in the London Gazette, on the fourteenth day of the same month certain lands, tenements, hereditaments, and endowments, in such Order particularly described, and formerly belonging to the said Bishop of Exeter, became vested in us, subject to any legally subsisting lease or leases thereof:

"And whereas application has been made to us for the purchase of all our estate and interest in certain portions of the said lands, tenements, and hereditaments; and, after due consideration, it appears to us to be expedient that we should be empowered to dispose of our interest therein, or in any part or parts thereof, in such manner as

shall appear to us to be advisable:

"We, therefore, humbly recommend and propose, that we may be authorized and empowered, by instrument or instruments in writing duly executed according to law, from time to time to sell and duly to convey, according to the provisions of the said Act, all or any of the said lands, tenements, hereditaments, or endowments heretofore belonging to the said Bishop of Exeter, which are so vested in us under the provisions of the said Order as aforesaid, with their appurtenances, and all our estate, right, title, and interest therein, or in any part or parts thereof, unto and to the use of any person or persons desirous or willing to purchase the same, and his or their heirs, executors, administrators, or assigns, or otherwise, as he or they shall direct or appoint, and for such consideration as shall upon due calculation and inquiry appear to us to be just and reasonable.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act,

or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Exeter.

"Your Majesty's Commissioners for building new churches beg leave humbly to represent that having taken into consideration all the circumstances of the parish of Llanfar, in the county of Merioneth, and in the diocese of Saint Asaph, it appears to them to be expedient that a par ticular district should be assigned to the con-secrated church of the Holy Trinity, situate at Rhos-y-Gwalia, in the said parish of Llanfar, under and by virtue of the power or authority contained in the sixteenth section of an Act of Parliament, passed in the fifty-ninth year of the reign of His Majesty King George the Third, intituled 'An Act to amend and render more effec-' tual an Act passed in the last session of Parlia-· ment for building and promoting the building of 'additional churches in populous parishes,' and in the third section of an Act of Parliament, passed in the second and third years of your Majesty's reign, intituled 'An Act to make better provision for the assignment of Ecclesiastical 'Districts to churches or chapels augmented by 'the Governors of the Bounty of Queen Anne, 'and for other purposes,' and that such proposed district should be named 'The District Chapelry of Russ-y-Gwalla,' and that the boundaries thereof should be those hereinafter mentioned; that is to say:

"The District Chapelry of Rhos-y-Gwalia is bounded on the north by the River Dee, and the parish of Llandderfel, on the north-east and partly on the cast by the parish of L'andrillo, on the

east by the parish of Llangynnog, on the southeast and partly on the south by the parish of Pennant, on other part of the south by the parish of Llannydyn, and on the west by the parish of Llangower, as the same district chapelry is more particularly delineated on the map hereto annexed,

and is thereon coloured green.

"Your Majesty's said Commissioners beg leave further to represent, that it also appears to them to be expedient that banns of marriage should continue to be published, and that marriages, baptisms, churchings, and burials should continue to be solemnized or performed in Holy Trinity Church, at Rhos-y-Gwalia aforesad, and that the fees to arise therefrom should be paid and belong to the minister or incumbent of such church for the time being.

" That the consent of the Right Reverend Thomas Vowler, Bishop of the said diocese of Saint Asaph, has been obtained thereto, as required by the Acts and sections hereinbefore mentioned, in testimony whereof he has signed and scaled

this representation.

"Your Majesty's said Commissioners therefore humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty having taken the said representation, together with the map thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the proposed assignment of a district chapelry to the consecrated church of the Holy Trinity at Rhos-y-Gwalia, in the parish of Llanfar, to be called "The District Chapelry of Rhos-y-Gwalia" be accordingly made, and that the recommendations of the said Commissioners in respect of the publication of banns and the solemnization of baptisms, churchings, and burials, in the said church, and in respect of the fees to arise therefrom, be carried into effect agreeably to the provisions of the said Acts; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Saint Asaph.

"Your Majesty's Commissioners for building new churches beg leave humbly to represent that having taken into consideration all the circumstances of the parish of Saint George, Birmingham, in the county of Warwick, and in the diocese of Worcester, it appears to them to be expedient that a particular district should be assigned to the consecrated church of Saint Matthias, situate in the said parish of Saint George, Birmingham, under the powers contained in the sixteenth section of an Act of Parliament, passed in the fiftyninth year of the reign of His Majesty King George the Taird, intituled 'An Act to amend and render more effectual an Act, passed in the last session of ' Parliament, for building and promoting the build-'ing of additional churches in populous parishes,' as enlarged by the third section of an Act of Parliament, passed in the second and third years of your Majesty's reign, intituled 'An Act to 'make better provision for the assignment of 'Ecclesiastical Districts to Churches or Chapels 'augmented by the Governors of the Bounty of ' Queen Anne, and for other purposes,' and that such proposed District should be named 'The DISTRICT CHAPELRY OF SAINT MATTHIAS, BIRM-INGHAM,' and that the boundaries thereof should be these hereinafter mentioned; that is to say:

"The boundary line of the district chapelry of Saint Matthias, Birmingham, commences at the point where Great Russell-street crosses the Hockley Brook, and proceeds in a southerly direction along the middle of Great Russell-street into Bridge-street, then turns easterly along the middle of Bridge-street as far as Eldon-street, then southerly along the middle of Eldon-street into New John-street West, then easterly along the middle of New John-street West as far as Summer-lane, then southerly along the middle of Summer-lane as far as Brearly-street (the same being the boundary line separating the parish of Saint George from the district of Saint Stephen, Birmingham), the boundary line of Saint Matthias District then proceeds westerly along the middle of Brearly-street and Brearly-street West into Well-street, then southerly along the middle of Well-street into Uncit-street, then north-westerly along the middle of Unett-street into Great Kingstreet, and south-westerly along the middle of Great King-street to Hockley Hill, then northerly along the middle of Hockley Hill as far as Hockley Brook, then easterly along the middle of that brook as far as Great Russell-street to the point where the boundary line of the said district chapelry of Saint Matthias, Birmingham, commenced, as the same is more particularly delineated on the map hereto annexed, and is thereon coloured red.

"Your Majesty's said Commissioners beg leave further to represent that it also appears to them to be expedient that banns of marriage should be published, and that marriages, baptisms, and churchings, should be solemnized or performed in the said church of Saint Matthias, and that the fees to arise therefrom should belong to the minister or incumbent of such church for the time being.

"That the consent of the Right Reverend Henry Bishop of the said diocese of Worcester has been obtained thereto, as required by the Acts and sections hereinbefore mentioned, in testimony whereof he has signed and sealed this representation.

"Your Majesty's said Commissioners therefore humbly pray that your Majesty will be graciously in

pleased to take the premises into your royal consideration, and to make such Order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

The Queen has been pleased to constitute so much of the present diocese of the Bishoprick of New Zealand as comprises all that portion of the middle Island of New Zealand which lies to the southward of a geographical line drawn across the said middle Island, at the northern boundary of the territory set apart for the Canterbury settlement under the provisions of the Act 13 and 14 Victoria, cap. 70; together with the southern Island of New Zealand, and the Auckland Islands, and all adjacent islands lying to the southward of the 43rd degree 5 minutes of south latitude, into a separate and distinct diocese, to be called "The Bishoprick of Christchurch," and to appoint the Reverend Henry John Chitty Harper, D.D., to be ordained and consecrated Bishop of the said diocese.

THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Ambassador at Paris, enclosing a copy of the following French Imperial Decree, relative to the importation of certain descriptions of iron.

Art. I.—In conformity with the regulations of the ordinance of 28 May, 1843, sheet iron, iron corners, and other articles of iron intended to be employed in the construction of iron ships and boilers for steam engines, will continue to be admitted free of duty, on condition of an engagement by the importers to re-export, within six months, manufactured articles of the nature of those described above, of a weight equal to the weight of the materials admitted to the privilege of the temporary free import.

Art. II.—Such sheet iron, iron corners, &c., cannot be imported, and iron ships and boilers cannot be re-exported, except through established warehousing ports (entrepôts réels), and through the offices on the frontier open to transit trade.

Art. III.—All deficiencies will give rise to the application of the penalties imposed by the Art. 3 of the law of the 5th July, 1836.

All discovered deficiencies arising from waste in the manufacture may, however, be considered as involving the payment of the duty attaching to the raw material.

Art. IV.—The regulations of the before-recited ordinance of 1843, which are not re-enacted by the present decree, are abolished.
