
Fixed Light at Verclut, St. Catherine's.

THE Lords Commissioners of the Admiralty hereby give notice, that on and after the 1st day of January, 1857, a light will be exhibited from the light tower recently erected at the outer extremity of Verclut pier or breakwater, on the north side of St. Catherine's Bay, on the east

coast of Jersey, one of the Channel Islands.

The light will be a fixed white light, the illumi-

nating apparatus a lens of the sixth order. The light is placed at a height of 60 feet above the mean level of the sea, and should be visible in ordinaryweather from the deck of a ship at a distance of from 7 to 10 miles.
