**A**T the Court at *Buckingham Palace*, the 20th day of *March*, 1857.

PRESENT,

The QUEEN's Most Excellent Majesty in Council.

**W**HEREAS by "The Common Law Procedure Act, 1854," it is enacted that it shall be lawful for Her Majesty, from time to time, by an Order in Council, to direct that all or any part of the provisions of the said Act, or of the rules to be made in pursuance thereof, shall apply to all or any Court or Courts of Record in England and Wales, and within one month after such Order shall have been made and published in the London Gazette such provisions and rules respectively shall extend and apply in manner directed by such Order, and any such Order may be, in like manner, from time to time altered and annulled; and that in and by any such Order Her Majesty may direct by whom any powers or duties incident to the provisions applied under the said Act, or "The Common Law Procedure Act, 1852," shall and may be exercised with respect to matters in such Court or Courts, and may make any orders or regulations which may be deemed requisite for carrying into operation in such Court or Courts the provisions so applied:

And whereas it has seemed fit to Her Majesty, by and with the advice of Her Privy Council, that all the provisions of the said Act (except such as are hereinafter excepted), shall extend and apply to the Court of Record of the city of *Norwich*, called the Guildhall Court:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, that, within one month after this Order shall have been published in the London Gazette, all the provisions of the said "Common Law Procedure Act, 1854," (except such as are contained in the sections of the said Act, numbered, respectively, 2, 17, 75, 76, 77, 95, 97, 98), and the whole of the 99th section (except so much thereof as explains the meaning of the word "action"), and also except such as are contained in sections 100, 101, 102, 104, 105, and 107, and the rules made and to be made in pursuance of the said Act, except such rules, if any, as apply exclusively to the said excepted sections, shall extend and apply to the said Court of Record of the city of *Norwich*, called the Guildhall Court:

And Her Majesty is further pleased to order, by and with the advice aforesaid, that all the

powers or duties incident to the provisions of the said Act hereby applied to the said Court of Record shall be exercised, in respect to matters in the said Court, by the Judge thereof.

And whereas it has seemed fit to Her Majesty, by and with the advice of Her Privy Council, that all the provisions of the said Act should be extended and applied to the Court of Record of the city of *Norwich*, called the Guildhall Court;

Now, therefore, Her Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that within one month after this Order shall have been made and published in the London Gazette, all the provisions of the said "Summary Procedure on Bills of Exchange Act, 1855," shall apply to the said Court of Record of the city of *Norwich*, called the Guildhall Court, so far as the same may be applicable to the said Court;

And Her Majesty is further pleased, by and with the like advice, to direct that all the powers or duties incident to the provisions of the said Act hereby applied to the said Court of Record, shall be exercised, in respect to matters in the said Court, by the Judge thereof.
