The Speech of the Lords Commissioners to both Houses of Parliament, on Friday, August 28, 1857.

My Lords, and Gentlemen,

W E are commanded by Her Majesty to release you from further attendance in Parliament; and at the same time to express to you Her Majesty's cordial acknowledgments for the zeal and assiduity with which you have performed your important duties during a Session which, though shorter than usual, has nevertheless been unusually laborious.

Her Majesty commands us to express to you Her satisfaction that the present state of affairs in Europe inspires a well-grounded confidence in the continuance of Peace.

The arrangements connected with the full execution of the stipulations of the Treaty of Paris have from various causes not yet been completed; but Her Majesty trusts that by the earnest efforts of the contracting parties to that Treaty all that remains to be done with reference to its stipulations may ere long be satisfactorily settled.

Her Majesty commands us to inform you, that the extensive mutinies which have broken out among the Native troops of the army of Bengal, followed by serious disturbances in many parts of that Presidency, have occasioned to Her Majesty extreme concern; and the b rbarities which have been inflicted upon many of Her Majesty's subjects in India, and the sufferings which have been endured, have filled Her Majesty's heart with the deepest grief; while the conduct of many civil and military officers, who have been placed in circumstances of much difficulty, and have been exposed to great danger, has excited Her Majesty's warmest admiration.

Her Majesty commands us to inform you, that She will omit no measure calculated to quell these grave disorders; and Her Majesty is confident that, with the blessing of providence, the powerful means at Her disposal will enable Her to accomplish that end.

Gentlemen of the House of Commons,

Her Majesty commands us to thank you for the liberal supplies which you have voted for the service of the present year, and for the assurances which you have given Her of your readiness to afford Her Majesty whatever support may be necessary for the restoration of tranguillity in India.

Her Majesty has been gratified to find that you have been enabled to provide the amount required to be paid to Denmark for the redemption of the

Sound dues, without on that account adding to the National Debt.

My Lords and Gentlemen,

Her Majesty commands us to convey to you Her heartfelt acknowledgments for the provision which you have made for Her beloved daughter the Princess Royal, on Her approaching marriage with His Royal Highness Prince Frederick William of Prussia.

Her Majesty commands us to inform you, that She has seen with satisfaction that, although the present Session has been short, you have been able to pass many Acts of great importance, and to which Her Majesty has given Her cordial assent.

The Acts for establishing a more efficient jurisdiction for the proving of wills in England and Ireland correct defects which have for many years been complained of.

The Act for amending the law relating to divorce and to matrimonial causes will remedy evils which have long been felt.

The several Acts for the punishment of fraudulent breaches of trust ;

For amending the law relating to secondary punishments;

For amending the law concerning joint stock banks;

For consolidating and amending the law relating to bankruptcy and insolvency in Ireland;

For the better care and treatment of pauper lunatics in Scotland;

For improving the organization of the county police in Scotland;

Together with other Acts of less importance, but likewise tending to the progressive improvement of the law, have met with Her Majesty's ready assent.

We are commanded by Her Majesty to express to you Her confidence, that, on your return to your several counties, you will employ that influence which so justly belongs to you, to promote the welfare and happiness of Her loyal and faithful people; and She prays that the blessing of Almighty God may attend and prosper your endeavours.

Then a Commission for prorogning the Parliament was read; after which the Lord Chancellor said,

My Lords, and Gentlemen,

By virtue of Her Majesty's Commission, under the Great Seal, to us and other Lords directed, and now read, we do, in Her Majesty's name, and in obedience to Her commands, prorogue this Parliament to Friday the sixth day of November next, to be then here holden ; and this Parliament is accordingly prorogued to Friday the sixth day of November next.

And whereas it has seemed fit to Her Majesty, by and with the advice of Her Privy Council, to order and direct that the Lieutenants of the several counties, ridings, and places in England, and of the counties, stewartries, cities, and places in Scotland, and also the Lord Lieutenant or other Chief Governor or Governors of Ireland, to draw out and embody all the regiments, battalions, and corps of militia, appointed to be raised and trained, or so many of them, or such part or proportion of them, or any of them, as Her Majesty shall judge necessary.

Now, therefore, Her Majesty by and with the advice of Her Privy Council, doth hereby order and direct the Lieutenants of the several counties, ridings, and places in England, and of the counties, stewartries, cities, and places in Scotland, and also the Lord Lieutenant or Chief Governor or Governors of Ireland, to draw out and embody all the regiments, battalions, and corps of militia, appointed to be raised and trained, or so many of them, or such part or portion of them, as Her Majesty shall judge necessary.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter one hundred and thirteen, section sixtysix, and of the Act of the fourth and fifth years of Her Majesty, chapter thirty-nine, section twenty, and of the Act of the fifth and sixth years of Her Majesty, chapter one hundred and eight, section eleven, duly prepared and laid before Her Majesty

in Council a scheme, bearing date the twenty-sixth day of March, in the year one thousand eight hundred and fifty-seven, in the words and figures following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the third and fourth years of your Majesty, chapter one hundred and thirteen, section sixty-six, and of the Act of the fourth and fifth years of your Majesty, chapter thirty-nine, section twenty, and of the Act of the fifth and sixth years of your Majesty, chapter one hundred and eight, section eleven, have prepared and now humbly lay before your Majesty in Council the following scheme for regulating the incomes of the dean and cauons of the cathedral church of Canterbury.

"Whereas it has been made to appear to us that the annual incomes of the dean and canons of the said cathedral church are subject to much fluctuation and uncertainty, and we have satisfied ourselves, after due inquiry and consideration, that the following arrangement should be adopted for regulating such incomes:

"Now, therefore, we humbly recommend and propose that there shall be delivered to us by the treasurer of the cathedral church of Canterbury, in this present and every future year so soon as conveniently may be after the annual audit of the accounts of the chapter of the said cathedral church, a correct account in writing, in such form and verified in such manner as we shall from time to time direct, showing every sum of money, from whatsoever source arising, which, according to the statutes and usage of the said cathedral church or the chapter thereof, shall have become due and payable to the dean and each canon in respect of the deanery, and of each canonry of the said cathedral church for the year ending on the day up to which such ac-counts shall have been so audited as aforesaid, and that if at any time it shall appear by any such account that the amount which may have so become due and payable to any such dean shall exceed the sum of two thousand pounds, or to any such canon the sum of one thousand pounds, then and in every such case the amount of the surplus shall at the same time be paid by the said trea-surer to our credit at the Bank of England, and that upon any account so delivered being examined and approved by our treasurers for the time being, their receipt for the amount of any such surplus shall be given to the said treasurer of the said cathedral church and shall be a good and valid discharge for the same; and that if at any time it shall appear by any such account that the amount so due and payable in the case of any such dean shall be less than the sum of two thousand pounds, or in the case of any such canon less than the sum of one thousand pounds, then and in every such case there shall be paid by us forthwith to such treasurer, on account of such dean or canon, such a sum of money as shall make up the deficiency; and the receipt of such treasurer, countersigned by the same dean or canon, as the case may be, shall be a good and sufficient discharge for any claim which such dean or canon may have on us in respect of the average annual income to which he may be entitled for the year to which the same account relates under the provisions of the said Acts.

"Provided always, and we further recommend and propose, that all moneys which, according to the statutes and usage of the said cathedral church, or the chapter thereof, may be receivable by any dean or canon thereof succeeding, upon the first vacancy of the deanery, and of each canonry, happening after the date of any Order of your Majesty in Council ratifying this scheme as aforesaid, shall be included in the next yearly account to be delivered to us as aforesaid; and that the income of the dean or canons so newly appointed

shall be made up or limited, as the case may be, in manner aforesaid, to such part of the sum of two thousand pounds, or one thousand pounds respectively, and no more, as shall be proportioned, ac-cording to such rate, to the period during which he shall have been appointed to such deanery or canonry

"And that upon every subsequent vacancy of the deanery or any canonry, all the moneys which, according to the statutes and usage of the said cathedral church, or the chapter thereof would if such vacancy had not taken place, have become due and payable to the dean or canon making such vacancy, out of the revenues of the said cathedral church for the year ending on the day of the next ensuing annual audit as aforesaid, shall be included in the account so to be delivered to us as aforesaid, after such audit ; and that the whole of any surplus above the sum of two thousand pounds in the case of a dean, and one thousand pounds in the case of a canon, shall be paid to us; and that in case the amount of such moneys shall be below the said sum of two thousand pounds or one thousand pounds, as the case may be, we shall not be called upon to pay, in respect of such deanery or canonry, any greater sums for that year than shall together be necessary to make up the income of such deanery or canonry for that year to two thousand pounds or one thousand pounds, as the case may be; and that the respective incomes of two thousand pounds to the dean and one thousand pounds to each canon, so to be secured as aforesaid, shall, on every such vacancy as last aforesaid, be strictly apportionable between the dean or canon making the vacancy, or his representatives, and the dean or canon succeeding thereto, any statutes or usage of the said cathedral church relating to the division of the corporate revenues thereof to the contrary notwithstanding

"And we further recommend and propose, with the consent of the Very Reverend Henry Alford, Dean of the said Cathedral Church of Canterbury, testified by his having hereunto set his hand and seal, that the provisions of this scheme shall apply to and affect him, the said Henry Alford, and the income payable to him as such dean.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the said cathedral church, or the deans and canons thereof, in conformity with the provisions of the said Acts, or either of them, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pur-suant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Canterbury. "Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint Peter, situate at Notting Hill aforesaid.

"Now therefore, with the consent of the Right Honourable and Right Reverend Archibald Campbell, Bishop of London, and of the Reverend John Philip Gell, incumbent of the said district parish of Saint John, Notting Hill, testified by their having signed and sealed this representation, we humbly represent that it would, in our opinion, be expedient that all that part of the said district parish of Saint John, Notting Hill, described in the Schedule hereunto annexed, all which part, together with the boundaries thereof is de-lineated and set forth on the map or plan hereunto also annexed, should be assigned to the said church of Saint Peter, and that the same should be named 'The District chapelry of Saint Peter, Notting Hill.

"And with the like consent of the said Archibald Campbell, Bishop of London, testified as aforesaid, we further represent that it appears to us to be expedient that hanns of marriage should be published, and that marriages, baptisms, and churchings, should be solemnized or performed at such church, and that the fees to arise therefrom should be paid and belong to the Minister of the same church for the time being.

"We, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such order with respect thereto as to your Majesty in your royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing representation has reference.

"The district chapelry of Saint Peter, Notting Hill, being all that part of the district parish of Saint John, Notting Hill, which is situate on the eastern side of a line commencing at a point marked A on the map or plan hereunto annexed, in the street or road called Ledbury-road, where it crosses the boundary of such district parish, and thence extending southward along the middle of such road to a point opposite to the middle of the street or road called Westbourne-gardens, and extending thence westward along such last-mentioned street or road, and of the streets or roads called

Archer-street and Ladbrooke-gardens, otherwise Saint Columb-terrace, to a point opposite to the middle of the street or road called Stanley-crescent, and thence extending southward along the middle of such last-mentioned road as far as the middle of the street or road called Kensington Park-gardens, and thence extending eastward along the middle of such last mentioned street or road as far as the middle of the street or road called Kensington Park-road, and thence extending towards the south-east along the middle of such last-mentioned road, as far as the middle of the turnpike-road leading from Notting Hill to London, and thence extending eastward along the middle of such turnpike-road until it meets the boundary of the said district parish of Saint John's, Notting Hill."

"And whereas by the same deed the said Edmund Davys has, with the consent of the said George, Bishop of Peterborough, granted and secured to the incumbent of the said district or new parish, so soon as one shall be appointed and licensed, and to his successors incumbents thereof for the time being, a clear annual sum of thirty pounds, by means of a rentcharge issuing out of and charged upon certain lands and hereditaments situate in the parish of Saint John Baptist, Peterborough, forming part of the endowments of the said vicarage of Saint John Baptist, Peterborough. "And whereas it has been proposed to us by the said Charles William, Earl Fitzwilliam, and by the said Edmund Davys, and it appears to us to be expedient, that in consideration of the benefaction towards the endowment of the incumbent of the district or new parish hereinafter recommended to be constituted, firstly above mentioned, the whole right of patronage of the said district or new parish, and the right of nomination of the incumbent of the same, should be assigned to the said Charles William, Earl Fitzwilliam, his heirs and assigns, in manuer hereinafter recommended and proposed.
