PRESENT.

The QUEEN's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act of the sixth and seventh years of Her Majesty, chapter thirty-seven, duly prepared and laid before Her Majesty in Council a scheme, bearing date the thirteenth day of August, in the year one thousand eight hundred and fifty-seven, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the sixth and seventh years of your Majesty, chapter thirty-seven, have prepared and now humbly lay before your Majesty in Council, the following scheme for assigning the right of patronage of the new parish of Saint James, Hatcham, in the counties of Surrey and Kent, and in the diocese of London.

"Whereas by Orders made by your Majesty in Council, bearing date respectively the thirtieth day of June, in the year one thousand eight hundred and forty-five, and the seventh day of March, in the year one thousand eight hundred and fifty-one, and duly published in the London Gazette, the district of Saint James, Hatcham, was constituted out of the parish of Saint Paul, Deptford, in the counties of Kent and Surrey, and in the diocese of Rochester, and the right of patronage of the said district of Saint James, Hatcham, and of the nomination of the minister thereof for the first turn of presentation, was assigned to Alexander Read, of Dorset-square, in the county of Middlesex, Esquire; and whereas the Reverend Augustus Kerr Bozzi Granville was duly nominated and licensed to the said district; and whereas the said district has since become a new parish for ecclesiastical purposes under the provisions of the said Act, and the said Augustus Kerr Bozzi Granville is now the perpetual curate thereof.

And whereas a suitable house of residence for the perpetual curate for the time being of the said new parish has been provided by the said Augustus Kerr Bozzi Granville upon the understanding that in consideration thereof we should recommend to your Majesty in Council that the right of patronage of the said new parish, and of the nomination of the perpetual curate thereto, should be assigned to the said Augustus Kerr Bozzi Granville, his heirs

and assigns, in manner hereinafter mentioned.
"Now, therefore, we humbly recommend and propose, that the right of patronage of the said new parish of Saint James, Hatcham, and of the nomination of the perpetual curate thereto, shall, without any conveyance or assurance in the law other than this scheme and any duly gazetted Order of your Majesty in Council ratifying the same, and upon and from the day upon which such Order shall be published in the London Gazette, be assigned to and absolutely vested in, and shall and may from time to time be exercised by the said Augustus Kerr Bozzi Granville, his heirs and

assigns, for ever.
"Aud we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Act, or of any other Act of Parliament."

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same, and every part thereof, shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct, that this Order be forthwith registered by the Registrar of the diocese of London.

REGULATIONS to be observed at the magazines, Liverpool, during the repair of one of the magazines, authorized by Master-General of Ordnance, as per Gazette of 25th February, 1852, and to continue in force until the magazine is again moored for the reception of powder.

1. All vessels having gunpowder on board are to hoist a red flag, which is to be kept up until the whole of the powder is discharged.

2. The import vessel is not to anchor within a quarter of a mile of the magazine; before anchoring all fires are to be completely extinguished, and they are not on any account to be relighted until the powder is discharged.

3. In any lighter used for the temporary accommodation of powder during the repair of the magazine, all iron bolts, nails, &c., in the hold or other part of the vessel, which may be at all liable to be brought into contact with the powder barrels, are to be carefully covered with sheet lead or pieces of leather, secured by copper nails; and the Master is enjoined to assure himself by frequent examination that such is the case.

4. On receiving powder on board the lighter, the Master is to see that the platform in the vessel's hold and the gangways and coverings of the hatchways are covered with tanned hides, the hold having previously been carefully swept and freed from grit or dust.

5. While any powder continues on board, the vessel is on no account to be left without either the Master or the Mate, and one other man.

6. The men employed in receiving or discharging the powder are to be clothed in canvas frocks and trousers, and to wear magazine slippers, such clothing to be worn at no other time.

7. No lights are to be allowed, except the signal one; another for the watch, which is to have water under it; and a temporary light in an approved hand-lantern, which is to brought from the shore for the purpose of lighting the signal and the light for the watch, and which is then to be extinguished. Smoking is strictly prohibited, and under no pretence whatever is any lucifer match to be permitted on board.

8. Import vessels with mixed cargoes are to observe the same precautions in approaching the lighter and discharging their powder as they would do under similar circumstances at the magazine.

9. Printed copies of these regulations are to be given to the masters and placed in conspicuous parts of the vessels.

10. Any lighter used for the foregoing purposes is to be under the direction of the authorized Storekeeper of the magazines.
