N.B. The Knights of the several Orders are to appear in their Collars at the Levee on the 17th of March next, it being a Collar Day.

Notice is hereby given, that all persons having petitions or addresses to present to Her Majesty at the Levees are to send a card having on it their names, a statement of the object of such Petitions or Addresses, and the names of the persons from whom they come, to the Lord Chamberlain's Office, before twelve o'clock on the day but one previous to each Levee; and that two other cards, having on them precisely what is written upon that sent to the Lord Chamberlain's Office, are to be taken to the Levee; one of the two cards to be delivered to the Page in the Corridor, and the other to the Lord Chamberlain, who will read its contents to Her Majesty; and, on these occasions, no other statement is to be addressed to Her Majesty.

A Deputation to present an Address is not to exceed four persons.

THE following Address of congratulation to the Queen, on the occasion of the Marriage of Her Royal Highness the Princess Royal with His Royal Highness Prince Frederick William of Prussia, having been transmitted to the Right Honourable the Secretary of State for the Home Department for presentation, have accordingly

been presented by him to Her Majesty, who has been pleased to receive the same very graciously:

To the QUEEN'S Most Excellent Majesty.

The humble Address of the Mayor, Aldermen, and Burgesses of the Borough of New Windsor, in the County of Berks, in Council assembled.

May it please your Majesty,

WE, your Majesty's loyal and dutiful subjects, the Mayor, Aldermen, and Burgesses of the loyal and ancient borough of New Windsor, who have on so many occasions been graciously permitted to address your Majesty, would entreat permission again to approach your Majesty with the expression of our sincere congratulations on that happy event which has recently united Her Royal Highness the Princess Royal to His Royal Highness the Prince Frederic William of Prussia.

We confidently anticipate that the care which has been so affectionately bestowed by your Majesty and your Illustrious Consort upon the nurture and education of the Royal Princess will, under the Divine Blessing, enable her to follow in the footsteps of your Majesty, and show forth those domestic and public virtues which have been so eminently displayed by your Majesty as a Wife, a Mother, and a Sovereign.

We trust that the alliance, which has been so auspiciously formed between the Royal Families of England and Prussia, may be succeeded by a feeling of mutual confidence and by a cordial and lasting friendship between the people of those

two great Protestant Countries.

May the blessing of Almighty God rest upon their Royal Highnesses, and may your Majesty and His Royal Highness the Prince Consort long live to witness the domestic happiness and prosperity of Her Royal Highness and the Royal Prince to whose care and guidance the Princess Royal of England has been confided.
