the College of Saint Mary, Winchester," made an Ordinance, dated the 12th of December, 1857, to amend an Ordinance made by the Oxford University Commissioners on the 28th of March in that year, and approved by Her Majesty in Council on the 27th of August following; and whereas such Ordinance was on the 17th of December, 1857, approved by the said Commissioners, and has been this day laid before Her Majesty in Council, the same is published in pursuance of the provisions of the said Act, and of the 17th and 18th Vict., cap 81. And NOTICE is hereby given, that it is lawful for the bodies or persons mentioned in the 35th section of the last-mentioned Act, within one month after this publication, to petition Her Majesty in Council against the approbation of the said Ordinance, or of any part thereof.

ORDINANCE ABOVE REFERRED TO.

Whereas the Commissioners appointed for the purpose of an Act passed in the seventeenth and eighteenth years of the reign of Her Majesty Queen Victoria, intituled, "An Act to make further provision for the good government and extension of the University of Oxford, of the Colleges therein, and of the College of Saint Mary, Winchester," framed and settled an Ordinance, dated the twentyeighth day of March, one thousand eight hundred and fifty-seven, which Ordinance was duly approved by Her Majesty in Council on the twentyseventh day of August, one thousand eight hundred and fifty-seven; and whereas the said Ordinance contains the following clause or portion of a clause: Clause 33-" The four Exhibitions of the foundation of John Warner, Bishop of Rochester, shall be consolidated into two Exhibitions, the holders of which shall receive by equal shares the whole emoluments now payable to the four exhibitioners. The election of Exhibitioners of the said foundation shall be held after a competitive examination of the candidates in such subjects, and conducted in such manner as the electors shall from time to time appoint, and that candidate, being otherwise duly qualified according to the instru-ment of foundation, shall be elected, who after such examination shall appear to be of the greatest

And whereas by an Act passed in the nineteenth and twentieth years of the reign of Her Majesty Queen Victoria, intituled, "An Act to amend the Act of the seventeenth and eighteenth years of Her Majesty, concerning the University of Oxford and the College of Saint Mary, Winchester," it is enacted that it shall be lawful for any College, of or in relation to which any Regulation, Ordinance, or Statute shall have been approved by Her Majesty in Council under section 36 of the said Act, from time to time, with the approval of the Commissioners, and during the continuance of their powers under the said Act, to amend or alter such Regulation, Ordinance, or Statute, subject to the same conditions and provisions as are imposed by the Act in relation to the making of the original regulation, ordinance, or statute.

And whereas it is expedient that the said Ordinauce of the twenty-eighth day of March, one thousand eight hundred and fifty-seven, should be amended as hereinafter mentioned. We, the Master and Fellow's (otherwise styled the Masters and Scholars) of Balliol College aforesaid, ordain as follows: The said Ordinance of the twenty-eighth day of

March, one thousand eight hundred and fifty-seven, shall henceforth be read as if in lieu of the clause or part of a clause hereinbefore set forth, there had been inserted therein the clause or part of a clause following:

The four Exhibitions of the Foundation of Doctor John Warner, Bishop of Rochester, shall be consolidated into one Exhibition, the holder of which shall receive the whole emoluments now payable to the four Exhibitioners. The Exhibitioners shall be elected from candidates born in Scotland, or whose fathers shall have been born in Scotland. No person shall be admissible as a candidate who shall have completed the fourth term of his academical residence in the University of Oxford. The election of Exhibitioners shall be held after a competitive examination of the candidates in such subjects, and conducted in such manner, as the electors shall from time to time appoint, and that candidate, being otherwise duly qualified according to the instrument of Foundation and this Ordinance, shall be elected, who after such examination shall appear to be of the greatest merit. Any Exhibitioner of the said Foundation who may be elected to and accept an Exhibition founded under the Will of Mr. John Snell, shall vacate the Exhibition held by him when so elected. Whenever there shall be no duly qualified candidate for a vacant Exhibition of the Foundation of Doctor John Warner, whom the electors shall judge of sufficient merit for election, the Exhibition shall be thrown open for that turn to general competition, and the election to it shall be held at some time within three months from the day originally fixed for that purpose, from which day the five years for which such Exhibition is now made tenable shall in that case be computed.

HER Majesty has been pleased, by her Order in Council of the 3rd February, 1858, to grant to Peter Rothwell Jackson, of Salford, county of Lancaster, a prolongation for the term of six years of certain letters patent for the United Kingdom of Great Britain and Ireland, for "improvements in the construction and manufacture of wheels, cylinders, hoops, and rollers, and in the machinery or apparatus connected therewith," on condition that the said Peter Rothwell Jackson, previously to the sealing of the new letters patent, do enter in the proper form by law provided, his disclaimer of certain parts of the said invention, such letters patent having been originally granted to the said Peter Rothwell Jackson, and bearing date the 24th February, 1844, for England, Wales, and the town of Berwick-upon-Tweed; the 17th September, 1844, for Scotland; and the 23rd October, 1844, for Ireland.
