"Whereas by the authority of an Order of your Majesty in Council, bearing date the seventeenth day of April, one thousand eight hundred and forty-four, and duly published in the London Gazette, on the twenty-third day of July following, the said Chapelry District was duly assigned out of the parish of Colton, in the same county and diocese.

"And whereas it has been made to appear to us to be expedient that the boundaries of such Chapelry District should be altered so as to include within them a portion of the adjacent parish of Cartmel in the same county and diocese.

"Now therefore, with the consent of the Honourable and Right Reverend Henry Montagu, Bishop of Carlisle; the Reverend Samuel Thomas Clarke, incumbent of the parish church of the said parish of Colton, and, as such incumbent, patron of the said Chapelry District of Haverthwaite ; the Reverend Richard Heighway Kirby, incumbent of the same Chapelry District; the Most Noble William, Duke of Devonshire, patron of the parish church of the said parish of Cartmel, during the subsistence and by virtue of a certain lease of the impropriate rectory of the same parish, granted to him, the said Duke when Earl of Burlington, by the late Bishop of Chester for certain lives therein specified; the Right Reve-rend John, Bishop of Chester, patron in right of his see of the last-mentioned church, in reversion expectant on the determination of such lease as aforesaid; and the Reverend Robert Curteis Hubbersty, incumbent of such last-named parish church, in testimony whereof they have respectively signed and sealed this representation, we beg leave to represent that it appears to us to be expedient that the boundaries of the said Chapelry Di-trict of Haverthwaite should be altered so as to include therein all that part of the township of of Upper Holker, in the parish of Cartmel, in the county of Lancaster and diocese of Carlisle, situate on the north and west of an imaginary line extending along the middle of so much of the road leading from Cartmel to Brow Edge, as is south of the Gravel Pits near Outley Mosses, being in length about eight hundred and eighty paces, and of a certain occupation road leading thence by Outley Mosses aforesaid, to Grass Garth and Stribers, and across the road leading from Low Wood to Holker, and along the middle of the streams or waters called Striders Beck and Skelwith Pool.

"And we humbly pray that your Majesty will be graciously pleased to take the premises into your royal consideration, and to make such Order in respect thereto as to your Majesty in your royal wisdom shall seem meet."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the proposed alteration of the boundaries of the said Chapelry District of Haverthwaite, by including within them a portion of the adjacent parish of Cartmel, in the said county of Lancaster, should be accordingly made and effected, agreeably to the provisions of the said first-mentioned Act; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Carlisle.
