nincteenth and twentieth years of your Majesty, chapter fifty-five; have prepared and now humbly lay before your Majesty, the following representation for altering the boundaries of the chapelry district of Whitechapel, in the county of York, and diocese of Ripon.

"Whereas by the authority of an Order of your Majesty in Council, bearing date the twentysecond day of July, one thousand eight hundred and forty-seven, and duly published in the London Gazette on the twenty-seventh day of the same month of July, the said district was duly assigned out of the parish of Birstal, in the said county and diocese.

"And whereas it has been made to us to appear expedient that the boundaries of such district should be altered as hereinafter mentioned.

"Now, therefore, with the consent of the Right Reverend Robert, Bishop of Ripon (who is patron in right of his see of the parish church of the said parish of Birstal), and of the Reverend William Margetson Heald, incumbent of the same church, in testimeny whereof they have respectively signed and sealed this representation, we beg leave to represent that it appears to us to be expedient that the boundaries of the said chapelry district of Whitechapel should be altered so as to include within such district all that portion of the chapelry district of Saint John, Cleckheaton, in the said parish of Birstal, which is situate on the western side of an imaginary line extending along the middle of a footway leading from a lane called Whitcliffe-lane to Upper Blakup; and also all that part of the chapelry or district of Liver-sedge, in the said parish of Birstal, which is situate to the north of an imaginary line which commences at the point marked A on the map hereunto annexed, where the fence forming the northern boundary of the close numbered 1062 on the tithe map of the township of Liversedge, in the said parish of Birstal, abuts upon a certain stream called Moor Bottom Beck, and thence extends in a westerly direction along the middle of such fence to the north-west corner of the said close numbered 1062, and thence westward in a straight line across the two closes numbered respectively 1061 and 1060 on the said maps, to the point marked B on the said map hereunto annexed, being the point where such last-mentioned straight line joins the stream dividing the township of Liversedge from the township of Cleckheaton, which point is distant fourteen yards to the south-west of the junction of the said stream with the stream flowing from Lark-hill, as the same are more particularly delineated on the map or plan hereunto annexed.

"And we humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order in respect thereto as to your Majesty in your Royal wisdom shall seem meet."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council to approve thereof, and to order, and it is hereby ordered, that the alteration of the boundaries of the said district proposed in and by the said representation. be accordingly made and effected agreeably to the provisions of the said Acts; and Her Majesty is further pleased, by and with the like advice, to direct that this Order be forthwith registered by the Registrar of the diocese of Ripon.

HEREAS the Ecclesiastical Commissioners VV for England have, in pursuance of an Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four, section sixteen; of an Act of the second and third years of Her Majesty, chapter forty-nine, section three; and of an Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five. section one; duly prepared and laid before Her Majesty in Council, a representation, bearing date the eleventh day of March, in the year one thousand eight hundred and fifty-eight, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the third, the Ecclesiastical Commissioners for chapter one hundred and thirty-four, section sixteen; of the Act of the second and third years of your Majesty, chapter forty-nine, section three; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five, section one; have prepared and now humbly lay before your Majesty in Council the following representation as to the assignment of a district chapelry to the consecrated church of the Holy Trinity, situate at Calverhall, in the parish of Prees, in the county of Salop, and in the diocese of Lich-

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of the Holy Trinity, situate at Calverhall aforesaid.

" Now, therefore, with the consent of the Right Reverend John, Bishop of Lichfield, testified by his having signed and scaled this representation, we humbly represent that it would, in our opinion, be expedient that all that part of the said parish of Prees, described in the Schedule hereunto annexed, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto also annexed, should be assigned to the said church, and that the same should be named 'The District Chapelry of the Holy Trinity, Calverhall.'

"And with the like consent of the said John, Bishop of Lichfield, testified as aforesaid, we further represent, that it appears to us to be expedient that banns of marriage should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at such church, and that the fees to be received in respect thereof should be paid and belong to the minister

of the same church for the time being :

"We therefore humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order with respect thereto as to your Majesty in your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"All those parts of the parish of Prees, in the county of Salop, and diocese of Lichfield, which are comprised within the several townships of Calverhall and Williston."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased by and Wm. L. Bathurst. | with the advice of Her Privy Council, to approve
