(No. 40.) AUSTRALIA—SOUTH COAST.

*Revolving Light on Cape Borda.*

THE Master and Wardens of the Trinity House of Adelaide have given notice, that on or about the 1st of May, 1858, a light would be exhibited from the lighthouse recently erected on Cape Borda, the north-west point of Kangaroo Island, off the entrance to St. Vincent Gulf, South Australia.

The light is a *revolving* light, showing alternately *red* and *white*, with intervals of half a minute

between each exhibition. It is placed at an elevation of about 510 feet above the sea at high water, and should be visible in clear weather from the deck of a vessel at a distance of 30 miles.

The lighthouse stands in about lat.  $35^{\circ} 45\frac{1}{2}'$  S. ; and long.  $136^{\circ} 34\frac{1}{2}'$  East of Greenwich.

#### NOTICE TO MARINERS.

(No. 41.) GULF OF MEXICO—UNITED STATES.

*Light at Pensacola Harbour, Florida.*

THE United States Lighthouse Board has given notice, that on and after the 1st of November, 1858, a light will be exhibited from a lighthouse now in course of erection at the entrance of Pensacola bay or harbour, Florida, when the light at present shown from the old tower will be discontinued, and the tower taken down as soon after as possible.

The new light will be a *white revolving* light, showing a bright flash every minute. It will be placed at an elevation of 210 feet above the level of the sea, and should be visible in ordinary weather from the deck of a vessel at a distance of 21 miles.

The illuminating apparatus will be dioptric, by a Fresnel lens, of the first order.

The new light tower is 160 feet in height, of the natural colour of the brick of which it is built ; the lantern is painted red. It stands at about one-third of a mile to the westward of the old structure, and its approximate position is in lat.  $30^{\circ} 19' 00''$  N. ; long.  $87^{\circ} 17' 24''$  West of Greenwich.

*Light on Sand Island, Mobile Bay, Alabama.*

Also, that on and after the same date a light will be exhibited from the lighthouse now being erected near the site of the present one on Sand Island, western side of the entrance to Mobile bay, Alabama, when the light in the old building will be discontinued, and the latter removed.

The new light will be a *fixed white* light, placed at an elevation of 152 feet above the sea, and should be seen in ordinary weather from a ship distant 19 miles.

The illuminating apparatus will be a Fresnel lens, of the first order.

The new light tower is 150 feet high, built of brick, surmounted by a granite cornice, brick parapet wall, and brass lantern unpainted. It is of the natural colour of the brick, and it stands in about lat.  $30^{\circ} 11' 18''$  N. ; long.  $88^{\circ} 1' 58''$  West of Greenwich by the U. S. Coast Survey.

The beacon range lights on Sand Island will be placed in their proper positions for preserving the ranges.

*Alteration of Mobile Point Light.*

On the same night the present revolving light on Mobile point, the east point of the entrance to Mobile bay, will be changed to a *fixed white* harbour light.

The illuminating apparatus will be dioptric, by a Fresnel lens, of the fourth order.

*Lighthouses on Florida Reefs.*

Also, that with the view to assist mariners navigating the Florida strait to determine whether they are on the Bahama or Florida reefs side, orders have been issued to the keepers of Carysfort Reef, Dry Bank (off Sombrero Cay), and Sand Cay lighthouses to display an American flag above the lantern at each of those lighthouses by day on and after the 1st of July, 1858.
