NOTIFICATION.

HEREAS there was concluded between Her Majesty and the Emperor of Brazil, on the 2nd day of June, 1858, a Convention in the following terms, for the settlement of outstanding claims, by means of a Mixed Commission:

WHEREAS claims have at various times since the date of the Declaration of Independence of the Brazilian Empire been made upon the Government of Her Britannic Majesty on the part of Corporations, Companies, and private individuals, subjects of His Majesty the Emperor of Brazil, and upon the Government of His Majesty the Emperor of Brazil on the part of Corporations, Companies, and private individuals, subjects of Her Britannic Majesty; and whereas some of such claims are still pending, or are still considered by either of the two Governments to remain unsettled; Her Majesty the Queen of the United Kingdom of Great Britain and Ireland, and His Majesty the Emperor of Brazil, being of opinion that the settlement of all such claims will contribute much to the maintenance of the friendly feelings which subsist between the two countries, have resolved to make arrangements for that purpose by means of a Convention, and have named as their Plenipotentaries to confer and agree thereupon, that is to say:

Her Majesty the Queen of the United Kingdom of Great Britain and Ireland, the Honourable Peter Campbell Scarlett, Companion of the Most Honourable Order of the Bath, and Her Britannic Majesty's Envoy Extraordinary and Minister Plenipotentiary to the Court of Rio de Janeiro, &c., &c.

And His Majesty the Emperor of Brazil, the Most Illustrious and Most Excellent Sergio Teixeira de Macedo, Member of His Council, holding rank as His Envoy Extraordinary and Minister Plenipotentiary, Great Cross of the Order of the Rose, and of that of Christ of Portugal, Commander of the Orders of St. Gregory Magnus, of St. Maurice and St. Lazarus, and of the Imperial Angelic and Constantinian Order of St. George, Member of the Chamber of Deputies, &c., &c., &c.

Who, having communicated to each other their respective full powers, found in good and due form, have agreed as follows :---

ARTICLE I.

The High Contracting Parties agree that all claims on the part of Corporations, Companies, or

private individuals, subjects of Her Britannic Majesty, upon the Government of His Majesty the Emperor of Brazil, and all claims on the part of Corporations, Companies, or private individuals, subjects of His Majesty the Emperor of Brazil, upon the Government of Her Britannic Majesty, which may have been presented to either Government for its interposition with the other since the date of the Declaration of Independence of the Brazilian Empire, and which yet remain unsettled. or are considered to be still unsettled, by either of the two Governments, as well as any other such claims which may be presented within the time specified in Article III hereinafter, shall be referred to two Commissioners, to be appointed in the following manner ; that is to say : one Com-missioner shall be named by Her Britannic Majesty, and one by His Majesty the Emperor of Brazil.

Her Britannic Majesty and His Majesty the Emperor of Brazil, respectively, shall appoint a Secretary to the Commission, who shall be empowered to act as Commissioner in case of the temporary incapacity or absence of the Commissioner of his Government, and also in case of the death, definite absence, or incapacity of the said Commissioner, or in the event of his omitting or ceasing to act as such, until the appointment of, and assumption of his duties by, another Commissioner in the place or stead of the said Commissioner.

In the case of the death, or definite absence, or incapacity of the Commissioner on either side, or in the event of the Commissioner on either side omitting or ceasing to act as such, Her Britannic Majesty, or His Majesty the Emperor of Brazil, respectively, shall forthwith name another person to act as Commissioner, in the place or stead of the Commissioner originally named.

In case of the Secretary on either side being appointed permanently Commissioner, Her Britannic Majesty or His Majesty the Emperor of Brazil, respectively, shall forthwith name another person to be Secretary in the place or stead of the Secretary originally named.

The Commissioners shall meet at Rio de Janeiro, at the earliest convenient period after they shall have been named, and shall, before proceeding to any business, make and subscribe a solemn declaration that they will impartially and carefully examine and decide, to the best of their judgment, and according to justice and equity, without fear, favour, or affection to their own country, upon all such claims as shall be laid before them on the part of the Governments of Her Britannic Majesty and His Majesty the Emperor of Brazil, respectively; and such declaration shall be entered on the record of their proceedings.

The Secretary on either side, when called upon to act as Commissioner for the first time, and before proceeding to act as such, shall make and subscribe a similar declaration, which shall be entered in like manner as aforesaid.

The Commissioners shall, before proceeding to any other business, name a third person to act as an Arbitrator or Umpire, in any case or cases on which they may themselves differ in opinion.

If they should not be able to agree upon the selection of such a person, the Commissioner on either side shall name a person; and in each and every case in which the Commissioners may differ in opinion as to the decision which they ought to give, it shall be determined by lot which of the two persons so named shall be Arbitrator or Umpire in that particular case.

The person so to be chosen to be Arbitrator or Umpire shall, before proceeding to act as such in any case, make and subscribe a solemn Declaration, in a form similar to that which shall have already been made and subscribed by the Commissioners, which Declaration shall be entered on the record of their proceedings.

In the event of the death, absence, or incapacity of such person, or of his omitting, or declining, or ceasing to act as such Arbitrator or Umpire, another and different person shall be named as aforesaid to act as such Arbitrator or Umpire in the place or stead of the person so originally named as aforesaid, and shall make and subscribe such Declaration as aforesaid.

ARTICLE II.

The Commissioners shall then forthwith proceed to the investigation of the claims which shall be presented to their notice.

They shall investigate and decide upon such claims in such order and in such manner as they may think proper, but upon such evidence or information only as shall be furnished by or on behalf of the respective Governments.

They shall be bound to receive and peruse all written or printed documents or statements which may be presented to them by or on behalf of the respective Governments, in support of or in answer to any claim, and to hear, if required, one person on each side on behalf of each Government, as counsel or agent for such Government, on each and every separate claim.

Should they fail to agree in opinion upon any individual claim, they shall call to their assistance the Arbitrator or Umpire whom they have agreed to name, or who may be determined by lot, as the case may bc; and such Arbitrator or Umpire, after having examined the evidence adduced for and against the claim, and after having heard, if required, one person on each side as aforesaid, and consulted with the Commissioners, shall decide thereupon finally, and without appeal.

The decision of the Commissioners, and of the Arbitrator or Umpire, shall be given upon each claim in writing, and shall be signed by them respectively.

It shall be competent for each Government to name one person to attend the Commission as agent on its behalf, to present and support claims, and to answer claims made upon it, and to represent it generally in all matters connected with the investigation and decision thereof.

Her Majesty the Queen of Great Britain and thereof, and shall appoint and employ a Clerk, if

Ireland, and His Majesty the Emperor of Brazil, hereby solemnly and sincerely engage to consider the decision of the Commissioners, or of the Arbitrator or Umpire, as the case may be, as absolutely final and conclusive upon each claim decided upon by them or him respectively, and to give full effect to such decisions without any objection, evasion, or delay whatsoever.

ARTICLE III.

Every claim shall be presented to the Commission within twelve months from the day of its first meeting, unless in any case where reasons for delay shall be established to the satisfaction of the Commission, or of the Arbitrator or Umpire in the event of the Commissioners differing in opinion thereupon; and then and in any such case, the period for presenting the claim may be extended to any time not exceeding six months longer.

The Commissioners shall be bound, under this Convention, to hold, for the consideration of the claims, at least eight sittings in each month, from the date of their first sitting until the completion of their labours.

The Commissioners shall be bound to examine and decide upon every claim within two years from the day of their first meeting, unless on account of some unforeseen and unavoidable suspension of the sittings, the two Governments may mutually agree to extend the time.

The Arbitrator or Umpire shall be bound to come to a final decision on any claim within fifteen days from the time of such claim being submitted to his consideration, unless the Commissioners consider a more extended period absolutely necessary.

It shall be competent for the Commissioners, or for the Arbitrator or Umpire if they differ, to decide in each case whether any claim has or has not been duly made, preferred, or laid before the Commission, either wholly or to any and what extent, according to the true intent and meaning of this Convention.

ARTICLE IV.

All sums of money which may be awarded by the Commission, or by the Arbitrator or Umpire, on account of any claim, shall be paid by the one Government to the other, as the case may be, within twelve months after the date of the decision, without interest, and without any deduction save as specified in Article VI hereinafter.

ARTICLE V.

The High Contracting Parties engage to consider the result of the proceedings of this Commission as a full, perfect, and final settlement of every claim upon either Government, arising out of any transaction of a date prior to the exchange of the ratifications of the present Convention; and further engage that every such claim, whether or not the same may have been presented to the notice of, made, preferred, or laid before the said Commission, shall, from and after the conclusion of the proceedings of the said Commission, be considered and treated as finally settled, barred, and thenceforth inadmissible.

ARTICLE VI.

The Commissioners and the Arbitrator or Umpire, with the assistance of the Secretaries, shall keep an accurate record and correct minutes or notes of all their proceedings, with the dates thereof, and shall appoint and employ a Clerk, if

necessary, to assist them in the transaction of the business which may come before them.

Each Government shall pay to its Commissioner an amount of salary not exceeding six contos of reis, or six hundred and seventy-five pounds sterling a year, which amount shall be the same for both Governments.

Each Government shall pay to its Secretary an amount of salary not exceeding three contos, or three hundred and thirty-seven pounds ten shillings sterling a year, which amount shall be the same for both Governments.

The Secretary on either side, when acting as Commissioner, shall receive the same amount of salary a year as that paid to the Commissioner; it being understood that his salary as Secretary shall lapse during that time. The amount of salary to be paid to the Arbi-

The amount of salary to be paid to the Arbitrator or Umpire shall be the same, in proportion to the time he may be occupied, as the amount paid a year to a Commissioner under this Convention.

The salary of the Clerk, if one is appointed, shall not exceed the sum of two contos, or two hundred and twenty-five pounds sterling a year.

The whole expenses of the Commission, including contingent expenses, shall be defrayed by a rateable deduction on the amount of the sums awarded by the Commissioners, or by the Arbitrator or Umpire, as the case may be; provided always that such deduction shall not exceed the rate of five per cent. on the sums so awarded.

The deficiency, if any, shall be defrayed by the two Governments.

ARTICLE VII.

The present Convention shall be ratified by Her Britannic Majesty, and by His Majesty the Emperor of Brazil; and the ratifications shall be exchanged at London as soon as may be within six months from the date hereof.

In witness whereof the respective Plenipotentiaries have signed the same, and have affixed thereto the seals of their arms.

Done at Rio de Janeiro, the second day of June, in the year of our Lord one thousand eight hundred and fifty-eight.

Notice is hereby given, that all persons, subjects of Her Majesty, who may have claims to prefer upon the Government of Brazil, must, in conformity with the provisions of the said Convention, transmit to Her Majesty's Principal Secretary of State for Foreign Affairs, or to Her Majesty's Minister at the Court of Brazil, in sufficient time to be laid before the Commissioners within twelve months of the day of their first meeting (of which day notice will hereafter be given), the particulars of their claims, together with the requisite evidence or information in support thereof.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four, section sixteen; of an Act of the first and second years of Her Majesty, chapter one hundred and seven, section twelve; of an Act of the second and third years of Her Majesty, chapter fortynine, section three; and of an Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, section one; duly prepared and laid before Her Majesty in Council, a representation, bearing date the tenth day of June, in the year one thousand eight hundred and fifty-eight, in the words and figures following; that is to say :

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the fifty-ninth year of His Majesty King George the Third, chapter one hundred and thirty-four, section sixteen; of the Act of the first and second years of your Majesty, chapter one hundred and seven, section twelve; of the Act of the second and third years of your Majesty, chapter forty-nine, section three; and of the Act of the nineteenth and twentieth years of your Majesty, chapter fifty-five, section one; have prepared and now humbly lay before your Majesty in Council the following representation as to the assignment of a district chapelry to the consecrated church of Saint John, situate at Studley, in the district parish of the Holy Trinity, Trowbridge, in the county of Wilts, and in the diocese of Salisbury.

"Whereas it appears to us to be expedient that a district chapelry should be assigned to the said church of Saint John, situate at Studley aforesaid.

"Now, therefore, with the consent of the Right Reverend Walter Kerr, Bishop of Salisbury, and the Reverend Edward Pizey, Incumbent of the said district parish of the Holy Trinity, Trowbridge, testified by their having respectively signed and sealed this representation, we humbly represent that it would, in our opinion, be expedient that all that part of the said district parish of the Holy Trinity, Trowbridge, described in the Schedule hereunto annexed, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto also annexed, should be assigned to the said church, and the same should be named 'The District Chapelry of Saint John, Studley.'

"And with the like consent of the said Walter Kerr, Bishop of Salisbury, testified as aforesaid, we further represent, that it appears to us to be expedient that banns of marriage should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at such church, and that the fees to be received in respect thereof should be paid and belong to the minister of the same church for the time being.

"We therefore humbly pray that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order with respect thereto as to your Majesty in your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"All that part of the district parish of the Holy Trinity Trowbridge, in the county of Wilts, and diocese of Salisbury, which is situate to the east and south of an imaginary line commencing in the middle of Trowle Brook, on the boundary between the said district parish and the parish of Winkfield, and extending thence generally in a northerly direction to the middle of the bridge called "London Bridge," by which the road leading from Wingfield to Trowbridge is carried over Trowle Brook aforesaid; and extending thence eastward, along the middle of such lastmentioned road, to a point opposite to the middle of the northern end of the fence dividing the close numbered 33 on the tithe commutation map of the parish of Trowbridge, in the same county and diocese, and on the map hereunto annexed, from the close numbered 34 on the same maps; and extending thence southward, along the middle of such last-mentioned fence, to the middle of the fence dividing the close numbered 35 on the same maps, from the said close numbered 33; and extending thence eastward, along the middle of such fence, to a point opposite to the middle of the northern end of the fence dividing the said close numbered 35, from the close numbered 48, on the said maps; and extending thence southward, eastward, southward, westward, and southward, along the middle of the last-mentioned fence, and along the middle of the fences dividing the said close numbered 35, and the close numbered 46, on the said maps, from the close numbered 47, on the same maps, to the middle of the road leading from Frome to Trowbridge aforesaid; and extending thence southward along the middle of such last-mentioned road, to a point opposite to the middle of the north-western end of the fence, dividing the close numbered 111 on the said maps, from the close numbered 112 on such maps; and extending thence south-eastward along the middle of such last-mentioned fence, and along the middle of the fences dividing the said close numbered 112, and the closes numbered respectively, 116, 140, 139, and 155a, on the said maps, from the closes numbered respectively, 110, 109, 141, and 150, on the said maps, to the middle of the road called Silver-street-lane; and extending thence eastward, along the middle of such last-mentioned lane, to the middle of the road leading from Westbury to Trowbridge aforesaid; and extending thence south-eastward along the middle of such last-mentioned road, to the boundary dividing the said district parish of the Holy Trinity Trow-bridge, from the parish of North Bradley, in the said county of Wilts, and diocese of Salisbury."

Her Majesty having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the proposed assignment of a district chapelry to the consecrated church of Saint John, situate at Studley, in the district parish of the Holy Trinity, Trowbridge, in the county of Wilts, to be called "The District Chapelry of Saint John, Studley," be accordingly made, and that the recommendations of the said Commissioners, with reference to the publication of banns, and the solennization of marriages, baptisms, churchings, and burials in the said church, and with reference to the fees to be paid in respect of those offices, be carried into effect agreeably to the provisions of the said Acts; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Salisbury.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter one hundred and thirteen, and of the Act of the sixth and seventh years of Her Majesty, chapter thirty-seven, duly prepared and laid before Her Majesty in Council a scheme, bearing date the twenty-fourth day of June, in the year one thousand eight hundred and fifty-eight, in the words following ; that is to say :

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the third and fourth years of your Majesty, chapter one hundred and thirteen, and of the Act of the sixth and seventh years of your Majesty, chapter thirty-seven, have prepared, and now humbly lay before your Majesty in Council, the following scheme for constituting a separate district for spiritual purposes out of the chapelry of Saint Margaret, in the parish of Saint Oswald, Durham, in the county and diocese of Durham.

"Whereas it has been made to appear to us that it would promote the interests of religion that the particular parts of the said chapelry of Saint Margaret, hereinafter mentioned and described, such parts not at present containing within their limits any consecrated church or chapel in use for the purposes of divine worship, should be constituted a separate district for spiritual purposes in manner hereinafter set forth.

"And whereas by a deed, bearing date the tenth day of April, in the year one thousand eight hundred and fifty-eight, and made or expressed to be made between the Very Reverend George Waddington, Doctor in Divinity, Dean, and the Chapter of the Cathedral Church of Durham, patrons of the perpetual curacy or chapelry of Saint Margaret, in the city of Durham and parish of Saint Oswald aforesaid, of the one part, and us the Ecclesiastical Commissioners for England of the other part, which deed has been enrolled in your Majesty's High Court of Chancery at Westminster, a clear annual sum of one hundred pounds has been granted and secured by the said dean and chapter to the minister or incumbent of the district hereinafter recommended to be constituted, so soon as one shall be appointed and licensed, and to his successor, ministers, or incumbents thereof for the time being, and so soon as such district shall have become, under the provisions of the herein secondly-named Act, a new parish for ecclesiastical purposes, then of the said new parish, by means of a rentcharge issuing and payable out of and charged upon certain lands and hereditaments situate and being in the township of Elvet, in the said parish of Saint Oswald, Durham, with a proviso that the said rentcharge so created as aforesaid shall cease and determine if and when the said dean and chapter shall to our satisfaction secure to the minister or incumbent for the time being of the said district or new parish an apportioned tithe rentcharge or tithe rentcharges arising upon and issuing out of lands and hereditaments situate within the said parish of Saint Oswald, Durham, and equivalent to a clear yearly sum or rentcharge of one hundred pounds at the least, free from all deductions or abatements whatsoever.

"And whereas it has been proposed to us by the said Dean and Chapter of the Cathedral Church of Durham, and it appears to us to be expedient, that, in consideration of the grant of the annual sum of one hundred pounds as aforesaid, the whole right of patronage of the district hereinafter recommended to be constituted, and of the nomination of the minister or incumbent of the same, and so soon as such district shall have become a new parish as aforesaid, then of the said new parish, should be assigned to the said dean and chapter and their successors in manner hereinafter mentioned.

"Now, therefore, with the consent of the Right Reverend Charles Thomas, Bishop of Durham, in testimony whereof he has signed and sealed this scheme, we humbly recommend and propose, that all that all those parts of the said chapelry of Saint Margaret, in the parish of Saint Oswald, Durham, described in the schedule hereunto annexed (all which parts, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto also annexed), shall, upon and from the day of the date of the publication in the London Gazette of any Order of your Majesty in Council ratifying this scheme, become and be together constituted a separate district for spiritual purposes, and that the same shall be named ' The District of Saint Cuthbert, Durham.'

" And we further recommend and propose, that there shall be paid by us in each and every year, by equal half-yearly payments, on the first day of May and the first day of November, to the minister or incumbent for the time being of the district so recommended to be constituted, when duly licensed according to the provisions of the said secondlynamed Act, and so soon as such district shall have become, according to the provisions of the same Act, a new parish for ecclesiastical purposes, then of the said new parish, the sum of fifty pounds, and that the first such payment, or a proportionate part thereof, shall be made on the first day of May or of November next, after the day of the date of the licence of such minister or incumbent as aforesaid; and that in case a vacancy in the ministry or incumbency of such district or new parish shall happen on any other day than the first day of May or the first day of November, the amount payable shall be duly apportioned between and paid to the minister or incumbent making the vacancy, or his personal representative or representatives, and the minister or incumbent succeeding to such district or new parish; provided always, that if it shall appear to us to be expedient at any future time that, instead of the annual sum then in course of payment by us to the minister or incumbent of the said district or new parish, or instead of any part of such annual sum, any land, tithe, or other hereditament should be conveyed or secured to such minister or incumbent and his successors in fee, nothing herein, or in any other scheme contained, shall prevent us from recommending and proposing such a substitution.

"And we further recommend and propose, that the whole right of patronage of the said district or new parish so recommended to be constituted, and of the nomination of the minister or incumbent thereto, shall, without any assurance in the law other than this scheme, and any duly gazetted Order of your Majesty in Council ratifying the same, and upon and from the day of the date of the publication of such Order in the London Gazette as aforesaid, be assigned to and absolutely vested in, and shall and may from time to time be

exercised by the Dean and Chapter of the said Cathedral Church of Durham, and their successors for ever.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any other Act of Parliament.

" SCHEDULE

"The District of SAINT CUTHBERT, DUR-HAM, being-

"All that part of the chapelry of Saint Margaret, in the parish of Saint Oswald, Durham, in the county and diocese of Durham, lying to the north-east of an imaginary line commencing at a point in the middle of the road leading from Findon Hill to the turnpike road leading from Newcastle-upon-Tyne to Durham, where the firstmentioned road crosses the boundary between the said chapelry of Saint Margaret and the chapelry of Witton Gilbert, and thence extending towards the south along the middle of the same road, and of the turnpike-road aforesaid, until the latter is joined by the road called or known as White Smocks-road, and thence continuing towards the north-west and west along the middle of the lastnamed road, until it is joined by the road called Field House-road, and thence extending towards the south along the middle of the last-named road as far as a point opposite to the middle of the road called Shaw Wood-road, and thence extending first towards the west and then towards the southeast and east along the middle of the last-named road and across the before-mentioned turnpikeroad leading from Newcastle-upon-Tyne to Durham, to the middle of Castle Chare-lane, and thence continuing towards the south-east along the middle of the said lane across the street called Framwellgate to the northern boundary wall of certain premises now or late in the occupation of George Smith, Esquire, and thence continuing in the same direction along the last-named boundary wall to the River Wear, forming the boundary of the said chapelry of Saint Margaret :---and also all that isolated part of the said chapelry of Saint Margaret situate near the place called or known as Red Brier, and lying to the west of the said turnpike-road leading from Newcastle-upon-Tyne to Durham."

And whereas due notice of the said scheme has, in accordance with the provisions of the said Acts, been given to the incumbents and to the patrons of the said chapelry of Saint Margaret, and parish of Saint Oswald, Durham respectively, and no objection has been made thereto.

And whereas the said scheme has been approved by Her Majesty in Council; now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law, immediately from and after the time when this Order shall have been duly published in the London Gazette, pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Durham.

TREASURY WARRANT.

WHEREAS by an Act of Parliament, passed in the fourth year of the reign of Her present Majesty, intituled "An Act for the regulation of the duties of postage," power is given to the Commissioners of Her Majesty's Treasury, from time to time, by Warrant under their hands, to alter and fix any of the rates of British postage or inland postage, payable by law, on the transmission by the post of foreign or colonial letters or newspapers, or of any other printed papers, and to subject the same to rates of postage according to the weight thereof, and a scale of weight to be contained in such Warrant, and, from time to time, by Warrant as aforesaid, to alter or repeal any such altered rates, and make and establish any new or other rates in lieu thereof, and, from time to time, to appoint at what time the rates which may be payable are to be paid.

And whereas further powers are given to the Commissioners of Her Majesty's Treasury by another Act of Parliament, passed in the eleventh

year of the reign of Her present Majesty, intituled "An Act for giving further facilities for the transmission of letters by post, and for the regulating the duties of postage thereon, and for other purposes relating to the Post-office."

And whereas the Commissioners of Her Majesty's Treasury, by a certain Warrant under their hands, bearing date the 16th day of August, 1858, did order and direct that, on any letter posted in the United Kingdom, addressed to Barbadoes, Trinidad, and Saint Helena, and on every letter posted in Barbadoes, Trinidad, and Saint Helena, addressed to the United Kingdom, the postage thereof should be paid at the time of the same being posted, and that if any letter should be posted in the United Kingdom, addressed to Barbadoes, Trinidad, or Saint Helena, without any postage having been paid thereon, or having thereon or affixed thereto a postage stamp or stamps, the value of which shall be less in amount than the single rate of postage to which such letter if not exceeding half an ounce in weight would be liable under the regulations in force relating thereto, every such letter should be detained and opened and should be either returned or given up to the sender thereof.

And whereas it is expedient that a further regulation should be made as to the letters hereinafter mentioned.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the powers reserved to us in and by the said hereinbefore recited Acts, or either of them, and of all other powers enabling us in this behalf, do by this present Warrant, under the hands of two of us the said Commissioners, by the authority of the Statute in that case made and provided, order and direct as follows; that is to say:

1. If any letter shall be posted in the United Kingdom, addressed to Barbadoes, Trinidad, or Saint Helena, without any postage having been paid thereon, or having thereon, or affixed thereto, a postage stamp or stamps, the value of which shall be less in amount than the single rate of postage to which such letter if not exceeding half an ounce in weight would be liable, under the regulations in force relating thereto, every such letter shall until the 31st day of December, 1858, inclusive, be forwarded, charged with the amount of the postage to which it would have been liable if the postage had been paid when posted, together with the further and additional rate of postage of sixpence; and from and after the said 31st day of December, 1858, every such letter instead of being forwarded, shall be detained and opened, and be either returned or given up to the sender thereof, as directed by the said recited Warrant of the 16th day of August, 1858.

2. The several terms and expressions used in this Warrant, shall be construed to have the like meaning in all respects as they would have had if inserted in the said Act, passed in the fourth year of the reign of Her present Majesty.

3. The Commissioners for the time being of Her Majesty's Treasury, may by Warrant, under their hands, duly made at any time hereafter, alter repeal or revoke, any of the orders, directions, or regulations hereby made, and may make and establish any new or other orders, directions, or regulations, in lieu thereof.

4. This Warrant shall come into operation on the first day of October, 1858.
