Windsor Castle, November 9, 1858.

THE Queen, taking into Her royal consideration that HIS ROYAL HIGHNESS ALBERT EDWARD, PRINCE OF WALES, Knight of the Most Noble Order of the Garter, and, by virtue of the statutes of the said Order, a constituent member thereof, has not as yet assumed the Stall assigned to the Prince of Wales in the Royal Chapel of St. George, at Windsor, and having, as Sovereign of the said Order, the inherent right of dispensing with all statutes, ordinances, and regulations in regard to Installation, Her Majesty has been pleased, by Letters Patent under Her Royal Sign Manual and the Great Seal of the Order, bearing date this day, to give and grant unto His Royal Highness Albert Edward, Prince of Wales, full power and authority to wear and use the Star, and also to wear and use the Collar and all other Ornaments belonging to the said Most Noble Order, and to sit in the Stall assigned to the Prince of Wales, in Our Royal Chapel of St. George, at Windsor, and to exercise all rights and privileges belonging to a Knight Companion of the said Most Noble Order, in as full and ample manner as if His Royal Highness had been formally installed, any decree, rule or usage to the contrary notwithstanding.

THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foteign Affairs a copy of a Despatch from Her Majesty's Consul at Teneriffe, stating that, in consequence of the outbreak of the Plague in Tripoli, all vessels arriving at the Canary Islands, from Malta, the Ionian Islands, and Morocco, will be subjected to a rigorous quarantine of eight days during the existence of the disease.

THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Consul at Lisbon, stating that the following orders respecting Quarantine have been issued by the Board of Health of that capital:—

1. All vessels arriving from ports suspected with cholera-morbus, shall be subject to a quarantine of observation for three complete days; and those arriving from infected ports, having cargoes susceptible of infection, shall be subject to a rigorous quarantine of five days. Vessels arriving from those infected ports in ballast, or with cargoes not susceptible of infection, shall be subject to a quarantine of observation of three days, the quarantine to be modified or increased should the circumstances of the vessel or the security of the public health require it.

2. The port of Charleston is considered to be infected with the yellow fever, and all the other ports of the United States of America are considered suspected, with the exception of New Orleans, which continues to be considered infected.
