Nothing herein contained shall be construed to extend to any letters, newspapers, books, publications, or works of literature or art, or other printed papers sent between the Argentine Confederation and France, or sent otherwise than in closed mails between the Argentine Confederation and any foreign country or British colony through France.

17. The several terms and expressions used in this Warrant shall be construed to have the like meaning in all respects as they would have had if inserted in the said Act passed in the fourth year

of the reign of Her present Majesty.

18. The Commissioners for the time being of Her Majesty's Treasury may, by Warrant under their hands duly made at any time hereafter, alter, repeal, or revoke any of the rates of postage hereby fixed or altered, or any of the orders, directions, regulations, and conditions hereby made, and may make and establish any new or other rates, orders, directions, regulations, and conditions in lieu thereof, and from time to time appoint at what time the rates which may be payable are to be paid.

19. This Warrant shall come into operation on

the first day of April, 1859.

PPLICATION is intended to be made to Parliament in the present session, for leave to introduce into the Manchester, Sheffield, and | Grocere'-Hall, February 11, 1859.
