THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Chargé d'Affaires at Santiago the following translation of an Edict issued by the Minister of Finance of the Republic of Chili.

**FOREIGN VESSELS EMPLOYED IN THE
COASTING TRADE.**

The Minister of Finance, under date the 10th June, has issued the following Edict:

In consideration of the difficulties which exist for national vessels employed in the coasting trade

to go to the ports situated to the north of Valparaiso, with cargoes of provisions, utensils, and other merchandize, for the use of the mines and the consumption of the workmen, in virtue of the authority granted by the Art. 15, c. 1, of the Customs Ordinances—

I decree—

That besides the articles which, according to the 15th Article, c. 1, of the Customs Ordinances, may be conveyed along the coast by foreign vessels, they may also carry to the ports situated to the north of Valparaiso, provisions, utensils, and other merchandize necessary for the working of the mines and the consumption of the workmen.
