THEREAS by an Act, passed in the session of Parliament held in the sixth and seventh years of the reign of His late Majesty King William the Fourth, intituled "An Act for rendering "more easy the taking the poll at county elections," it is enacted that it shall be lawful for His Majesty, by and with the advice of His Privy Council, from time to time, on petition from the Justices of any county, riding, parts, or division in England or Wales, in quarter sessions assembled, representing that the number of polling places for such county, riding, parts, or division, is insufficient, and praying that the place or places mentioned in the said petition may be a polling place or polling places for the county, riding, parts, or division of the county within which such place or places is or are situate, to declare that any place or places mentioned in the said petition shall be a polling place or polling places for that county, riding, parts, or division; and that the Justices of the Peace for such county, riding, parts, or division, in quarter sessions or some special sessions assembled, as mentioned in the Act passed in the second and third years of the reign of His said late Majesty, intituled "An Act to settle and determine the "divisions of counties and the limits of cities and "boroughs in England and Wales, in so far as "respects the election of members to serve in "Parliament," shall, conformably to the said lastmentioned Act, divide such county, riding, parts,

or division into convenient polling districts, and assign one of such districts to each polling place :

And whereas the Justices of the Peace for the county of WORCESTER, in general quarter sessions assembled at the Shire Hall, Worcester, on the twenty-seventh day of June last, have presented two petitions to Her Majesty, representing that the number of polling places for the eastern division of the said county of Worcester is insufficient, and praying that the parish or township of Redditch and the township of Oldbury, respectively, may be declared polling places for the said division, within which such places are situate :

Now, therefore, Her Majesty, having taken the said petitions into consideration, is pleased, by and with the advice of Her Privy Council, to declare, order, and direct, and it is hereby declared, ordered, and directed, that the said parish or township of Redditch and the said township of Oldbury shall be polling places for the eastern division of the county of Worcester; and that the Justices of the Peace for the said county, in quarter sessions or some special sessions assembled, as mentioned in the said Act passed in the second and third years of the reign of His said late Majesty, shall, conformably to the said Act, divide such division into convenient polling districts, and assign one of such districts to each polling place.

HEREAS by the 333rd section of "The Merchant Shipping Act, 1854," it is enacted that, subject to the provisions contained in the 5th part of that Act, it shall be lawful for every pilotage authority, by bye-law made with the consent of Her Majesty in Council, from time to time to do within its districts all or any of the things specified in that behalf in the said section ;

And whereas the Trinity House Corporation, being the pilotage authority under the said Act, for the Trinity House outport district called the Dartmouth District, the limits whereof now are from Bob's Nose to Bolt Head, and vice versâ, and into and out of all ports and places within those limits, and also for the districts adjoining thereto, has submitted for the consent of Her Majesty in Council, the bye-law, a copy whereof is set forth in the Schedule hereunto annexed, for altering the limits of the said Dartmouth District, and also with respect to the pilotage of the said Dartmouth District, as so altered;

And whereas it has been made to appear to Her Majesty that the said bye-law is proper and reasonable;

Now, therefore, Her Majesty, by virtue of the power vested in Her by the said recited Act, and by and with the advice of Her Privy Council, is pleased to approve, and doth hereby approve of and signify Her consent to, the said bye-law, as a bye-law of the said Trinity House with respect to the pilotage of the Dartmouth District.

### Schedule to which the foregoing Order refers.

From and after the expiration of ten days from the publication in the London Gazette of the Order signifying the consent of Her Majesty in Council to this bye-law, the limits of the Dartmouth District shall be from Bob's Nose to the Start, and vice versâ, and into and out of all ports and places within those limits, and there shall be paid to all Trinity House Pilots for all ships passing through those limits such dues in respect of their pilotage services as are specified in the table following :

Rates of Pilotage to be demanded and received by qualified Pilots for piloting ships within the undermentioned limits.

All British ships, if boarded without the run of the Mewstone East, or the Blackstone West, are to pay as follows, for the pilotage into Dartmouth Harbour, viz.:--

If boarded within the abovenamed line, they are to pay one quarter part less.

If boarded within the Castle, they are to pay only one half the above-named rates, subject to the circumstances of weather, &c., under which the service may be performed, which circumstances are to be considered and allowed for by the Subcommissioners.

All British ships, if boarded without the run of Bob's Nose, or Berry Head, are to pay as follows, for the pilotage into the harbours of Brixham or Torquay, viz.:--

If boarded within the abovenamed line, they are to pay one quarter part less.

If boarded half a mile only from the outer piers, vessels of all sizes are to pay one shilling per foot of their draught of water.

The pilotage to Torbay is not compulsory, but should the master of any vessel choose to employ

a pilot to the anchorage therein, the pilotage is to be two-thirds less than that for the harbours of Brixham and Torquay.

The pilotage out of the harbours is to be in all cases one-third less than the inward pilotage. Ships not having British registers are to pay onefourth more than ships having British registers, except when such first-mentioned ships shall, by any Order of Her Majesty in Council, be privileged to enter the ports of this kingdom upon paying the same duties of tonnage as are paid by British ships, in which case such ships and vessels not having British registers shall pay the like rates of pilotage only as are payable by ships having British registers ; the said surplus rate chargeable on *unprivileged* foreign vessels is to be paid to the Collector of this Corporation's light duties at the Custom House, Dartmouth.

Masters of ships taking a pilot at sea, viz.: two leagues or more from the harbour's mouth, are to pay according to circumstances attending the hazard run, assistance required, &c., which is to be regulated in case of dispute by the Sub-commissioners.

The pilot is to provide a proper tow boat and crew, consisting of at least four men, for whose services he shall be allowed to charge two shillings and sixpence per man, per day, in addition to the rate of pilotage; and, in case of dispute, the same shall be settled by the Sub-commissioners, and the assistants rewarded according to the risk, time and trouble.

HEREAS by an Act, passed in the session of Parliament held in the fifteenth and sixteenth years of Her Majesty's reign, intituled "An Act to amend the laws concerning the "burial of the dead in the metropolis;" it is enacted, that in case it appears to Her Majesty in Council, upon the representation of one of Her Majesty's Principal Secretaries of State, that, for the protection of the public health, burials in any part or parts of the metropolis, or in any burialground or places of burial in the metropolis, should be wholly discontinued, or should be discontinued subject to any exception or qualification, it shall be lawful for Her Majesty by and with the advice of Her Privy Council, to order that from and after a time mentioned in the Order, burials in such part or parts of the metropolis, or in such burial-grounds or places of burial, shall be discontinued wholly, or subject to any exceptions or qualifications mentioned in such Order, and so from time to time, as circumstances may require; provided that notice of such representation, and of the time when it shall please Her Majesty to order the same to be taken into consideration by the Privy Council, shall be published in the London Gazette, and shall be affixed on the doors of the churches or chapels of the parishes in which any burial-grounds or places of burial affected by such representation, shall be situate, or on some other conspicuous places within the part or parts of the metropolis affected by such representation, one calendar month at the least before such representation is so considered; provided always, that no such representation shall be made in relation to the burial-ground of any parish until ten days' previous notice of the inten

tion to make such representation shall have been given to the Incumbent and the Vestry Clerk of such parish:

And whereas the Right Honourable Thomas Sotheron Estcourt, late one of Her Majesty's Principal Secretaries of State, after giving to the Incumbent and Vestry Clerk of the parishes hereinafter mentioned, ten days' previous notice of his intention to make such representation, has made a representation stating that, for the protection of the public health, burials should be discontinued in the undermentioned burial-grounds, with the following modifications; viz.;

And whereas Her Majesty was pleased, by Her Order in Council of the eighteenth of June last, to give notice of such representation, and to order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council, on the thirtieth of July last, and such Order has been published in the London Gazette, and copies thereof have been affixed as required by the above recited Act.

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, that burials be discontinued, from and after the twenty-fourth day of this instant August.

- SAINT PANCRAS.—In the vaults and catacombs under the New National Scotch Church, Regent's-square, Saint Pancras.
- PLUMSTEAD, KENT.-Beneath the Parish Church of Plumstead, Kent; and from and after the first day of November, one thousand eight hundred and sixty, in the churchyard, with the exception of vaults and family graves which were in existence on the eighteenth of May, one thousand eight hundred and fiftynine, and which shall be used on the following conditions,-that the vaults and brick graves be opened without disturbing soil that has been already buried in, and that each coffin be entombed in brick or stone work properly cemented; that family earthen graves be opened without the disturbance of human remains, that one foot of earth be left between each coffin, and that no body be buried within four feet of the surface ; and that in the excepted vaults and graves the only bodies interred be those of the husbands, wives, parents, unmarried children, and brothers and sisters of persons already buried therein.

WHEREAS by an Act, passed in the session of Parliament, held in the sixteenth and seventeenth years of Her Majesty's reign, intituled "An Act to amend the laws concerning the "burial of the dead in England, beyond the limits of "the metropolis, and to amend the Act concerning "the burial of the dead in the metropolis;" it is enacted, that in case it appears to Her Majesty in Council, upon the representation of one of Her Majesty's Principal Secretaries of State, that, for the protection of the public health, the opening of any new burial-ground in any city or town, or A 2

within any other limits, save with the previous approval of one of such Secretaries of State, should be prohibited, or that burials in any city or town, or within any other limits, or in any burial-ground or places of burial, should be wholly discontinued, or should be discontinued subject to any exception or qualification ; it shall be lawful for Her Majesty, by and with the advice of Her Privy Council, to order that no new burial-ground shall be opened in any city or town, or within such limits, without such previous approval, or (as the case may require), that after a time mentioned in the Order, burials in such city or town, or within such limits, or in such burial-grounds or places of burial, shall be discontinued wholly, or subject to any exceptions or qualifications mentioned in such Order, and so from time to time, as circumstances may require: provided always, that notice of such representation, and of the time when it shall please Her Majesty to order that the same be taken into consideration by the Privy Council, shall be published in the London Gazette, and shall be affixed on the doors of the churches or chapels of, or on some other conspicuous places within the parishes affected by such representation, one month before such representation is so considered; provided also, that no such representation shall be made in relation to the burial-ground of any parish until ten days' previous notice of the intention to make such representation, shall have been given to the Incumbent and Vestry Clerk or Churchwardens of such parish;

And whereas the Right Honourable Thomas Sotheron Estcourt, late one of Her Majesty's Principal Secretaries of State, after giving to the Incumbents and the Churchwardens of the parishes hereinafter mentioned, ten days' previous notice of his intention to make such representations, has made two representations stating that, for the protection of the public health, no new burial-ground should be opened in the undermentioned parishes without the previous approval of one of Her Majesty's Principal Secretaries of State, and that burials should be discontinued therein, with the following modifications;

And whereas Her Majesty was pleased, by Her Orders in Council of the sixth and eighteenth of June last, to give notice of such representations, and to order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council, on the fifteenth and thirtieth days of July last respectively; and such Orders have been published in the London Gazette, and copies thereof have been affixed, as required the said Act:

Now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, that no new burial-ground shall be opened in any of the undermentioned parishes without the previous approval of one of Her Majesty's Principal Secretaries of State; and that burials in the said parishes shall be discontinued, with the following modifications, from and after the twenty-fourth of August instant, (except as is herein otherwise directed), as follows; viz.:

- WOODSTOCK.—In Woodstock *churchyard*, on and after the first day of January, one thousand eight hundred and sixty, except in now existing vaults and walled graves, in which each coffin shall be embedded in charcoal, and entombed in an air-tight manner.
- ROCHDALE.—In the Wesleyan Burial-ground, Wardle, near Rochdale, except in graves not less than five feet deep, which can be opened without exposure of human remains.

GILLINGHAM, DORSETSHIRE.—On and after the first day of June, one thousand eight hundred and sixty-one, in the parish churchyard of Gillingham, Dorset, except in now existing vaults and walled graves, in which each coffin shall be imbedded in charcoal and entombed in an airtight manner, and except in other graves for the burial of the husbands or wives of those previously buried therein ; and it is also ordered that the wet portion of the churchyard be drained to the depth of six feet at least.

TEWKESBURY.--In Holy Trinity Churchyard, and in the Independent and Baptist burialgrounds, Tewkesbury, except in family graves and vaults, and in graves never previously buried in. No grave or vault to be re-opened except to bury husbands, wives, parents, or unmarried children of these previously buried therein. No human remains to be disturbed; and all coffins buried in vaults or walled graves to be imbedded in charcoal and separately entombed in an airtight manner.

Now, therefore, Her Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that the time for the discontinuance of burials in such churchyards and burialgrounds be postponed, as follows; viz.:

In the parish churchyard, in the burial-ground of the Independent Chapel, in the Wesleyan Burial-ground, in Battley Carr Churchyard, in St. Matthew's Churchyard, West Town, and in the burial-ground of the Roman Catholic Chapel, West Town, all in DEWS-BURY, from the first of September next, to the first of January, one thousand eight hundred and sixty;

- In the churchyard of the parish of WANSTEAD, Essex, from the first of September next, to the first of January, one thousand eight hundred and sixty;
- In the churchyard of the parish of WESTBOURNE, Sussex, from the first of August to the first of December, one thousand eight hundred and fifty-nine.

### BURIAL-GROUND OF THE PRECINCT OF BRIDE-WELL, BLACKFRIARS.

1. That the whole of the rubbish, building materials, &c., which have been deposited in the burial-ground of the precinct of Bridewell, Blackfriars, be completely removed under suitable supervision, care being taken not to disturb or damage the head or foot stones, or tombs.

2. That the whole surface of the ground be levelled, with the exception of the tombs and graves stones, and be covered with a layer of fresh earth of the thickness of at least a foot.

3. That the surface be sowed with grass seed, and the vegetation be maintained in a proper state, and the surface be never disturbed.

VAULTS UNDER BLOOMSBURY CHAPEL, COMMER-CIAL-ROAD EAST, IN THE HAMLET OF RAT-CLIFFE, IN THE PARISH OF SAINT DUNSTAN, STEPNEY.

- CAVERSWALL, STAFFORDSHIRE.-In the parish churchyard of Caverswall, on and after the first day of March, one thousand eight hundred and sixty, except in vaults and walled graves, in which each coffin shall be entombed in an airtight manner, and also in other graves, except for the burial of husbands, wives, or parents of those already buried therein, in graves which can be opened without indecent exposure of remains.

Now, therefore, Her Majesty in Council is pleased hereby to give notice of such representations, and to order that the same be taken into consideration by a Committee of the Lords of Her Majesty's Most Honourable Privy Council, on the twenty-sixth day of Septembor next;

THEREAS the CAMBRIDGE UNIVERSITY COMMISSIONERS, appointed for the purposes of the Act of the 19th and 20th Vict., cap. 81, in virtue of the powers conferred upon them by the 29th section of the said Act, have framed the following Statute, dated the 12th day of April, 1859, with respect to the Fellow Exhibition at ST.
