The Speech of the Lords Commissioners to both Houses of Parliament, on Saturday, August, 13, 1859.

My Lords and Gentlemen,

E are commanded by Her Majesty to release you from further attendance in Parliament; and at the same time to convey to you Her Majesty's acknowledgments for the zeal and assiduity with which you have applied yourselves to the performance of your important duties during the session of Parliament now about to

Various circumstances which occasioned interruptions in the usual course of business, prevented the completion of important measures which Her Majesty pointed out to the attention of Her Parliament in the beginning of the present year; but Her Majesty trusts that those matters will be taken into your earnest consideration at an early period of your next session.

The war which had broken out in Northern Italy having been brought to a close by the peace of Villafranca, overtures have been made to Her Majesty with a view to ascertain whether, if Conferences should be held by the Great Powers of Europe, for the purpose of settling arrangements connected with the present state and future condition of Italy, a Plenipotentiary would be sent by Her Majesty to assist at such Conferences; but Her Majesty has not yet received the information necessary to enable Her to decide whether Her Majesty may think fit to take part in any such negotiations.

Her Majesty would rejoice to find Herself able to contribute to the establishment of arrangements calculated to place the general peace on satisfactory and lasting foundations.

Her Majesty, in accordance with the stipula-tions of the Treaty of Tiensing, has instructed Her Plenipotentiary in China to repair to the Imperial Court at Pekin; and Her Majesty trusts that such direct communication with the Imperial Government will have a beneficial effect upon the relations between the two countries.

Her Majesty commands us to inform you, that She looks forward with confidence to the continued maintenance of those friendly relations which so happily subsist between Her Majesty and all foreign powers and states.

you on the complete restoration of tranquillity in Her Indian Dominions.

It will be Her earnest endeavour to promote their internal improvement, and to obliterate the traces of those conflicts which Her Majesty witnessed with such deep concern.

The financial arrangements of that portion of Her Majesty's empire will continue to engage Her Majesty's serious attention.

Her Majesty has had much satisfaction in giving Her assent to the Bills which you presented to Her for the formation of a naval and of a military reserve force. A complete and permanent system of national defence must at all times be an object of paramount importance.

Gentlemen of the House of Commons,

Her Majesty commands us to convey to you Her cordial thanks for the readiness and zeal with which you have provided the necessary supplies for the service of the year.

My Lords and Gentlemen,

Her Majesty commands us to express to you Her heartfelt gratification at witnessing the general wellbeing and contentment which prevail throughout Her Dominions: the happiness of Her Majesty's people is the object dearest to Her heart.

In returning to your respective counties you will have duties to perform intimately connected with the attainment of this great end; and Her Majesty fervently prays that the blessing of Almighty God may attend your exertions in the performance of those duties, for the common good of all classes of Her Majesty's subjects.

Then a Commission for proroguing the Parliament was read; after which the Lord Chancellor said,

My Lords and Gentlemen,

By virtue of Her Majesty's Commission, under the Great Seal, to us and other Lords directed, and now read, we do, in Her Majesty's name, and in obedience to Her commands, prorogue this Parliament to Thursday the twenty-seventh day of October next, to be then here holden; and this Parliament is accordingly prorogued to Thursday Her Majesty is glad to be able to congratulate the twenty-seventh day of October next.

Board of Trade, Whitehall, August 17, 1859.

THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Decree which was published in the Monitore Toscano of the 22nd ultimo, instituting a new system of measurement for Tuscan and foreign vessels, in the place of that formerly in use.

The following is a translation of the Decree:-

The Government of Tuscany, considering that the present system of the computation of tonnage is burthensome to the commerce of Tuscan vessels, inasmuch as it differs from that adopted by the principal maritime powers in the points of mensuration, which yield as the result a smaller amount of tonnage; and being desirous of securing to shippers the advantages to be derived from a similar method of computation;

On the proposition of the Minister of Finance Commerce, and Public Works—

Decrees:-

Art. I.—The capacity or burthen both of sailing and steam vessels, whether national or foreign, shall in future be reckoned in tons, their dimensions being measured in the following manner.

Length.

For a one-decked vessel—

From stem to stern along the level of the deck, that is from the poop to the prow (internally).

For a two-decked vessel-

Add to the first length that which is comprised between the stern-post and the stern, measured along the floor of the second deck, and divide the sum of the two lengths by two, to obtain the medium length.

Width.

At the main beam, or point of the greatest width of the vessel.

For vessels having an inner fixed planking, from one surface to the other of that planking.

For those with a moveable planking, or with no planking, between the two inner boards.

Height.

At the point of the greatest width.

For a one-decked vessel-

From under the floor of the deck, without reckoning the aperture for the mast, or the cross beams of the deck, to the upper side of the floor of the store room (pagliolo).

For a two-decked vessel—

From under the floor of the deck as above, to that of the gangway, and from under that to the store room.

Art. II.—These three dimensions shall be expressed in metres and their decimal fractions, and after multiplying such products into each other, the produce shall be divided by 3.80, and the quotient shall indicate the amount of the tonnage of the vessel.

Art. III.—The computation of steam vessels shall be reckoned in a similar manner, but forty

per cent. shall be deducted from the amount of the tonnage for the space occupied by the engine and its accessories.

Art. IV.—The Minister of Finance, Commerce, and Public Works, is charged with the execution of the present decree, which shall have effect from the 1st day of August next.

Light on Kili Point.

THE Director of Lights for the Turkish Government has given notice that on and after the 8th of August 1859, a light would be established at Kili Point, on the coast of Anatolia, 22 miles to the eastward of the entrance to the Bosphorus.

The light revolves once a minute. It is placed at an elevation of 221 English feet above the level of the sea, and in clear weather should be visible from a distance of 25 miles.

Light on Orrio De Tapia Isle.

THE Minister of Marine at Madrid has given notice, that on and after the 1st of September 1859 a light will be exhibited from a lighthouse recently erected on Orrio de Tapia Isle, in the province of Oviedo, Bay of Biscay.

The light will be a fixed light, varied by a flash every two minutes, it is placed at an elevation of 93 English feet above the level of the sea, and in ordinary weather should be visible from a distance of 15 miles.

The illuminating apparatus is dioptric, or by lenses of the third order.

The light tower is octagonal, of ash-coloured granite, 27 feet in height, and rises above the north face of the keeper's dwelling, which is painted white. It is in lat. 43° 35′ 36″ N.; long. 6° 58′ 26″ W. of Greenwich, according to the latest given Spanish position.
