THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Consul at Lisbon, stating that, from and after the 1st of December, the ports of Spain, in the Mediterranean, are considered to be clean.

THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Consul at Lisbon, stating that Oran is considered to be infected with Cholera Morbus, and all the other ports of Algiers suspected of infection.

THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Consul-General at Venice, stating that the following ports are to be considered as infected with Yellow Fever:

1. Western Africa-

The ports of Gambia, and all ports between Senegal and Sierra Leone.

2. North America-

New Orleans, and all other ports in Louisiana.

3. Central America-

Tampico, and all other ports in Mexico.

4. South America-

All the Ports of Brazil.

THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Consul-General at Venice, stating that the Quarantine Regulations to which, according to the circulars of the 5th November, 1858, and 7th October, 1859, vessels arriving from Syria, Egypt, the Regency of Tunis, Algeria, and Morocco, were liable, are withdrawn, but—

That vessels arriving from the Regency of Tripoli which, by the above-mentioned circular of November 5, 1858, were subject to quarantine of foul bill of health for plague, shall henceforth, if furnished with clean bills of health, be liable to

quarantine in the following manner:

Vessels, persons, and cargo, where the bill of health be given or confirmed by the Consulate of any European Power, to six days.

Should the said confirmation be wanting, to seven days.

Merchandize extremely suspected (rags and wearing apparel), after being opened in the lazaretto, to ten days.
