NOTICE is hereby given, that The Queen will hold a Court at St. James's Palace, on Wednesday, the 7th of March next, at two o'clock, for the special and exclusive reception of Officers of Volunteer Corps, who may be desirous of presenting themselves before Her Majesty.

REGULATIONS.

The Officers of Volunteer Corps who are desirous of attending the Queen's Court, at Saint James's Palace, on Wednesday the 7th of March next, should forthwith communicate their intention to the Lord Lieutenants of the several Counties in which their Corps have been established.

A list of the Officers who have thus signified their wish to be present will be transmitted by the Lord Lieutenant of each County to the Secretary of State for the War Department.

These lists, which will distinguish the rank of each Officer and the Corps or Company to which he belongs, will be forwarded to the Lord Chamberlain from the War Department, at latest, upon Monday the 5th of March.

The Lord Lieutenants and the Military Authorities summoned to attend the Court, will enter the Palace at the Entrée Entrance in Ambassadors' Court, and will pass at once to the Entrée Room.

The Officers of Volunteers will enter the Palace at the usual Corridor Entrance, opposite Marlborough House, and will be shewn at once to the room appointed for the assembling of their corps, where they will form into Companies in the order in which they are to pass the Queen. In order to facilitate this arrangement, each Officer will be furnished with a card on which is distinctly written, his County, the number of his County in the Army List, and the name and number of his Corps, Company, or Sub-division. Artillery should be specially marked on the cards of Officers of Artillery Volunteer Corps.

The doors of the Palace will be opened at half past twelve o'clock, and no Officer can be admitted after a quarter before two o'clock.

Officers will appear in the Uniforms approved for their Corps by the Lord Lieutenants.

They will pass before the Queen by Regiments, Companies, or Sub-divisions, headed by the Senior Officer present. The Officers of each Corps will be introduced by the Lord Lieutenants of their Counties, who will join them before entering the Throne Room. In the absence of the Lord Lieutenants, they will be introduced by the Under Secretary of State for the War Department. The Officers will draw up in line before the Queen, and the Senior Officer of each Corps or Company present, will hand a card containing the names of those about to pass before Her Majesty, to the Lord Lieutenant. This Card will be passed to the Lord Chamberlain, who will read the names to the Queen. The Officers will then pass on.

The various Corps will take precedence according to their Seniority in the Army List.

REGULATIONS

TO BE OBSERVED WITH REGARD TO THE QUEEN'S LEVEES AT ST. JAMES'S PALACE.

By Her Majesty's Command.

The Noblemen and Gentlemen, who propose to attend Her Majesty's Levees, at St. James's Palace, are requested to bring with them two large cards, with their names *clearly written* thereon, one to be left with The Queen's Page in Attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to The Queen.

PRESENTATIONS.

Any Nobleman or Gentleman who proposes to be presented to The Queen must leave at the Lord Chamberlain's Office, *before twolve o'clock*, two clear days before the Levee, a card with his name written thereon, and with the name of the Nobleman or Gentleman by whom he is to be presented.

In order to carry out the existing regulation that no presentation can be made at a Levee excepting by a person actually attending that Levee, it is also necessary that a letter from the Nobleman or Gentleman who is to make the presentation, stating it to be his intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is Her Majesty's command, that no presentations shall be made at the Levees, except in accordance with the above regulations.

It is particularly requested, that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to The Queen.

The state apartments will not be open for the reception of Company coming to Court, until half-past one o'clock.

Addresses.

The same regulations apply to the presentation of Addresses or Petitions.

A card containing a statement of the object of the Addresses or Petitions, with the names of the persons who are to present them, must be sent to the Lord Chamberlain's Office two clear days before the Levee. Two other cards. Lontaining similar information, are to be taken to the Levee, one to be delivered to The Queen's Page in Attendance in the Corridor, and the other to the Lord Chamberlain, who will read its contents to The Queen.

On these occasions no other statement is to be addressed to Her Majesty.

A Deputation to present an Address is not to exceed four persons.

The members of a Deputation, who have not previously attended Court, must be presented to The Queen.

The Ladies, who propose to attend Her Majesty's Drawing Rooms, at St. James's Palace, are requested to bring with them two large cards, with their names *clearly written* thereon, one to be left with The Queen's Page in Attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to The Queen.

PRESENTATIONS.

Any Lady who proposes to be presented to The Queen must leave at the Lord Chamberlain's Office, *before twelve o'clock*, two clear days before the Drawing Room, a card with her name written thereon, and with the name of the Lady by whom she is to be presented. In order to carry out the

existing regulation, that no presentation can be made at a Drawing Room excepting by a Lady actually attending that Court, it is also necessary that a letter from the Lady who is to make the presentation, stating it to be her intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen, for Her Majesty's approbation. It is Her Majesty's Command, that no Presentations shall be made at the Drawing Rooms, except in accordance with the above regulations.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to The Queen.

And whereas it is expedient that so much of the said recited Warrant as imposes upon every British newspaper, posted in the United Kingdom, addressed to Australia, and transmitted by packetboat, viâ Southampton and Egypt, a rate of two pence, and that so much of the said recited Warrant as imposes upon every such newspaper

an additional charge and rate of postage of one penny, as hereinbefore mentioned and recited, should be repealed, and that such newspapers should be transmitted by the post, at the reduced rate of one penny each, as hereinafter mentioned.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the powers vested in us in and by the said several before recited Acts of Parliament, or either of them, and of all other powers enabling us in this behalf, do, by this Warrant (under the hands of two of us, the said Commisioners, by the authority of the statute in that case made and provided), order and direct as follows:

1: So much of the said 4th clause of the said recited Warrant of the 16th day of February, 1859, as directs that every British newspaper posted in the United Kingdom, addressed to Australia, may be transmitted by the post to Australia by packet-boat, via Southampton and Egypt, at a rate of two pence each. And so much of the said 8th clause of the said recited Warrant as directs that if any newspaper shall be posted in the United Kingdom for transmission, via Southampton and Egypt, addressed to Australia, having thereon, or affixed thereto, a postage stamp or stamps, the value of which shall be less in amount than the rate of postage to which such newspaper would be liable under the said recited Warrant, but equal in amount to the sum of one penny, every such newspaper shall be forwarded charged with the amount of the difference between the value of such stamp or stamps so being thereon, or affixed thereto, and the postage to which such newspaper would be liable as aforesaid, together with a further and additional rate of postage of one penny, shall be, and the same is, and are, hereby repealed, revoked, and annulled, and the said rate of two pence, and also the said further and additional rate of postage of one penny, so far as they respectively relate to British newspapers transmitted to Australia as aforesaid, shall wholly cease and determine, anything in the said recited Warrant of the 16th day of February, 1859, contained to the contrary, notwithstanding.

Rockabill Lighthouse, and St. John's Point Light.

THE Port of Dublin Corporation hereby give notice, that a lighthouse has been erected on Rockabill—off the east coast of County Dublin —from which a light will be exhibited during the night of the 1st day of July next, 1860, and thenceforth will be lighted every night from sunset to sunrise. Notice is also given, that from and after same date the light on St. John's Point, Dundrum Bay, will be coloured red.

Specification given of the position and appearance of the lights, by MR. HALPIN, Superintendent of Lighthouses.

Rockabill Light.

Rockabill Lighthouse is erected on the summit of the larger rock— $2\frac{1}{2}$ miles eastward of Skerries Islands—and is in lat. 53° 35′ 45″ N., and long. 6° 0′ 30″ W., bearing from Drogheda Bar S.S.E. distant 11 miles; from the Kish Lightship N. by E., $\frac{1}{2}$ E., distant 17 miles; from the Nose of Lambay Island N.N.E., distant $6\frac{1}{4}$ miles; from Balbriggan Pier Light, S.E. by E., distant $6\frac{1}{4}$ miles.

The light will be a *flashing* light, giving a bright flash every *twelve* seconds, of the natural colour *white*, as seen from between the bearings of S. $\frac{1}{2}$ E. (round by the Eastward) to N.E. by N., and will be coloured *red* round by the westward, between the same bearings.

The illuminating apparatus is dioptric (holophotal) of the 1st order, its focal plane 155 feet over the mean level of the sea, and in clear weather the *whit*: light should be seen from a distance of 18 miles.

The tower is circular, of gray limestone, and the whole height from its base to the top of its lantern is 105 feet. A range of storehouses surround the lower story of tower; the dwellinghouses are built to the north westward, on a lower level of the rock.

St. John's Point Light.

From and after the date of the exhibition of the Rockabill light (1st July, 1860), the *inter-*No. 22356. B *milting* light on St. John's Point, Dundrum Bay, will be coloured *red*, the times of its eclipses will continue as heretofore.

Note.—At same date with the exhibition of the new light on Rockabill, and the change in the colour of the light on St. John's Point, some alterations will be made in the distinctive characters of floating lights off the east coast of Ireland, conformably to notices this day published.
