By Her Majesty's Command.

The Ladies, who propose to attend Her Majesty's Drawing Rooms, at St. James's Palace, are requested to bring with them two large cards, with their names clearly written thereon, one to be left with The Queen's Page in Attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to The Queen.

'Any Lady who proposes to be presented to The Queen must leave at the Lord Chamberlain's Office, before twelve o'clock, two clear days before the Drawing Room, a card with her name written thereon, and with the name of the Lady by whom she is to be presented. In order to carry out the existing regulation, that no presentation can be made at a Drawing Room excepting by a Lady actually attending that Court, it is also necessary that a letter from the Lady who is to make the presentation, stating it to be her intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen, for Her Majesty's approbation. It is Her Majesty's Command, that no Presentations shall be made at the Drawing Rooms, except in accordance with the above regulations.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to The Queen.

REGULATIONS

TO BE OBSERVED WITH REGARD TO THE QUEEN'S LEVEES AT ST. JAMES'S PALACE.

By Her Majesty's Command.

The Noblemen and Gentlemen, who propose to attend Her Majesty's Levees, at St. James's Palace, are requested to bring with them two large cards, with their names clearly written thereon, one to be left with The Queen's Page in Attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to The Queen.

Présentations. ...

Any Nobleman or Gentleman who proposes to be presented to The Queen must leave at the Lord Chamberlain's Office, before twelve o'clock, two clear days before the Levee, a card with his name written thereon, and with the name of the Nobleman or Gentleman by whom he is to be presented. In order to carry out the existing regulation that no presentation can be made at a Levee excepting by a person actually attending that Levee, it is also necessary that a letter from the Nobleman or Gentleman who is to make the presentation, stating it to be his intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is Her Majesty's command, that no presentations shall be made at the Levees, except in accordance with the above regulations.

It is particularly requested, that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to The Queen.

The state apartments will not be open for the reception of Company coming to Court, until half-past one o'clock.

Addresses:

The same regulations apply to the presentation of Addresses or Petitions,

A card containing a statement of the object of the Addresses or Petitions, with the names of the persons who are to present them, must be sent to the Lord Chamberlain's Office two clear days before the Levee. Two other cards, containing similar information, are to be taken to the Levee, one to be delivered to The Queen's Page in Attendance in the Corridor, and the other to the Lord Chamberlain, who will read its contents to The Queen.

On these occasions no other statement is to be addressed to Her Majesty.

A Deputation to present an Address is not to exceed four persons.

The members of a Deputation, who have not previously attended Court, must be presented to The Queen.

THE Secretary of State for India has received the following Minute of the Governor-General of India, in continuation of that published in the London Gazette of the 7th October, 1859.

Minute by his Excellency the Viceroy and Governor-General of India on the Services of Civil Officers and others during the Mutiny and Rehellion.

1. I PROCEED to complete the minute of the 2nd of July last, which was in some respects imperfect.

2. First, as regards Oude.

In every part of Onde, except within the walls of the Lucknow Residency, the Civil Officers of the Government were killed at their posts, or escaped by concealment and flight, under the most trying difficulties.

The Civil Government was overwhelmed and swept away, and, for the ten months following the outbreak of the mutiny, the history of the Civil Officers of the province is comprised in the accounts of the siege, relief, and recovery of the seat of the local Government in Lucknow, which have already been submitted to Her Majesty's Government.

But there are some of the officers of Sir Henry Lawrence's Government who still survive to bear testimony to the great qualities of their noble chief, and who have also had a share in the recovery of the province, and in re-establishing the administration. And there are those whose services in the province began with the relief of the garrison, or the recovery of the city.

- 3. Mr. Martin Gubbins held the post of Financial Commissioner of Oude until the office was abolished on the reorganisation of the local Government. During a great part of the siege he had charge of the Intelligence Department, and his energy in the construction and superintendence of defensive works, and in other respects, were very praiseworthy, and call for the notice of Her Majesty's Government.
- 4. Mr. G. Couper held the office of Secretary to the Chief Commissioner of Oude. Sir J. Inglis bears grateful testimony to the value of the aid which he received from this able and zealous officer in military as well as civil matters. Mr. Couper's services were very remarkable, and I

strongly recommend him to the favourable consideration of Her Majesty's Government.

- I also beg that the services rendered by Mr. W. Forbes, Deputy Commissioner, whose good service, almost single-handed, on the south-eastern border of Oude, was conspicuous; and by Major J. W. Carnegie, Deputy Commissioner; may be favourably considered.
- 5. The services of the following officers should, I submit, receive the notice of Her Majesty's Government:-Major Hutchinson, who, after taking an important part in the military operations, was of signal service as a civil officer and military secretary to the Chief Commissioner; Mr. S. Martin, Deputy Commissioner; Captain Reid, Deputy Commissioner; Mr. C. Denison, on temporary service in Oude; Captain H. Evans, Deputy Commissioner; Captain A. P. Orr, Deputy Commissioner; Mr. G. H. Lawrence, Deputy Commissioner; Mr. W. C. Capper, Deputy Commissioner, whose conduct in the garrison of the residency has been commended by Sir J. Inglis; Mr. Balmain, Deputy Commissioner; Lieutenant E. Chamier, Assistant Commissioner; Mr. Kavanagh, Assistant Commissioner, whose courage at a most critical time of the siege has already won for him high reward; Mr. R. Moss King, Assistant Commissioner; Captain Thurburn, attached to General Walpole's column, and since employed in Lucknow; and Captain Bunbury, formerly of the intelligence department, and afterwards in command of a police battalion.
- 6. The valuable services of Major H. Bruce, Chief of the Police, have been recognised by Her Majesty's Government. The officers of his corps have done their duty admirably: Captain Chamberlain, Captain Boileau, and Captain Dawson have much distinguished themselves.
- 7. Major L. Barrow has also received acknowledgment for his good services; but, in addition to those which were rendered in the field, he has the credit of having discharged with great judgment the task of making settlements with the landholders.
- 8. Of gentlemen not in the regular service of the Government, Mr. Schilling and Mr. Crank, of the Martiniere College, Mr. McCrae, Civil Engineer, and Mr. Cameron deserve that their valuable exertions during the siege, to which General Inglis has already borne testimony, should not be passed over, although the service was military rather than civil. To these should be added Mr. F. Lincoln, Superintendent of the Judicial Commissioner's office.
- 9. But it was to the Chief Commissioner of Oude, Sir Robert Montgomery, that, from the time when the reorganisation of the province began, the praise of directing and steadily advancing the work, with scarcely a single check, mainly belonged. I cannot too warmly express my thanks for the service which he rendered to the State, in the ten months during which the Chief Commissionership was in his hands.

10. I have next to refer to Nagpore, a full report from this province being now before me.

The task which fell to the Civil Officers and others of the Local Government in Nagpore was, for the most part, one of prevention and repression, rather than a struggle against open rebellion; but it was most judiciously, as well as promptly and vigorously performed, and to this is due that, not even in the wild and remote parts of that province, were those fearful tragedies enacted, of which other provinces have been the scenes. Services which secured this result are eminently deserving of praise,

11. The officers of the Nagpore Commission, whom I recommend to the favourable consideration of Her Majesty's Government, are—Mr. R. S. Ellis, Deputy Commissioner and Superintendent of Police, Captain C. Elliot, Deputy Commissioner, and Captain Crichton, Deputy Commissioner.

The responsibilities which fell upon these officers in their respective districts (Nagpore, Raepore, and Chanda) were very heavy, and were sustained with great courage and complete success.

- 12. I also ask the favourable notice of Her Majesty's Government for Major Snow, Deputy Commissioner; Lieutenant C. B. Lucie Smith, Assistant Commissioner; Mr. A. B. Ross, Assistant Commissioner; Lieutenant Cumberlege, Personal Assistant to the Commissioner; Captain Rybot, Executive Engineer, and Mr. Peter, of the Telegraph Department.
- 13. Mr. G. Plowden, the head of the Nagpore Commission, has the high credit of having been ready at all times to contribute, from the small force at his disposal, to the defence of his fellow-countrymen beyond his own province. The cheerfulness with which Mr. Plowden not only complied with, but anticipated, the requests from neighbouring provinces for aid, well merits the notice of Her Majesty's Government.
- 14. There remain a few, whose names should have had place in my former minute, but who, owing to the transfer of their services from one local government to another, the death of the officers from whom the reports should have been received, and other incidental causes, were not included in it.
- 15. Those for whom I now have to ask the notice of Her Majesty's Government are Mr. C. B. Saunders, at first Magistrate of Moradabad, and afterwards the very efficient Commissioner of Delhi; Mr. George Campbell, since transferred to the Judicial Commissionership of Oude; Mr. W. Ford, Magistrate of Goorgaon; Mr. J. W. Sherer, Magistrate of Cawnpore, and attached as Civil Officer to General Havelock's column; Mr. J. D. Inglis, Magistrate of Bareilly; Mr. C. Richardes, Joint Magistrate of Paniput; Mr. John Campbell, Joint Magistrate of Moradabad; Mr. James Power, Assistant Magistrate of Myn-poorie; Mr. F. B. Outram, Assistant Magistrate of Allygurh; Dr. Stewart Clark, who had charge also of the construction and supply of carriages for the troops, and, in spite of surrounding difficulties, never failed to meet every demand upon him; Captain W. McNeile, Deputy Commissioner of Thanesur; and Mr. H. Harington, of the Telegraph Department.
- 16. For Major W. H. Greathed, of the Bengal Engineers, employed by the Civil Government, during the first months of the mutiny, upon most perilous duty, between Agra and Delhi, which he performed with excellent judgment and courage, I request the favourable consideration of Her Majesty's Government.
- 17. In Bengal, I have only to add for notice the name of Mr. Edward Lushington, who, as Commissioner of Mambhoom and Singhbhoom, did good service, with small support, in the wild tracts of the South-Western frontier.
- 18. Lastly, I ask that the services of Mr. H. B. Riddell, Director-General of the Post Office in all India, may be noticed. The appliances of his department were, under his superintendence, turned to most valuable account, in the conveyance of male of his body lawfully begotten.

troops and stores, from the very beginning of the Mutiny, and mainly by his own energy and activity.

19. I now close this list, which is the supplement and conclusion of that of the 2nd of July. $I_{\rm S}$ might have extended them greatly, without inserting the name of a single man whose duties did not, in the time of which I have spoken, rise far beyond their ordinary scope; and who had not proved himself more than equal to them. But, where the field and the numbers engaged in it are so large, it is not possible to include all to whom honour is due. As it is, I am painfully sensible of the inadequacy of written words to convey a true estimate of all that has been done, and endured, by those whom I have named.

None but those, whose duty it was to watch, day after day, the throbbings of the vast continent in its convulsion, can thoroughly conceive the extent, and character, and variety, of the great services rendered by the officers of the Civil Government of India, and by those who aided There are some who impetuously struck them. down rebellion when it first raised its head within the sphere of their action; there are some who, threatened by it all around, day and night, steadily repelled it at every point, and held their ground; there are others, whose business it became to cheer and discipline mistrustful communities into useful loyalty; there are others who, as the representatives of their Government in Native States, and standing almost alone amongst armed fanatics, excited by daily rumours of disaster to the British power, worthily sustained, and, by their bearing, compelled respect to, the dignity and authority of their country; and there are those (and they are not the least) who, to England's eternal honour, and with a wise perception of her true interests, knew when to exhibit mercy in its most godlike form-mercy extended in the hour of triumph and asserted power—to those who had deeply offended.

I cannot attempt to do justice to the part which has been borne by each individual whom I have mentioned. The records in full are before Her Majesty's Government; and I can but place these lists in the hands of the Secretary of State, with the assurance that there is not in them the name of a single man of whom his country may not be proud, or of any whom I cannot conscientiously and earnestly recommend as worthy of the favour or notice of the Crown.
