OTICE is hereby given, that The Queen will hold a Levee, at St. James's Palace, upon Wednesday the 28th of March next, at two o'clock.

REGULATIONS

TO BE OBSERVED WITH REGARD TO THE QUEEN'S LEVEES AT ST. JAMES'S PALACE.

By Her Majesty's Command.

The Noblemen and Gentlemen, who propose to attend Her Majesty's Levees, at St. James's Palace, are requested to bring with them two large cards, with their names clearly written thereon, one to be left with The Queen's Page in Attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to The Queen.

PRESENTATIONS.

Any Nobleman or Gentleman who proposes to be presented to The Queen must leave at the Lord Chamberlain's Office, before twelve o'clock, two clear days before the Levee, a card with his name written thereon, and with the name of the Nobleman or Gentleman by whom he is to be presented. In order to carry out the existing regulation that no presentation can be made at a Levee excepting by a person actually attending that Levee, it is also necessary that a letter from the Nobleman or Gentleman who is to make the presentation, stating it to be his intention to be present, should accompany the presentation card above referred to, which will be submitted to The Queen for Her Majesty's approbation. It is Her Majesty's command, that no presentations shall be made at the Levees, except in accordance with the above regulations.

It is particularly requested, that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to The Queen.

The state apartments will not be open for the reception of Company coming to Court, until half-past one o'clock.

ADDRESSES.

The same regulations apply to the presentation of Addresses or Petitions.

A card containing a statement of the object of the Addresses or Petitions, with the names of the persons who are to present them, must be sent to the Lord Chamberlain's Office two clear days before the Levee. Two other cards, containing similar information, are to be taken to the Levee, one to be delivered to The Queen's Page in Attendance in the Corridor, and the other to the Lord Chamberlain, who will read its contents to The Queen.

On these occasions no other statement is to be addressed to Her Majesty.

A Deputation to present an Address is not to exceed four persons.

The members of a Deputation, who have not previously attended Court, must be presented to The Queen.

WHEREAS Her Majesty was graciously pleased by Her Royal Proclamation, bearing date the thirtieth day of April, one thousand eight hundred and fifty-nine, to promise

and declare that the Bounties of Ten Pounds ! for every Able Seaman, and Five Pounds for every Ordinary Seaman, fit for Her Majesty's Service, should be paid, in the manner thereby directed to every such Able and Ordinary Seaman, not above the age of forty-five, nor under the age of twenty years, who should, on or before the fifteenth day of June then following, enter themselves to serve in Her Majesty's Royal Navy, either with the Captains or Lieutenants of Her Majesty's Ships, or Officers employed in Tenders, or at Rendezvous on Shore for raising men for the service of the Royal Navy: and whereas Her Majesty was also graciously pleased by Her said Proclamation to declare that all Ablebodied Landsmen, not above the age of twenty-five, nor under the age of twenty years, who should so enter themselves as aforesaid, should receive the sum of Forty Shillings each man as Her Majesty's Royal

And whereas the time limited for Payment of the said Bounties, so far as they relate to Able Seamen and Ordinary Seamen, was, by Order in Council of the eleventh day of June last, prolonged and extended from the said fifteenth day of June to the thirty-first day of July last; and whereas by certain other Orders in Council, the said Bounties to Able and Ordinary Seamen were reduced to Eight Pounds and Four Pounds, to Six Pounds and Three Pounds, and lastly to Four Pounds and Two Pounds, respectively; and the time limited for the payment of the said lastnamed Bounties was, on the twenty-third day of January last, prolonged and extended from the first day of February last to the thirty-first day of March instant; and it being judged expedient for Her Majesty's Service that such Bounties should, so far as they relate to Able Seamen and Ordinary Seamen, be continued to be paid for some time longer; Her Majesty, with the advice of Her Privy Council, doth therefore order, and it is hereby accordingly ordered that the time limited for payment of the said Bounties of Four Pounds to Able Seamen, and of Two Pounds to Ordinary Seamen, be prolonged and extended from the first day of April next to the thirtyfirst day of March, one thousand eight hundred and sixty-one, inclusive; Whereof all persons concerned are to take notice, and govern themselves accordingly.

WHEREAS by an Act, passed in the session of Parliament, held in the eighteenth and nineteenth years of Her Majesty's reign, intituled "An Act further to amend the "laws concerning the burial of the dead in "England" it is, amongst other things, enacted that it shall be lawful for Her Majesty, by and with the advice of Her Privy Council, from time to time, to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the said Act (whether the time thereby appointed for

the discontinuance of burials thereunder, or other operation of such Order, shall or shall not have arrived), as to Her Majesty, with such advice as aforesaid, may seem fit;

And whereas certain Orders in Council have been made, directing the discontinuance of burials in the churchyards and burial-grounds hereinafter mentioned from the time mentioned in such Orders respectively; and whereas it seems fit to Her Majesty, by and with the advice of Her Privy Council, that the time for discontinuing burials in the said churchyards and burial-grounds be postponed;

Now, therefore, Her Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that the time for the discontinuance of burials in such churchyards and burial-grounds be postponed, as follows; viz.:

- In the present churchyard of the parish of Alston, Cumberland, from the first of April to the first of June, one thousand eight hundred and sixty;
- In St. Bartholomew's Churchyard, in the Independent Chapelyard, in the Inghamite Burial-ground, and in the Wesleyan and Baptist Burial-grounds, all in COLNE, in the parish of Whalley, from the first of April to the first of July, one thousand eight hundred and sixty:
- In the churchyard of Kington, Herefordshire, from the first of April to the first of October, one thousand eight hundred and sixty;
- In the churchyard of Melbourne, Derbyshire, and in the Friends' Burial-ground, in the New Jerusalem Chapel Burial-ground, and in the Baptist Chapel Burial-ground, in the same parish, from the first of March to the first of June, one thousand eight hundred and sixty;
- In the churchyard of All Saints, POPLAR, from the first of May next, to the first of May, one thousand eight hundred and sixty-one, provided the burials therein be conducted in accordance with the 7th, 8th, and 9th Official Regulations for burial-grounds; that in all cases there shall be a covering of four feet and six inches of earth above the coffin, measuring from the general surface of the ground; and that with the exception of now existing family vaults and graves, which shall only be used for the interment of persons whose relations are already buried therein, no earth that has been already buried in shall be reopened.

And whereas by an Order in Council of the seventh day of this instant March, burials were directed to be discontinued, with certain exceptions, in the Roman Catholic Cemetery at Fallsworth, and it seems fit that the said Order be varied; now therefore Her Majesty, by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, that instead of limiting the burials in the said cemetery to those of Roman Catholics dying within the townships of Failsworth and Newton Heath only, there be permitted also burials of Roman Catholics dying within the townships of Moston, Harpurley, and Blackley, and of members of the families of those persons who now possess family graves therein, on condition that the Regulations for New Burial Grounds be observed.
