

tinuance of burials in such churchyards and burial-grounds be postponed, as follows; viz.:

In the churchyard of St. John, BACUP, in the parishes of Whalley and Rochdale, and in the Ebenezer and Irwell Terrace Chapel Burial-grounds, in that consolidated chapelry, from the first of July to the first of October, one thousand eight hundred and sixty;

In the chapelyard of the Ecclesiastical District of WHITECHAPEL, CLECKHEATON, in the parish of Birstal, Yorkshire, from the first of July to the first of September, one thousand eight hundred and sixty;

In the churchyard of the parish of BISLEY, Gloucestershire, from the first July to thirty-first October, one thousand eight hundred and sixty;

In St. Bartholomew's Churchyard, in the Independent Chapelry, in the Inghamite Burial-ground, and in the Wesleyan and Baptist Burial-grounds, all in COLNE, in the parish of Whalley, from the first of July to the first of September, one thousand eight hundred and sixty;

And whereas by an Order in Council of the twelfth day of April, one thousand eight hundred and fifty-nine, burials were directed to be discontinued (with certain exceptions) in the chapelyard of THORNTON Episcopal Chapel, near Bradford, Yorkshire, on and after the first day of July, one thousand eight hundred and fifty-nine, which period was afterwards extended to the first of July, one thousand eight hundred and sixty, and it seems fit that the said Order be varied: now, therefore, Her Majesty by and with the advice of Her Privy Council is pleased to order, and it is hereby ordered, that interments in the chapelyard of THORNTON Episcopal Chapel, near Bradford, Yorkshire, be discontinued on and after the said first day of July, one thousand eight hundred and sixty, except in vaults and walled graves, which can be opened without the disturbance of soil which has been buried in, and in which each coffin shall be separately entombed in an air-tight manner, and except in earthen graves not less than five feet deep, which can be opened without the exposure of human remains;

And whereas, by an Order in Council of the twenty-fourth of September, one thousand eight hundred and fifty-five, burials were directed to be discontinued (with certain exceptions) in the churchyard of St. Bartholomew, BIRMINGHAM, on and after the first of January, one thousand eight hundred and fifty-eight, and such Order was, on the twenty-eight of November, one thousand eight hundred and fifty-six, varied in respect of the churchyard of St. Bartholomew, and the time for discontinuing burial therein was postponed till the thirty-first of December, one thousand eight hundred and fifty-seven; and whereas, by another Order in Council of the twentieth of March, one thousand eight hundred and fifty-seven, burials were directed to be discontinued on and after the said thirty-first of December in the churchyards or cemeteries of St. Philip, St. Martin, St. Paul, and St. Mary, BIRMINGHAM, except as was therein excepted, and such Order was on the third day of February, one thousand eight hundred and fifty-eight, varied in respect of the churchyards of St. Bartholomew, St. Mary, St. Paul and St. Martin, BIRMINGHAM, and the time for discontinuing burials therein was postponed to the first day of July, one thousand eight hundred and fifty-nine, which time was by an Order in Council of the sixth day of July, one thousand eight hundred and fifty-nine, further postponed to the first of July,

one thousand eight hundred and sixty, and it seems fit that the said Orders be varied; now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, that the time for the discontinuance of burial should be postponed until the first July, one thousand eight hundred and sixty-one, in the churchyards of St. Bartholomew, St. Mary, St. Paul and St. Martin, BIRMINGHAM, at which time burial shall be discontinued except in vaults and walled graves existing on the twentieth March, one thousand eight hundred and fifty-seven, in which each coffin shall be embedded in charcoal and separately entombed in an airtight manner; and that in the meantime one body only be buried in any earthen grave which shall not be opened unless free from remains;

And whereas, by an Order in Council of the second of December, one thousand eight hundred and fifty-seven, and by another Order in Council of the third day of February, one thousand eight hundred and fifty-eight, an Order of the twenty-fourth of September, one thousand eight hundred and fifty-five, was varied, in respect of the discontinuance of burials in the *General Cemetery* in the old parish of BIRMINGHAM, and it seems fit that such first-mentioned Order be varied; now, therefore, Her Majesty, by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, that the operation of the said Orders in Council of the second December, one thousand eight hundred and fifty-seven, and of the third of February, one thousand eight hundred and fifty-eight, so far as they direct only one body to be buried in any grave, in the *General Cemetery* and in the Church of England Cemetery of the same town respectively; be postponed from the first July, one thousand eight hundred and sixty, to the first July, one thousand eight hundred and sixty-one;

And whereas, by an Order in Council, of the twenty-fourth June, one thousand eight hundred and fifty-six, burials were directed to be discontinued (with certain exceptions) in the churchyard of St. Helen's, ABINGDON, and in the Baptist Burial-ground from and after the first January, one thousand eight hundred and sixty, which period was afterwards extended to the first July, one thousand eight hundred and sixty, and it seems fit that the said Order be varied; now, therefore, Her Majesty by and with the advice of Her Privy Council, is pleased to order, and it is hereby ordered, that the time for the discontinuance of burials in the new part of the churchyard of St. Helens, ABINGDON; and in the other parts of that churchyard, provided no human remains be exposed; and in the Baptist Burial-ground, St. Helens, ABINGDON, be extended to first January, one thousand eight hundred and sixty-one.

WHEREAS the Right Honourable Sir George Cornwall Lewis, Bart., one of Her Majesty's Principal Secretaries of State, after giving to the Incumbents and the Churchwardens of the parishes hereinafter mentioned, ten days' previous notice of his intention to make such representation, has, under the provisions of an Act, passed in the session of Parliament, held in the sixteenth
