The Queen has been pleased to grant unto the Reverend Augustus James Brine, of Boldre, in the county of Southampton, Master of Arts of the University of Oxford, and in the Commission of the Peace for the said county of Southampton, only child and heir of Augustus Brine, late of Boldre aforesaid, Esquire, deceased, a Rear-Admiral in the Royal Navy, Her Royal licence and authority that he and his issue may, as sole representative of his grandmother, Anne Dansey, formerly Anne Knapton, and in grateful respect to the memory of his great aunt, Elizabeth Knapton, Spinster, deceased, daughters and coheirs of the late Odber Knapton, Esquire, take and henceforth use the surname of Knapton, instead of that of Brine, and also bear the arms of Knapton; such arms being first duly exemplified according to the laws of arms and recorded in the Herald's Office, otherwise the said Royal licence and permission to be void and of none effect:

And also to command that the said Royal concession and declaration be recorded in Her Majesty's College of Arms.

Board of Trade, Whitehall, August 7, 1860.

THE Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received from the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Chargé d'Affaires at St. Petersburgh, enclosing a copy of an Ukase issued by the Emperor of Russia, authorizing foreigners to enter the Russian commercial guilds, upon the same footing as native subjects, and conceding to them all the rights conferred by the guilds upon Russian merchants.

The ukase further grants to foreigners the right to acquire, by purchase, succession, legacy, gift, or imperial concession, all kinds of property, both real and personal, excepting always such property as the Russian hereditary nobility, and foreigners possessing equal rights, are alone able to obtain by virtue of existing laws.

Foreigners are further allowed to act as agents for occupied estates, provided the consent of the proprietors has been obtained. It is also lawful for them to farm real property under the conditions prescribed by law.

The above concessions do not apply to foreign Jews, who are subject to a special treatment.

THE Queen has been graciously pleased to signify Her intention to confer the decoration of the Victoria Cross on the under-mentioned Soldier of Her Majesty's Army, whose claim to the same has been submitted for Her Majesty's approval, on account of an Act of Bravery performed by him in India, as recorded against his name, viz.:—

2nd Battalion, Military Train	No. 201, Private Samuel Morley  Date of Act of Bravery, April 15, 1858	On the evacuation of Azimgurh by Koer Sing's Army, on the 15th of April, 1858, a Squadron of the Military Train, and half a Troop of Horse Artillery, were sent in pursuit.  Upon overtaking them, and coming into action with their rear-guard, a Squadron of the 3rd Spikh Cavalry (also detached in pursuit), and one Troop of the Military Train, were ordered to charge, when Lieutenant Hamilton, who commanded the Seikhs, was unhorsed, and immediately surrounded by the Enemy, who commenced cutting and hacking him whilst on the ground. Private Samuel Morley, seeing the predicament that Lieutenant Hamilton was in, although his (Morley's) horse had been shot from under him, immediately and most gallantly rushed up, on foot, to his assistance, and in conjunction with Farrier Murphy, who has already received the Victoria Cross for the same thing, cut down one of the Sepoys, and fought over Lieutenant Hamilton's body, until further assistance came up, and thereby was the means of saving Lieutenant Hamilton from being killed on the spot.

The Signal Ball at Ascension.

THE Naval Officer in charge of Ascension has given notice, that, in order that vessels calling at the island may readily find the error and rate of their chronometer, a time ball is dropped daily (Sundays excepted) from a flagstaff at the Master's cottage, precisely at one o'clock of Greenwich mean time.

The Master's cottage is situated immediately to the southward of Hayes Hill, and is the only cottage near it bearing a flagstaff. The ball when hoisted ready to drop is at a height of 90 feet above the level of the sea, and may be readily seen from the anchorage.

The longitude of the flagstaff is assumed at 14° 25′ 30″ West, or Oh. 57m. 42s.; the ball, therefore, is dropped at 2m. 18s. after Noon,

mean time at Ascension.

Vessels not intending to remain for the usual time of showing the signal may have the ball dropped at any convenient hour of Greenwich time by making a request at the Master's office at the cottage.
