An Act for removing doubts respecting the Craven Scholarships in the University of Oxford, and for enabling the University to retain the custody of certain testamentary documents.

An Act to amend the Law relative to the Scottish Herring Fisheries.

An Act to amend and further extend the Acts for the commutation of tithes in England and Wales.

An Act to repeal the Duties on Game Certificates and Certificates to deal in Game, and to impose in lieu thereof duties on excise licences and certificates for the like purposes.

An Act to remove doubts as to the authority of the Senior Member of the Council of the Governor-General of India in the absence of the President.

An Act to extend certain provisions for Admiralty jurisdiction in the colonies to Her Majesty's territories in India.

An Act to extend in certain cases the provisions of the Superannuation Act, 1859.

An Act to amend the Police of Towns Improvement Act, so as to enable towns and populous places in Scotland to avail themselves of its provisions for sanitary and other improvements, without at the same time adopting its provisions as regards the establishment and maintenance of a police force.

An Act for the sale of the Settled Estates, in the counties of Sligo and Galway, of John, Lord De Freyne, and for the purchase of estates, in the county of Roscommon, to be limited to the uses of those Settled Estates.

WITH reference to the notice inserted in the London Gazette of the 3rd instant, the Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations hereby notify that they have received, from the Secretary of State for Foreign Affairs, a copy of a further Despatch from Major Stokes, the British Commissioner for the European Commission of the Danube, enclosing a copy of the following "Provisional Tariff of Navigation Dues, applicable to the Sulina Mouth of the Danube, in execution of Article XVI. of the Treaty of Paris of the 30th March, 1856."

THE European Commission of the Danube:

Whereas the 16th Article of the Treaty of Paris, of the 30th March, 1856, stipulates that the expenses of the works executed to clear the mouths of the Danube, as well as the neighbouring parts of the sea, from the impediments which obstruct them, as well as those of the establishments intended to secure and facilitate the navigation, shall be covered by means of fixed duties established and levied by the Commission;

And whereas the increase of depth produced by the provisional works undertaken at the Sulina mouth, and by the works of rectification in the course of the river, on the shallows of the Argagni, as well as the improvements introduced into the establishments of which mention is made in the treaty, have already the effect of diminishing the impediments which vessels encounter in the Danube, and the expenses resulting therefrom;

And whereas, in order not to lay exclusively upon the commerce of the future the weight of the expenses of these improvements, of which the trade of the present day is beginning to reap the benefits, it is just and equitable, whilst awaiting the application of the definitive tariff which will be established after the completion of the works, to subject the navigation immediately to a provisional toll, proportioned to the advantages which it enjoys at the present time;

And whereas, in order to simplify the collection as much as possible, it is desirable that the different dues paid by vessels, whether for the works of improvement or for the service of the establishments, such as lighthouses and pilots, be blended into one single navigation due;

The Commission decrees the provisional tariff, of which the tenor is as follows:

ART. 1. Every sailing vessel of more than 30 tons register, quitting the port of Sulina to go to sea, and which shall have, according to her manifest, more than half of her full lading, shall pay a fixed navigation toll by ton register, the amount of which shall be regulated according to the following table, by the total tonnage of the vessel, and by the depth on the bar at the mouth of the Sulina branch.

ART. 2.—Steam vessels belonging to a public Company, specially appropriated to the transport of passengers, and making periodical voyages according to a time-bill published beforehand, shall pay each time on leaving the river a fixed toll of 25 centimes per registered ton without reference to their lading being whole or partial. This toll shall be calculated on the total tonnage of the vessel less 40 per cent. for space occupied by engines and coal bunkers. These vessels shall be free from all toll on entering the river.

ART. 3.—All merchant steam vessels, not included among those designated in Art 2, shall be subjected to the same tolls as sailing vessels,

excepting the deduction of 40 per cent. which shall also be made from their total tonnage on account of the engines and coal bunkers. The amount of the toll which these vessels shall pay by register ton, is to be determined in conformity with the above table after the deduction of 40 per cent. guaranteed by this Article.

ART 4.—Sailing vessels and merchant steam vessels other than those mentioned in Art. 2, which shall enter the Port of Sulina from the sea, and which shall have, according to their manifest, more than half of their lading, shall pay for their passage inwards one-fourth of the toll which would fall on them for the passage outwards according

to the above Arts. 1 and 3. They shall, however, pay the total amount of the toll for entering if they clear outwards with less than half cargo.

ART. 5.-Lighters chartered for the passage of the Sulina Bar by vessels which shall have paid the duties fixed by the preceding articles, shall pay for each passage effected with a lading either whole or partial, only the following toll; namely:

Lighters of 10 to 50 tons burden ... 6 francs. Those of more than 50 and not ex-

ceeding 100 tons... 8 francs. And those of more than 100 tons ... 12 francs.

ART. 6.—Vessels of more than 30 tons register which shall remain at anchor on the roadstead of Sulina to load or unload the whole or part of their cargo, without entering the port, shall not be subjected to the tolls established by the preceding Articles; the said vessels shall only pay a uniform duty of 50 francs per vessel towards the expenses of the establishments, such as lighthouse and pilotage, by which they really profit.

Lighters chartered to transport across the bar the cargo of the said vessels, shall pay for each passage of the bar, with either whole or part lading, a fixed duty of 1 franc per ton on their

total tonnage.

Steam Lighters shall be allowed a deduction of 40 per cent. on their tonnage in the calculation of the tolls which they will have to pay.

ART. 7.—Vessels of war shall be freed from all toll for passing the Sulina Bar, either inwards

ART. 8.—Sea going vessels, or lighters, who shall seek shelter in the Port of Sulina from bad weather, those who shall put in to repair damages, and those who by reason of any accident whatever shall be obliged to take refuge in the port, and shall be prevented from continuing their course at sea, shall be freed from all toll, provided that they put to sea again without transacting any commercial business.

ART. 9.—The tolls established by the present tariff shall comprise:

The tolls imposed on vessels to cover the expenses of the works and other improvements effected by the European Commission.

The duties at present in force for the maintenance of the Lighthouses of Sulina, and the Isle of Serpents; and the dues intended to cover the expenses of the Pilot Service on the Sulina Bar.

In addition to these tolls, vessels shall be subjected to no toll or charge whatever, except the pay of the River Pilots, which vessels will pay in conformity with Arts. 61 and 62, of the Pilotage Regulations of the 9th July, 1860.

ART. 10.—The amount of the tolls shall be paid over to the Cashier, who shall be appointed to administer the Navigation Cash Office of the Port of Sulina, and who shall give receipt for the

ART. 11.—By the expression of register ton shall be understood the English ton, measuring 1015 kilogrammes. The tonnage of vessels shall be ascertained from the regular ship's papers.

ART. 12.—Vessels entering the Danube without regular ship's papers showing their tonnage, shall be submitted, exclusively with a view to fix the navigation tolls which they shall be bound to pay in conformity with the present tariff, to an approximate valuation made under the direction of | Sulina,

the Captain of the Port, and with the concurrence of the competent Consular authority, by two shipmasters, of whom one shall be chosen by preference from among those of the nation of the vessel concerned.

In the same manner shall be decided disputes which may arise, on the proportion of a vessel's lading in the cases provided by the above Articles 1 and 4.

The apprizement of tonnage, in default of regular ship's papers, shall be made at the expense of the vessel which gives rise to it; the same rule shall hold for the apprizement of the proportion of the lading, if it is in excess of the declaration of the master of the vessel.

In the contrary case the said expenses will remain at the charge of the navigation chest.

In any case these apprizements shall be final, and can give rise to no appeal whatever.

ART. 13.—The depths, according to which shall be determined the tolls established by the present tariff, shall be measured on the Sulina Bar in English feet.

Soundings shall be taken every day under the direction and responsibility of the engineer superintending the works of improvement at the mouth of the river; the result of these soundings shall be posted daily at the Navigation Cash Office, and at the office of the Captain of the Port.

If the state of the weather does not allow of soundings being taken, the amount of the tolls to be levied shall be calculated on the latest depth

ascertained.

ART. 14.—Every vessel which shall endeavour by any means whatever, to escape the payment of the tolls fixed by the present tariff, shall be liable, in addition to the tolls which she shall have to pay in conformity with the preceding Articles, to a fine equal to four times the amount of these tolls.

The application of this fine shall be pronounced

by the Captain of the Port of Sulina.

Any appeal from these judgments shall be brought before the European Commission of the Danube, or before the International Authority who shall succeed to its functions.

The period within which such appeal must be made, and the form of proceeding, shall be determined hereafter by special dispositions.

The judgments pronounced by the Captain of the Port shall take effect, notwithstanding an appeal: in such case the amount of fine shall be paid into the navigation chest as a deposit.

Upon confirmation of the judgment, the amount of fine shall accrue to the said chest, to be devoted to the relief of shipwrecked persons.

ART. 15.—The commanders of vessels of war, stationed at the mouths of the Danube, conformably with Article 19 of the Treaty of Paris, shall be called upon to ensure the payment of the tolls established by the present tariff, and of the fines accruing under its stipulations, by the vessels of their nation, and of those whose flag they shall be authorized to protect, either by virtue of a Treaty

or by virtue of a general or special delegation.

The action of the vessels of war shall be demanded, as a rule, by the intervention of the Captain of the Port of Sulina on the requisition of the Cashier appointed to administer the navigation

In default of a vessel of war authorized to exercise a coercive action over an offending vessel, the Captain of the Port shall have recourse to the intervention of the Ottoman man-of-war at

ART. 16.—The present tariff shall come into operation on the 1st September (new style).

Chartered vessels which shall have started for their destination at the moment when the preliminary notice, published by the European Commission on the 11th July, 1860, shall have been legally made known in their port of departure, shall not be subjected, for the voyage commenced, to the tolls established by the present Tariff: they shall only pay for that voyage the dues in force at the moment of their departure.

ART. 17.—The present Tariff being only provisional, can be revised.
