LOCAL GOVERNMENT ACT, 1858. CARTWORTH, YORKSHIRE.

WHEREAS notice in writing was duly given to me, as one of Her Majesty's Principal Secretaries of State, that the Local Government Act, 1858, was adopted on the 4th day of July, 1860, by such part of the township of Cartworth, in the parish of Kirkburton, in the county of York, as maintains its own highways, such part having known and defined boundaries; and whereas it has now been duly certified to me, that a copy of such notice has been advertised for three successive weeks in the Huddersfield Chronicle and the Huddersfield Examiner, those being two of the local newspapers published and circulated in the aforesaid part of such township, and that copies of such notice have also been affixed to the principal doors of each church and chapel in such part of such township to which notices are usually affixed; and whereas an appeal has been duly made to me, under the provision of the said Act, by owners and ratepayers within the aforesaid part of such township, setting forth

grounds on which they dispute the validity of the vote for the adoption of the said Act therein, and praying for the exclusion of such part of such township from the operation of such Act; and whereas inquiry has been duly directed by me into the circumstances of the case, and such inquiry has been made, and the result thereof reported to me.

Now, therefore, I, as one of Her Majesty's Principal Secretaries of State, as aforesaid, do hereby, under the provisions of the said Act, issue the following order, and do determine the questions arising on such appeal as follows—

That the vote for the adoption of the Local Government Act, 1858, within the said part of the said township of Cartworth, was not valid.

Southwark and Vauxhall Water Company.

(Amendment of Acts; Extension of Limits for Supply.)

NOTICE is hereby given, that application is intended to be made to Parliament, in the ensuing session, for an Act to amend, extend, and enlarge the powers and provisions of an Act passed in the 15th and 16th years of Her Majesty, intituled "The Southwark and Vauxhall Water Act, 1852," and of a certain other Act, passed in the 18th year of Her present Majesty, intituled "Southwark and Vauxhall Water Act, 1855," and by the said Act it is intended to extend the limits of the Southwark and Vauxhall Water Company for supplying water, to all or certain parts of the following parishes, districts, or places, or some of them ; that is to say : Putney, Barnes, Mortlake, East Sheen, Kew, Richmond, Petersham, Ham, Wimbledon, and Roehampton, all in the county of Surrey ; and to confer upon the said Company all requisite and necessary powers for breaking up highways and other places, laying mains and pipes, and otherwise, for the purposes of such supply.

And it is also intended to apply for power to levy rates, rents, or charges in respect of such supply of water, and to vary or extinguish existing rates, rents, or charges, and to confer, vary, and extinguish exemptions from the payment of rates, rents, or charges, and to vary or extinguish all rights and privileges which would interfere with the carrying into effect of the purposes of the said intended Act, and to confer other rights and privileges.

And notice is hereby also given, that printed copies of the proposed Bill will be deposited in the Private Bill Office of the House of Commons on or before the 23rd day of December next.
