ON the Morning of MONDAY, March 25th, 1861, the Remains of HER LATE ROYAL HIGHNESS THE DUCHESS OF KENT AND STRATHERN, Daughter of His late Serene Highness Francis Frederick Anthony Duke of Saxo-Coburg-Saalfeld, Mother of Her Majesty The Queen, and Widow of His late Royal Highness Edward Duke of Kent and Strathern, were privately removed from Frogmore House to the Nave in St. George's Chapel, Windsor, near to the Cenotaph of Her late Royal Highness The Princess Charlotte, in the Choir of which Chapel they were deposited, and will remain until the completion and Consecration of the Mausoleum, now in the course of construction in the grounds at Frogmore.

In strict accordance with the understood wishes of Her late Royal Highness, the Funeral was conducted in the most private manner, and the following limited Ceremonial was observed :—

At half past Four o'Clock A.M., the Remains of Her late Royal Highness, attended by Colonel Lord James Murray, Equerry to Her late Royal Highness, by the Honourable Spencer Ponsonby, Comptroller in the Lord Chamberlain's Department, and by Henry Brown, Esquire, Medical Attendant upon Her late Royal Highness; and followed by Mr. William Seabrook, Mr. Maslin, Miss Wagner and Miss Kreukler, Servants of Her late Royal Highness, were removed, in the strictest privacy, from Frogmore House to St. George's Chapel; where, at Five o'Clock, A.M., they were received by Viscount Castlerosse, Vice-Chamberlain of Her Majesty's Household, and, having been placed in the north-west corner of the Nave, near to the Cenotaph of The late Princess Charlotte, there remained under the charge of the Officers appointed by the Lord Chamberlain until the hour fixed for the Funeral Service.

At Half-past Ten o'Clock, those who had the honour to receive The Queen's Commands to attend the Ceremony, but who did not take part in the Procession, were admitted to St. George's Chapel, and were at once conducted to Seats in the Choir.

At Eleven o'Clock, The Royal Family and other Royal Personages assembled in the Chapter Room of St. George's Chapel, from which They were conducted to their Places in the Procession by the Lord Chamberlain.

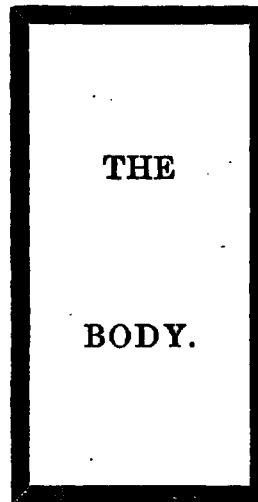

Upon arrival within the Choir, the Coronet and Cushion were placed upon the Coffin. His Royal Highness, the Chief Mourner, stood at the head of The Corpse, with His Royal Highness The Prince of Wales and His Serene Highness The Prince of Leiningen on either side. The other Royal Personages in the Procession stood behind His Royal Highness The Chief Mourner, and the Attendants upon Their Royal Highnesses near them.

The Ladies who supported the Pall occupied stools on either side of the Coffin. The Lord Chamberlain stood at the foot of the Coffin.

The rest of the Procession, upon their arrival within the Choir, were conducted to Pews on either side of the Chapel.

The opening sentences of the Burial Service were sung by the Choir, to the Music by Dr. Croft, while the Procession moved up the Nave; after which, the 90th Psalm was chanted to the Funeral Chant adapted from Beethoven.

The first part of the Service and the Anthem (Martyn Luther's Hymn) having been performed, The Corpse was lowered into the entrance to the Royal Vault, and the Dean having concluded the Burial Service, Garter King of Arms proclaimed the Style of Her late Royal Highness.

After which The Royal Family and other Royal Personages were conducted out of the Chapel and the others composing the Procession retired, while the Dead March in Saul was played.

A Guard of Honour of the Scots Fusilier Guards mounted during the Ceremony at the entrance to St. George's Chapel, and Presented Arms as the Procession moved up the Nave.
