THE Queen has been pleased to direct letters patent to be passed under the Great Seal, granting the dignities of Viscount and Earl of the United Kingdom of Great Britain and Ireland unto the Right Honourable John Russell (commonly called Lord John Russell), and to the heirs male of his body lawfully begotten, by the names, styles, and titles of Viscount Amberley, of Amberley, in the county of Gloucester, and of Ardsalla, in the county of Meath, and Earl Russell, of Kingston-Russell, in the county of Dorset.

HER Majesty has been pleased, by Her Order in Council of the 25th July instant, to grant to William Hutchison, of Tunbridge Wells, county of Kent, a prolongation for the term of two years of certain Letters Patent for "improvements in treating pasteboard and other substances, rendering them compact and impervious to wet, frost, vermin, and other destructive agents," such Letters Patent having been originally granted to the said William Hutchison, and bearing date the 25th

November, 1847, for England, Wales, and the town of Berwick-upon-Tweed, and also all Her Majesty's Colonies and Plantations abroad.

THE Right Honourable the Lords of the Committee of Privy Council for Trade, have received from the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Minister at Madrid, enclosing a Royal Order reducing the import duties upon syphon bottles used for soda and other aërated waters, to 1 real 50 cents per bottle if imported under the Spanish flag, and 1 real 65 cents if imported under foreign flag or by land.
