THE DEFENCE ACT, 1860.

ALDERSHOT CAMP.

NOTICE is hereby given, that under and by virtue of the provisions of a certain Act of Parliament made and passed in the 19th and 20th years of the reign of Her present Majesty, intitled "An Act to extinguish certain rights of way, and to stop up certain roads and paths near the camp at Aldershot."

The roads and ways mentioned and set forth in the first schedule hereunder written have been formed and made as public roads or highways at the expense of the Government, and the completion thereof certified upon the 25th day of May, 1861, under the hands of two Justices of the Peace for the county of Southampton, and such certificate has been enrolled at the Quarter Sessions for the same county. And further, that all rights of way in, over, and upon certain roads mentioned and set forth in the second schedule hereunder written have absolutely ceased and for ever determined, and that the same roads are now closed and stopped up by order of Her Majesty's

The First Schedule hereinbefore referred to.

1st. A road leading from the bridge over the Basingstoke Canal on the road called the Reading and Farnham Road, near the Oat Sheaf Public House, in the tything of Crookham, in the parish of Crondall, and extending thence over lands formerly part of Crookham and Aldershot Commons, and terminating on the Farnham and London Turnpike Roads, near the Farnham Wharf on the said canal, being the road intended to be shown by a line dotted black from the letter A to the letter C, on the plan annexed to a certain agreement of the 31st May, 1856, mentioned and set forth in the said Act.

2ndly. A road branching out of the said last-mentioned road from the letter B, and terminating at or near Galley Hill, at Crookham aforesaid, at a place marked D, as respectively marked or shown on the said plan.

3rdly. A certain road branching out of the said last-mentioned road at the letter H, and terminating at the letter G, as respectively marked or shown on the said plan.

The Second Schedule hereinbefore referred to.

1st. The road called Harrington Road, leading from the North Horns into the turnpike road from Farnham to Farnborough, as shown by a line dotted black from the letter E to the letter F on the said before-mentioned plan.

2ndly. The road leading from the said letter D to the letter G, as shown by a line coloured blue from the said letter D to the said letter G on the same plan.

3rdly. The road leading from the said letter G to the letter K, as shown also by a line coloured blue from the said letter G to the said letter K on the same plan.

All which roads are in the parishes of Crondall and Aldershot, in the county of Southampton.
