

In such cases an agent must be furnished with a power of attorney either under private seal, or attested before a Public Notary, bearing a French stamp and authenticated by a French Consul, which must be registered, and delivered by the agent to the Secretary of the Conseils de Prud'hommes. The registration fee is two francs whatever may be the number of designs or models deposited.

In cases where the power of attorney is written in the English language, a second registration fee will be charged on the translation which is required to be deposited.
