The Pork to be delivered into the respective Stores as follows; viz.: one-third of each quantity for each place by the 31st day of January, 1862; another third thereof by the 11th day of March, 1862; and the remainder thereof by the 30th day of April, 1862; or any greater portion, or the whole, at any earlier period, if preferred by the party tendering, and to be paid for by bills at seven days after date, which will be sent to parties as usual.

Their Lordships reserve to themselves the power, when the tenders are opened, of contracting either for the whole, or for such part thereof only as they may deem fit, or for a greater quantity, or of not contracting for any; and also an unlimited power of selection.
