BY virtue of an Act, passed in the twenty-fourth year of the reign of His Majesty King George the Third, intituled "An Act to repeal "so much of two Acts made in the tenth and "fifteenth years of the reign of His present Ma-"jesty, as authorizes the Speaker of the House "of Commons to issue his warrant to the Clerk of "the Crown for making out writs for the election "of Members to serve in Parliament, in the "manner therein mentioned, and for substituting "other provisions for the like purposes:"
