BY virtue of an Act, passed in the twentyfourth year of the reign of His Majesty King George the Third, intituled "An Act to repeal "so much of two Acts made in the tenth and "fifteenth years of the reign of His present "Majesty, as authorizes the Speaker of the House "of Commons to issue his warrant to the Clerk "of the Crown for making out writs for the elec-"tion of Members to serve in Parliament, in the "manner therein mentioned, and for substituting "other provisions for the like purposes:"

I do hereby give notice, that the death of the Right Honourable Sir James Robert George Graham, Baronet, late a Member serving in this present Parliament, for the city of Carlisle, hath been certified to me in writing, under the hands of two Members, serving in this present Parliament, and that I shall issue my warrant to the Clerk of the Crown to make out a new writ for the electing of a Member to serve in this present Parliament for the said city of Carlisle, at the end of fourteen days after the insertion of this notice in the London Gazette.

The Queen has been pleased to give and grant unto Barnard Trollope, of Sidmouth, in the county of Devon, and of Cowlam, in the county of York, Esquire, Her Royal licence and authority that he and his may, in compliance with a direction contained in the last will and testament of his late Maternal Uncle Barnard Foord-Bowes, late of Beverley, in the county of York, sometime Major-General in the Army, deceased, henceforth take and use the surnames of Foord-Bowes only, instead of that of Trollope, and also bear the arms of Foord and Bowes, such arms being first duly exemplified according to the laws of arms, and recorded in the Heralds' Office, otherwise the said Royal licence and permission to be void and of none effect:

And also to command that the said Royal concession and declaration be registered in Her Majesty's College of Arms.
