would, in our opinion, be expedient that all that part of the said parish of Aylesbeare, described in the schedule hereunto annexed, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto also annexed, should be assigned to the said church, and that the same should be named 'The District Chapelry of Saint Luke, Newton Poppleford.'

"And, with the like consent of the said Henry, Bishop of Exeter, testified as aforesaid, we further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at such church, and that the fees to be received in respect thereof, should be paid and belong to the minister of the same church for the time being.

"We, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such order with respect thereto, as to your Majesty in

your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

" The District Chapelry of Saint Luke, Newton Poppleford, being :-

" All that part of the parish of Aylesbeare, in the county of Devon, and in the diocese of Exeter, which is comprised within the tything or chapelry of Newton Poppleford."

Her Majesty, having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the proposed assignment of a district chapelry to the consecrated church of Saint Luke, situate at Newton Poppleford, in the parish of Aylesbeare, in the county of Devon, to be called "The District Chapelry of Saint Luke, Newton Poppleford," be accordingly made; and that the recommendations of the said Commissioners with reference to the publication of banns, and the solemnization of marriages, baptisms, churchings, and burials in the said church, and with reference to the fees to be paid in respect of those offices, be carried into effect agreeably to the provisions of the said Acts; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Exeter.

The QUEEN's Most Excellent Majesty in Council.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the third and fourth years of Her Majesty, chapter one hundred and thirteen; of the Act of the fourth and fifth years of Her Majesty, chapter thirty-nine; and of the Act of the twenty-third and twenty-fourth years of Her Majesty, chapter one hundred and twenty-four, duly prepared and laid before Her Majesty in Council a scheme, bearing date the twelfth day of December, in the year one thousand eight hundred and sixty-one, in the words following; that is to say:

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the third and fourth years of your Majesty, chapter one hundred and thirteen; of the Act of the fourth and fifth years of your Majesty, chapter thirty-nine; and of the Act of the twenty-third and twenty-fourth years of your Majesty, chapter one hundred and twenty-four, have prepared, and now humbly lay before your Majesty in Council, the following scheme for making better provision for the cure of souls in the district of South Charlton, in the county of Northumberland, and in the diocese of Durham.

"Whereas under and by virtue of an Order of your Majesty in Council, bearing date the twentysixth day of October, in the year one thousand eight hundred and sixty, and duly published in the London Gazette of the thirtieth day of the same month, the said district of South Charlton was duly constituted, and the right of patronage of such district, and of the nomination of the minister thereof, were assigned to and vested in the Most Noble Algernon, Duke of Northumberland, his heirs and assigns, and the Dean and Chapter of the cathedral church of Durham, and their successors, in the manner in the said Order mentioned, and hereinafter described; that is to say: so that the said Duke and his heirs and assigns should have and enjoy two nominations of a minister to the said district for every single nomination by the said dean and chapter, and their successors; and that the first two of every three nominations to such district should be vested in, and belong to, and should and might be exercised by the said Duke, his heirs and assigns; and whereas it has been agreed between the said dean and chapter, and the said Algernon, Duke of Northumberland, and it has been proposed to us by the said dean and chapter and the said Duke, and it appears to us to be expedient that the share of the patronage of the said district, and of the nomination of the minister thereof, which now belongs to the said dean and chapter, should be assigned and transferred to the said Algernon, Duke of Northumberland, as hereinafter recommended and proposed.

"And whereas it has been also agreed that the said Duke should transfer, and he has accordingly transferred to our account and into our name in the books of the Governor and Company of the Bank of England, a sum of seven hundred and seventy-five pounds, five shillings, and seven pence, three pounds per centum Consolidated Bank Annuities, upon the understanding that the income of the minister of the said district, when the entire patronage thereof shall have been transferred and assigned as hereinafter set forth, should be augmented by an equivalent annual grant to be payable out of the common fund under our con-

trol, in manner hereinafter mentioned.

"Now, therefore, with the consents of the Right Reverend Charles, Bishop of Durham (in testimony whereof he has signed and sealed this scheme), and of the Dean and Chapter of the said cathedral church of Durham (in testimony whereof they have hereunto affixed their common or capitular seal), we humbly recommend and propose that the share of the patronage of the said district of South Charlton, and of the nomination of the minister thereof, which now belongs to the Dean and Chapter of the said cathedral church of Durham, shall without any assurance in the law, other than this scheme and any duly gazetted order of your Majesty in Council ratifying the same, and upon and from the day of the date of the publication of such Order in the London Gazette, be assigned and transferred to, and be
