

NAVAL PRIZE MONEY.

Department of the Accountant-General of the Navy, Admiralty, Somerset-House, March 24, 1862.

NOTICE is hereby given to all persons interested therein, that preparations are now being made for the intended distribution of bounty awarded for the destruction of Pirates in the China Seas, on the 12th, 13th, 14th, and 15th March, 1859, by Her Majesty's Ships Niger, Clown, and Janus.

Agents or other persons having any just and legal demand, unliquidated, against the said proceeds are required to transmit the particulars of any such demand to the Registrar of the High Court of Admiralty, in order that the same may be examined, taxed, and allowed by that Officer, and paid under the sanction of the Judge of the said Court.

Hull South Bridge.

(Alteration of part of Line of Eastern Approach.)

NOTICE is hereby given, that it is intended in the Bill now pending in Parliament, under the name or short title of the Hull South Bridge Bill, to seek power to make an alteration in the line or course of the eastern approach to the intended bridge, such alteration to commence at, in, or near the shipbuilding yard at the mouth of, and on the eastern side of the River Hull, in the extra-parochial place called Garrison-side, and to terminate at, or about two chains west of the point marked on the plans deposited in November last, with the Clerk of the Peace for the county of the town of Kingston-upon-Hull, 4 furlongs; the whole of which alteration will be situate in the extra-parochial places or parishes called Garrison-side, and the Citadel, in the borough and county of the town of Kingston-upon-Hull. It is intended to authorize the Company to be incorporated by the Bill, to adopt such altered line of approach, in substitution for the portion of the intended approach between the points before described, which will be rendered unnecessary by such substitution, with the same powers of purchasing lands compulsorily, and all other rights and powers as contained in the said Bill. Plans, sections, and books of reference, of such alteration, were on the 15th day of March instant, deposited for public inspection at the office at Hull, of the Clerk of the Peace for the county of the town of Kingston-upon-Hull, and with the parish clerk of the parish of Drypool, at his residence.—Dated this 27th day of March, 1862.
