The Queen has been pleased to give and grant unto John Henry Charles Erridge King, of Cambridge House, in the borough of Portsmouth, in the county of Southampton, Doctor in Medicine in the University of Edinburgh, Member of the Royal College of Surgeons of England, and a Licentiate of Dental Surgery in the same College, Her royal licence and authority that he and his issue may take, use, and bear the surname of Martin only, in lieu of that of King :

And also to command that the said royal concession and declaration be recorded in Her Majesty's College of Arms, otherwise to be void and of none effect.

THE Queen has been graciously pleased to signify Her intention to confer the decoration of the Victoria Cross on the under-mentioned Officers of Her Majesty's Indian Forces, whose claims to the same have been submitted for Her Majesty's approval, on account of Acts of Bravery performed by them in India, as recorded against their names ; viz. :

Regiment.	Rank and Name.	Act of Bravery for which recommended.
The late 2nd European Bengal Fusiliers	Lieutenant Thomas Cadell Date of Acts of Bravery, June 12th, 1857	For having, on the 12th of June, 1857, at the Flag-staff Picquet at Delhi, when the whole of the Picquet of Her Majesty's 75th Regiment and 2nd European Bengal Fusiliers were driven in by a large body of the enemy, brought in from amongst the enemy a wounded Bugler of his own regiment, under a most severe fire, who would otherwise have been cut up by the rebels. Also, on the same day, when the Fusiliers were retiring, by order, on Metcalfe's house, on its being reported that there was a wounded man left behind, Lieutenant Cadell went back of his own accord towards the enemy, accompanied by three men, and brought in a man of the 75th Regiment, who was severely wounded, under a most heavy fire from the advancing enemy.
Bengal Engineers ...	Lieutenant Edward Talbot Thackeray. Date of Act of Bravery, September 16th, 1857	For cool intrepidity and characteristic daring in extinguishing a fire in the Delhi Magazine enclosure, on the 16th of September, 1857, under a close and heavy musketry fire from the enemy, at the imminent risk of his life from the explosion of combustible stores in the shed in which the fire occurred.
