RULES, Orders, and Regulations for the preservation of Her Majesty's moorings, and for the mooring, anchoring, and placing of all transports, and all other private and merchant ships and vessels, lighters, barges, boats, and other craft whatsoever in and communicating with the harbour of Queenstown, in that part of the United Kingdom of Great Britain and Ireland called Ireland, and near the docks, dock-yards, arsenals, wharfs, and moorings belonging to Her Majesty therein, for the purpose of keeping and preserving the same free and open, and for ensuring the free and safe passage to and from the same respectively, made and established pursuant to an Act of Parlia ment made and passed in the fifty-fourth year of the reign of His late Majesty King George the 3rd, chapter 159, intituled "An Act for the better "regulation of the several ports, harbours, road-"steads, sounds, channels, bays, and navigable "rivers in the United Kingdom, and of His Ma-"jesty's docks, dock-yards, arsenals, wharfs, moor-"ings, and stores therein, and for repealing several "Acts passed for that purpose."

It is hereby ordered that no transport, nor any private or merchant ship or vessel, steam vessel, lighter, barge, boat, or other craft whatever shall be moored or placed within the boundaries or limits of the said harbour following, that is to say, the "Man of War Roads," the anchorage of such roads being bounded on the east by a line drawn from the club house, on the west quay, in a south by east direction, by compass forming a tangent with the east end of Spike Island, on the west by a line drawn in a similar south by east direction, from White point towards the west end of Haulbowline Island, and on the north by the contour line of three fathoms depth at low-water spring tides, as marked in the Admiral ty Chart of Queenstown harbour, No. 1777, and on the south by low-water mark on Haulbovline Spit Bank.
