having signed and sealed this representation, we humbly represent, that it would, in our opinion, be expedient that all that part of the said parish of Huddersfield, described in the schedule hereunto annexed, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto also annexed, should be assigned to the said church, and that the same should be named 'The District Chapelry of Saint Bartholomew, Scammonden.'

"And, with the like consent of the said Robert, Bishop of Ripon, testified as aforesaid, we further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said church of Saint Bartholomew, and that the fees to be received in respect thereof should be paid and belong to the minister of the same church for the time being : Provided always, that so long as the Reverend Samuel Holmes, the present Vicar or Incumbent of the vicarage of the said parish of Huddersfield, shall continue to be such vicar or incumbent, all the fees which shall be received in respect of the performance of marriages in the said church of Saint Bartholomew, shall be paid by the said minister thereof to the said Samuel Holmes.

"We, therefore, humbly pray, that your Majesty will be graciously pleased to take the premises into your Royal consideration, and to make such Order with respect thereto as to your Majesty in your Royal wisdom shall seem meet.

## The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Bartholomew, Scammonden, being :---

"All that part of the parish of Huddersfield, in the county of York, and in the diocese of Ripon, which is comprised within the township of Scammonden."

Her Majesty, having taken the said representation, together with the map or plan thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof; and to order, and it is hereby ordered, that the proposed assignment of a district chapelry to the consecrated church of Saint Bartholomew, situate at Scammonden, in the parish of Hud-dersfield, in the county of York, to be called "The District Chapelry of Saint Bartholomew, Scammonden," be accordingly made; and that the recommendations of the said Commissioners with reference to the publication of banns, and the solemnization of marriages, baptisms, churchings, and burials in the said church, and with reference to the fees to be paid in respect of those offices, be carried into effect agreeably to the provisions of the said Acts ; and Her Majesty is further pleased to direct that this Order be forthwith registered by the Registrar of the diocese of Ripon.

W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the sixth and seventh years of Her Mathe day of the date of the publication of such

jesty, chapter thirty-seven, duly prepared and laid before Her Majesty in Council a scheme, bearing date the seventh day of August, in the year one thousand eight hundred and sixty-two, in the words following ; that is to say :

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the sixth and seventh years of your Majesty, chapter thirtyseven, have prepared, and now humbly lay before your Majesty in council, the following scheme for constituting a separate district for spiritual purposes out of the chapelry district of Saint James, Lower Holloway, in the county of Middlesex, and in the diocese of London.

"Whereas it has been made to appear to us that it would promote the interests of religion that the particular part of the said chapelry district of Saint James, Lower Holloway, hereinafter mentioned and described, such part not at present containing within its limits any consecrated church or chapel in use for the purposes of divine worship, should be constituted a separate district in the manner hereinafter set forth.

"And whereas a sum of five thousand pounds, three pounds per centum Consolidated Bank Annuities, has been contributed and transferred to our account and into our name in the books of the Governor and Company of the Bank of England, by George Cubitt, of Denbies, near Dorking, in the county of Surrey, Esquire, in aid of the maintenance of the minister for the time being of the district hereinafter recommended to be constituted, and we have in respect thereof agreed with the said George Cubitt, and have undertaken to provide and pay by equal half-yearly payments on the first day of May and the first day of November in each and every year to such minister as aforesaid, when duly licensed, the yearly sum of one hundred and fifty pounds.

"And whereas it has been proposed to us, and it appears to us to be expedient that, in consideration of the transfer of the said sum of five thousand pounds three pounds per centum Consolidated Bank Annuities as aforesaid, the whole right of patronage of the district hereinafter recommended to be constituted, and of the nomination of the minister thereof, should be assigned to the said George Cubitt, his heirs and assigns, in the manner hereinafter recommended.

"Now, therefore, with the consent of the Right Honourable and Right Reverend Archibald Campbell, Bishop of London, in testimony whereof he has signed and sealed this scheme, we humbly recommend and propose that all that part of the said chapelry district of Saint James, Lower Holloway, described in the schedule hereunto annexed, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto also annexed, shall upon and from the day of the date of the publication in the London Gazette of any Order of your Majesty in Council ratifying this scheme, become and be constituted a separate district for spiritual purposes, and that the same shall be named 'The District of Saint Clement, Barnsbury.'

"And we further recommend and propose that the whole right of patronage of the said district so recommended to be constituted, and of the nomination of the minister thereof, shall without any assurance in the law other than this scheme, and any duly gazetted Order of your Majesty in Council ratifying the same, and upon and from the day of the date of the publication of such
