"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the thirteenth and fourteenth years of your Majesty, chapter forty-one, have prepared, and now humbly lay before your Majesty in Council, the following scheme, for making better provision for the cure of souls in certain parishes and districts within the original limits of the parish of Manchester, in the county of Lancaster, and diocese of Manchester.

"Whereas, under the provisions of the said Act, and of the Acts therein recited, certain monies have been paid to us by the dean and canons of the cathedral church of Manchester, and the same, together with the accumulations of interest arising therefrom, are now in our hands, and are applicable, under such provisions, to making better provision for the cure of souls within the original limits of the said parish of Manchester.

"Now, therefore, we humbly recommend and propose, that there shall be paid by us, out of the monies now in our hands, subject to the provisions of the said Act, on the first day of November
