## Penzance and St. Just Turnpike Roads.

(Constructi n of New Turnpike Roads from Saint Just, in Penwith, to Penzance, with branches from Nancherrow in Saint Just, to Main Road at Chywoone; from Neds shop at Pendeen, to the main road at Tregerras Directing Post, and from Warren's Shop, at Trewellard, to the branch last aforesaid at Bojewyan; Adoption and Alteration of existing Highways; Appointment of Trustees; Tolls; Borrowing Powers; Arrangements with Boards of Highways, and with parishes.

OTICE is hereby given, that application is intended to be made to Parliament in the ensuing session for leave to bring in a Bill to appoint a body of trustees, with powers to sue and be sued, and all other proper powers for making and maintaining the following turnpike roads, that is to say :-

No. 1. A turnpike road, to commence in the parish of Saint Just, in Penwith, and county of Cornwall, at or near the church stile at the western end of the parish church of the parish of Saint Just, in Penwith aforesaid, and to terminate in the parish of Madron, and county of Cornwall, at or near the boundstone in the highway at Alverton, in the said parish of Madron, which separates the same parish from the borough of Penzance, in the county of Cornwall aforesaid, and so far as may be expedient to adopt, alter, and improve the existing highway between such commencement and termination.

No. 2. A turnpike road, to commence in the parish of St. Just, in Penwith, and county of Cornwall aforesaid, from the side of the parish road, at or near Holman's Iron Foundry, near Nancherrow, in the parish of Saint Just, in Penwith, in the county of Cornwall aforesaid, and to terminate in the said parish of Saint Just, in Penwith, and county of Cornwall, by a junction with the intended turnpike road before described, in the tenement of Chywoone, otherwise Choone, in the parish of Saint Just, in Penwith aforesaid, in the field next outside the Vicarage Gate.

No. 3. A turnpike road, to commence in the parish of Saint Just, in Penwith, and county of Cornwall aforesaid, from the side of the parish road, at or near a blacksmith's shop, near Pendeen District Church, known as Ned's Shop, in the tenement of Portheiras, in the parish of Saint Just, in Penwith aforesaid, and to terminate in the parish of Sancreed, and county of Cornwall, by a junction with the intended turnpike road firstly before described, at or near the directing post, in the tenement of Tregerras, in the parish of Sancreed aforesaid, which is placed at the spot at which the highway now known as the North Road diverges from the highway now known as the Saint Just Road; and so far as may be expedient to adopt, alter, and improve the existing highway between such commencement and termination.

No. 4. A turnpike froad, to commence in the parish of Saint Just, in Penwith, and county of Cornwall aforesaid, from the side of the parish road, at or near a grocer's shop, known as Warren's Shop, in the tenement of Trewellard, in the parish of Saint Just, in Penwith aforesaid, and to terminate in the parish of Saint Just, in Penwith, and county of Cornwall aforesaid, by a junction with the intended turnpike road, lastly hereinbefore described, at or near a directing post, in the tenement of Bojewyan, in Saint Just, in Penwith aforesaid, placed at the spot at which the highway known as the Trewellard Road diverges from the north road aforesaid; and so far as may be expedient to adopt, alter, and improve the existing highway between such commencement and termination.
