

belonging thereto, to and along the middle of the last described fence to a point in the middle of the River Cynon, opposite to the middle of the south-western end of such last described fence, and extending thence in a direction generally south-eastward along the middle of such river, as far as a point opposite to the middle of the north-eastern end of the fence dividing the close numbered 486 upon the said maps, from the closes numbered respectively 525 and 526 upon the same maps, and extending thence south-westward to and along the middle of the last-described fence to its south-western extremity, and extending thence westward in a direct line across the Aberdare Railway, to a point in the middle of the north-eastern end of the fence dividing the close numbered 484 upon the said maps from the close numbered 527 upon the same maps, and extending thence south-westward along the middle of the last described fence, to a point in the middle of a certain stream called Boy Brook, flowing from a source near to Twynsyeh into the River Cynon aforesaid, and continuing thence still south-westward along the middle of such stream as far as the boundary dividing the said parish of Aberdare from the parish of Llanwonno aforesaid, near to Twynsyeh aforesaid, and extending thence first north-eastward and then south-eastward along such parish boundary, as far as a point in the middle of the road leading from Aberdare to Ynysyawl, and extending thence first south-eastward, then southward, and then again south-eastward along the middle of the last-named road, as far as a point opposite to the middle of the western end of the fence dividing the close numbered 1239 upon the said maps from the close numbered 1823 upon the same maps, and extending thence north-eastward to and along the middle of the last described fence, and of the fences dividing the closes numbered respectively 1218, 1217 and 1216 upon the said maps, from the closes numbered respectively 1823 as aforesaid, 1519 and 1521 upon the same maps, to the junction of the fence dividing the close numbered 1216 from the close numbered 1521 as aforesaid, with the fence dividing the closes numbered respectively 1216 as aforesaid, 1215, 1214, 1213, and the plantation numbered 1210 upon the said maps from the wood numbered 1504 upon the same maps, and extending thence first south-eastward and then north-eastward along the middle of the last described fence to its north-eastern extremity, and extending thence still north-eastward, and in a direct line to a point in the middle of the River Cynon aforesaid, and extending thence first northward along the middle of such river, and then north-westward along the middle of the same river, as far as a point opposite to the middle of the southern end of the fence, dividing the close numbered 1707 upon the said maps from the road leading from such close to Cwm Cynon, and extending thence north-eastward to and along the middle of the last described fence, as far as a point at the middle of the south-eastern end of the last-mentioned road, and extending thence first north-westward along the middle of such road, and then north-eastward along the middle of the same road, as far as a point opposite to the middle of the south-western end of the fence, dividing the close numbered 1711 upon the said maps from the close numbered 1719a upon the same maps, and extending thence north-eastward to and along the middle of the last described fence, to its north-eastern extremity, and continuing thence still in the same direction, and in a straight line across the road leading from Aberdare to Cardiff, and across the Aberdare Canal and the towing-path belonging thereto as aforesaid, to a point in the middle of the south-

western end of the fence dividing the plantation numbered 1739 upon the said maps from the plantation numbered 1712 upon the said maps, and extending thence first northward along the middle of the fence last referred to, and then either north-eastward or north-westward along the middle of the fences dividing the plantation and closes numbered respectively 1739 as aforesaid 1484, 1485, 1486, and 1497, upon the said maps from the plantations and closes numbered respectively 1734, 1738, 1736, 1737, 1748, 1749, 1499, and 1498, upon the same maps crossing the road leading to Forest Ucha, to a point on the boundary dividing the said parish of Llanwonno from the parish of Merthyr Tydvil before-mentioned, opposite to the middle of the eastern end of the fence dividing the close numbered 1497 from the close numbered 1498 as aforesaid, and extending thence northward along the last described parish boundary to its junction with the boundary dividing the parish of Aberdare from the parish of Merthyr Tydvil as aforesaid, and extending thence north-westward along the last described parish boundary to the point opposite to the middle of the eastern end of the fence dividing the close numbered 946 upon the said maps from the close numbered 791 upon the same maps where the said imaginary line commenced."

Her Majesty having taken the said representation, together with the map thereunto annexed, into consideration, was pleased, by and with the advice of Her Privy Council, to approve thereof, and to order, and it is hereby ordered, that the that the Consolidated Chapelry therein mentioned for the consecrated church of Saint Margaret, situate at Mountain Ash, in the parish of Aberdare, in the county of Glamorgan, be accordingly formed, and that the agreement mentioned in the said representation with respect to the right of presentation and appointment of an incumbent or perpetual curate to serve the said church be carried into effect, agreeably to the provisions of the said Acts, and that the said right of presentation and appointment of an incumbent, or perpetual curate, to serve the said church, shall belong to and be exercised by the Right Reverend Alfred, Bishop of Llandaff, and his successors bishops of the same see for ever; and Her Majesty is further pleased to direct that this order be forthwith registered by the Registrar of the diocese of Llandaff.

WHEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the eighth and ninth years of Her Majesty, chapter seventy, and of the Act of the nineteenth and twentieth years of Her Majesty, chapter fifty-five, duly prepared and laid before Her Majesty in Council, a representation bearing date the twelfth day of February, in the year one thousand eight hundred and sixty-three, in the words and figures following; that is to say:
