Somerset and diocese of Bath and Wells, formerly belonging to the precentorship of the cathedral church of Wells, and now vested in us, together with our interest in the soil of the church yard at North Wootton, shall be transferred to, and become absolutely vested in, the perpetual curate or incumbent, for the time being, of the perpetual curacy of the said parish of North Wootton cum Worminster; that the lands and hereditaments described in the ninth schedule hereunto annexed, situate within the parish of Alton Pancras, in the county of Dorset and diocese of Salisbury, formerly belonging to the prebend of Alton Australis, in the cathedral church of Salisbury, and now vested in us, shall be transferred to, and become absolutely vested in, the vicar or incumbent, for the time being, of the vicarage of the said parish of Alton Pancras; and that the whole of the tithes or rent-charges in lieu of tithes, arising out of or upon lands situate within the parish of Llanddewi Aberarth, in the county of Cardigan and diocese of Saint David's, formerly belonging to the prebend of Llanddewi Aberarth, in the cathedral church of Saint David's, and now vested in us, shall be transferred to, and become absolutely vested in, the perpetual curate or incumbent, for the time being, of the perpetual curacy of the said

parish of Llanddewi Aberarth.
"And we further recommend and propose, with the consent of the Reverend Arthur Adolphus Fanshawe, Clerk, the perpetual curate or incumbent of the perpetual curacy of the parish of Bubbenhall, in the county of Warwick and diocese of Worcester, testified by his having signed and sealed this scheme, that the whole of the glebe lands, situate within the said parish of Bubbenhall, comprising one hundred and eleven acres, two roods, and sixteen perches, or thereabouts, with their appurtenances, which formerly belonged to the prebend of Bobenhall, otherwise Bubbenhall, in the cathedral church of Lichfield, and are now vested in us, shall in like manner and by the authority aforesaid, be transferred to, and become absolutely vested in, the perpetual curate or incumbent, for the time being, of the perpetual curacy of the said parish of Bubbenhall, in lieu of, and in full substitution for, and discharge of, the annual sum or stipend of twenty pounds, now payable by us to the said perpetual curate or incumbent, in respect of the estates formerly belonging to the said prebend of Bobenhall, otherwise Bubbenhall, and also of the annual sum or stipend of forty-five pounds, now payable by us to the same perpetual curate or incumbent, under the provisions of an Order of your Majesty in Council, bearing date the twenty-seventh day of August, in the year one thousand eight hundred and fifty-

"And we further recommend and propose, with the consent of the Reverend George Whitehead Bower, Clerk, the perpetual curate or incumbent of the perpetual curacy of Saint Mary, Newton-in-Mottram, in the county and diocese of Chester, testified by his having signed and sealed this scheme, that the yearly chief rent described in the tenth schedule hereunto annexed, and therein numbered I., together with the lands and hereditaments described in the same schedule, and therein numbered II., situate at Newton-in-Mottram aforesaid, with their appurtenances, which were conveyed to us by a deed, bearing date the twenty-third day of September, in the year one thousand eight hundred and sixty-two, shall, in like manner, and by the authority aforesaid, be transferred to, and become absolutely vested in, the perpetual curate or incumbent for the time being, of the said perpetual curacy of Parliament.

in the state . The death Saint Mary, Newton-in-Mottram, in lieu of, and in full substitution for, and discharge of, the annual sum or stippend of ten pounds, payable by us to the said perpetual curate or incumbent, under the provisions of an Order of your Majesty in Council, bearing date the eleventh day of October, in the year one thousand eight hundred and sixty-one.

"And we further recommend and propose, that all our right, title, and interest, to or in the church-yard of the parish of Pilton, in the county of Somerset, and in the diocese of Bath and Wells, shall, in like manner, and by the authority aforesaid, be transfered to and become absolutely vested in the vicar or incumbent for the time being, of the vicarage of the said parish of

Pilton.

" And whereas it appears to us, after duly considering the circumstances of the several cases undermentioned, to be expedient, that the several grants hereinbefore recommended to be made to the benefices or churches of Alton Pancras; Bubbenhall; Saint Thomas, Charterhouse; Friday bridge; Llanddewi Aberarth; Newland; Saint Mary, Newton-in-Mottram; Saint Mark, Old-street; Stanningley; and Stockcross; should commence and take effect from the several dates hereinafter mentioned respectively, that is to say, in the case of the vicarage of Alton Pancras, from the twenty-fifth day of November, in the year one thousand eight hundred and sixty; in the case of the perpetual curacy of Bubbenhall, from the twenty-fourth day of April, in the year one thousand eight hundred and sixty-two; in the case of the perpetual curacy of Saint Thomas, Charterhouse, from the first day of May, in the year one thousand eight hundred and sixty-two; in the case of the perpetual curacy of Fridaybridge, from the twenty-ninth day of September, in the year one thousand eight hundred and sixty-two; in the case of the perpetual curacy of Llanddewi Aberarth, from the eleventh day of September, in the year one thousand eight hundred and sixtytwo; in the case of the perpetual curacy of Newland, from the eighth day of December, in the year one thousand eight hundred and sixty-two; in the case of the perpetual curacy of Saint Mary, Newton-in-Mottram, from the twenty-third day of September, in the year one thousand eight hundred and sixty-two; in the case of the perpetual curacy of Saint Mark, Old-street, from the first day of November, in the year one thousand eight hundred and sixty-two; in the case of the perpetual curacy of Stanningley, from the sixth day of August, in the year one thousand eight hundred and sixty-two; and in the case of the perpetual curacy of Stockcross, from the fifteenth day of August, in the year one thousand eight hundred and sixty-two.

"Now, therefore, we humbly recommend and propose, that the several grants which are hereinbefore recommended by us to be made to the said last-mentioned benefices or churches respectively, shall, subject nevertheless, in the cases of Saint Thomas, Charterhouse, and Saint Mark, Old-street, to the production to us of certificates, with respect to the employment of curates, as hereinbefore provided, commence and take effect from the said several dates hereinbefore in that

behalf mentioned respectively.

"And we further recommend and propose, that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of either of them, or of any other Act of Parliament.
