The Queen has been pleased to order a writ to be issued under the Great Seal of the United Kingdom of Great Britain and Ireland for summoning Edward Adolphus Ferdinand Seymour, Esq. (commonly called Earl St. Maur), to the House of Peers, by the style and title of Baron Seymour.

The Queen has been pleased to direct letters patent to be passed under the Great Seal appointing Vere Henry Hobart, Esq. The Queen has been pleased to grant unto May Lloyd, of Uxbridge, in the county of Middlesex, widow and relict of John Lloyd, late of Aylesbury, in the county of Buckingham, Gentleman, deceased, and only child and heir of Alexander Shirreff, late of Anerum, in the shire of Roxburgh, also deceased, Her Royal licence and authority, that she may, in compliance with an obligation contained in a deed of disposition executed by her paternal uncle, James Shirreff, late of Bastleridge, in the parish of Ayton, in the shire of Berwick, Esquire, Merchant; in Leith, deceased, bearing date the 8th day of March, 1834, take, and henceforth use the surname of Shirreff, in addition to, and after that of Lloyd :

And also to command that the said Royal concession and declaration be registered in Her Majesty's College of Arms, otherwise to be void and of none effect.
