I do hereby give notice, that it hath been certified to me in writing, under the hands of two Members serving in this present Parliament, that Henry Lygon (commonly called Viscount Elmley), late a Member serving in this present Parliament for the Western Division of the county of Worcester, is become a Peer of the United Kingdom, and that a writ of summons hath been issued to him, under the Great Seal of the United Kingdom, to summon him to Parliament; and that I shall issue my warrant to the Clerk of the Crown to make out a new writ for the electing of a Member to serve in this present Parliament for the said Western Division, at the end of six days after the insertion of this notice in the London Gazette.
