TREASURY WARRANT.

WHEREAS by an Act of Parliament, passed in the fourth year of the reign of Her Majesty, cap. 96, for the regulation of the duties of postage; power is given to the Commissioners of Her Majesty's Treasury, from time to time, by Warrant under their hands, to alter and fix any of the rates of British postage, payable by law on the transmission by the post of foreign or colonial letters or newspapers, or of any other printed papers, and to subject the same to rates of postage according to the weight thereof, and a scale of weight to be contained in such Warrant.

And whereas further powers were given to the Commissioners of Her Majesty's Treasury, by another Act of Parliament, passed in the eleventh year of the reign of Her Majesty, chapter 85, for giving further facilities for the transmission of letters by post, and for the regulating the duties of postage thereon, and for other purposes relating to the Post Office.

And whereas the Commissioners of Her Majesty's Treasury, by a certain Warrant in writing, under their hands, bearing date at Whitehall Treasury-chambers the 15th day of January, 1858, in exercise of the powers reserved to them, in and by the said hereinbefore recited Acts of Parliament, and every of them, and of all other powers enabling them in that behalf, did order, direct, and declare (amongst other things) that all packets consisting of books, publications, or works of literature or art whether British, colonial, or foreign, posted in the United Kingdom, addressed to Sardinia, or posted in Malta, addressed to Sardinia,
