LOCAL GOVERNMENT ACT, 1858.

NOTICE OF ADOPTION OF ACT BY THE DISTRICTS OF COWPEN AND HOWDON.

WHEREAS the Local Government Act, 1858, was adopted by the district of Cowpen, in the county of Northumberland, on the 19th day of May, 1864, and by the district of Howdon, in the same county, on the 20th day of May, 1864, within the boundaries of such districts, as settled for the purposes of such Act; and notice of such adoption has in each case been duly given, and the other requirements of the Act have been complied with.

Now, therefore, I, as one of Her Majesty's Principal Secretaries of State, do hereby give
