NOTICE TO MARINERS.

(No. 12.)-New Zealand-North Island.

Tiri Tiri Matangi Island, Fixed Light on Hauraki Gulf.

The Colonial Government at New Zealand has given notice, that on and after the 1st day of January, 1865, a light would be exhibited from a lighthouse recently erected on Tiri Tiri Matangi island, Hauraki gulf, North Island, New Zealand.

The light is a *fixed* white light, at an elevation of 300 feet above the level of high water, and in clear weather should be seen from a distance of 23 miles.

The illuminating apparatus is dioptric or by lenses, of the second order.

The tower is of iron, 48 feet high, of a light red colour, and stands in lat. 36° 36' 30" S., long. 174° 55' 15" East of Greenwich.
